The Committee recommended the following:-

**ADMINISTRATION – DRAFT MANAGEMENT PLAN 2000/2003 – APPROVAL FOR PUBLIC EXHIBITION (2021951)**

That arising from consideration of a minute by the General Manager dated 26 April 2000, Council approves the Draft Management Plan 2000/2003, to be placed on public exhibition, subject to the following amendments to the Draft Fees and Charges, namely:-

- (1) Under the heading Temporary Road Closures on Page 11, the proposed charge of \$1,100 be detailed as under:
  - \$300 – for each application and \$800 – for advertising.
- (2) Under the heading Meals on Wheels Programme on Page 38, (Activities Clubs Meals and Meals on Wheels Meals) – the current charges remain as printed;

-Committee recommended that a further report be submitted by the General Manager to Council:-

- (1) on the engagement of a private marketing firm to look at aspects of marketing Paddington Town Hall, in particular, appropriate fees and charges for the hiring of the hall;
- (2) such firm to also make suggestions with respect to the marketing of other community halls to the public and community;
- (3) on the marketing of Council's properties in general.
