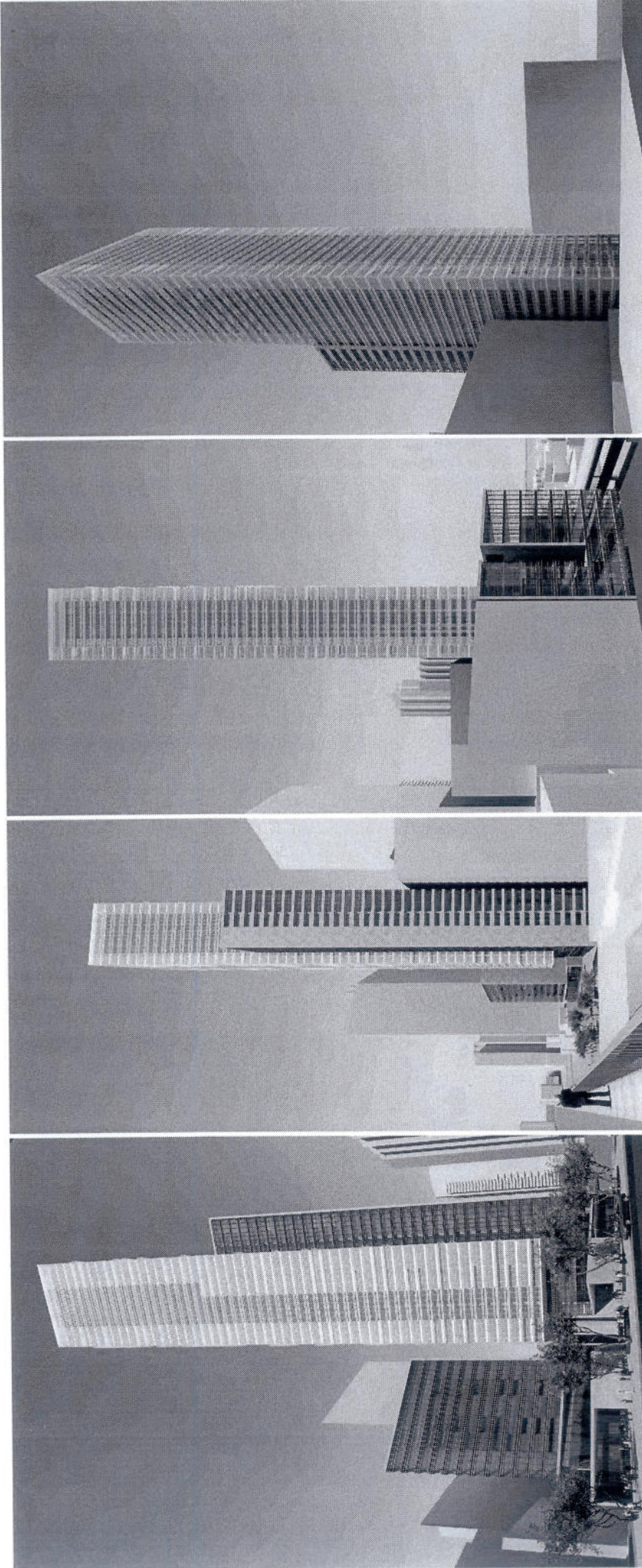
NIGHT VIEW OF THE BUILDING FROM ALFRED ST

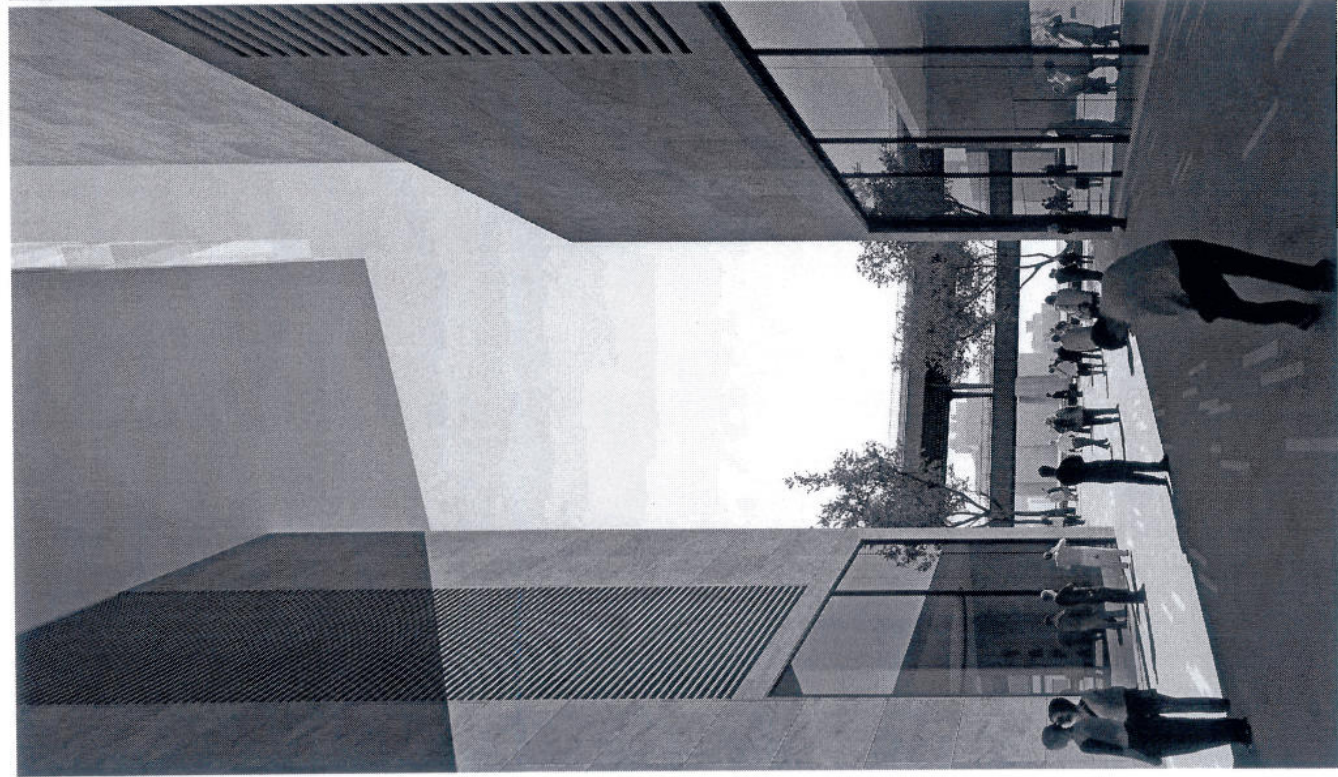
EXTERNAL BUILDING VIEWS SHOWING THE EXTENT OF FACADE TYPES

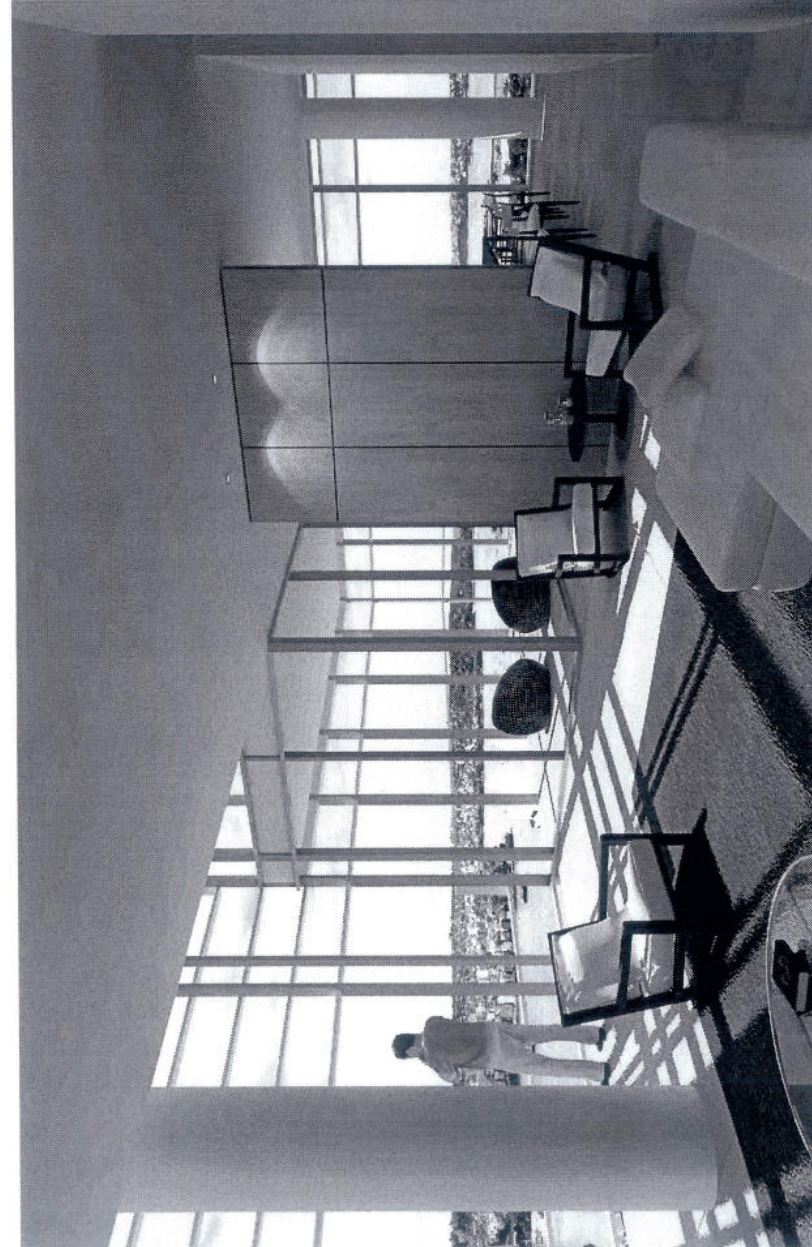

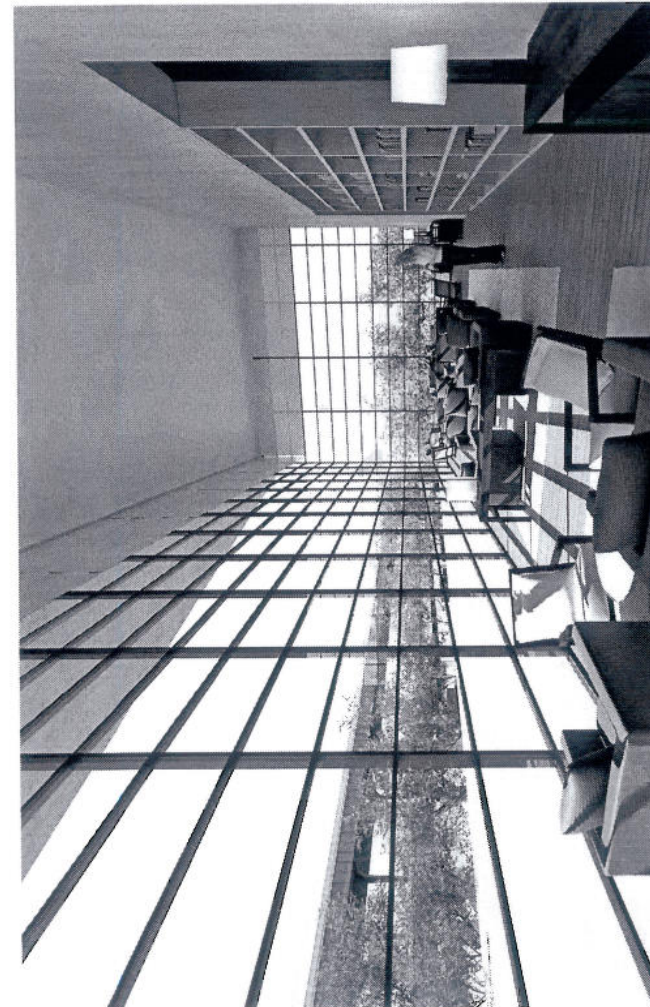
