### TRAFFIC MANAGEMENT PLAN APPROVAL

City of Sydney Council have submitted a Traffic Management Plan (TMP) in accordance with RMS' *Procedures for Use in the Preparation of a Traffic Management Plan.* Council proposes to close the southern end of Newcombe Street and reopen the northern end at Oxford Street, Paddington. The southern end will become a paved plaza and the northern end will become a street opening to Oxford Street. Signage and linemarking will also be installed to complement these changes and will be developed as part of the detailed design package.

Council proposes to implement the above changes to provide adequate vehicular access for the proposed redevelopment at 1 Newcombe Street while maintaining a safe and functional local road network in the vicinity of the site. A Road Safety Audit (RSA) is attached which the highlights several medium and low risk priority issues for the area. Pedestrian and cyclist provision will be maintained through the relocation of the plaza to the Gordon Street end of Newcombe Street. In addition, the plaza is expected to provide an improved pedestrian environment. The outcome of the community consultation indicated that the road opening/ road closure was generally supported.

Traffic flow, congestion and safety monitoring to be undertaken for the first six months of its fully occupied operation and, if required, provide mitigation for any safety/congestion issues that generate as a result of the development and new access arrangements at Newcombe Street and Oxford Street.

A copy of the traffic management plan (TMP) is attached, for reference.

The submission from City of Sydney Council has satisfactorily addressed the necessary requirements of the TMP therefore the traffic management plan is **RECOMMENDED FOR APPROVAL**.
