#### **PRESENT**

Councillors - Craig Chung, Christine Forster, Robert Kok, Jess Miller, Prof Kerryn Phelps AM, Linda Scott, Jess Scully, Philip Thalis and Angela Vithoulkas.

At the commencement of business at 5.02pm, those present were:-

The Lord Mayor, Councillors Chung, Forster, Kok, Miller, Phelps, Scott, Scully, Thalis and Vithoulkas.

The Chief Executive Officer, Chief Operating Officer, Chief Financial Officer, Director City Operations, Director Legal and Governance, Director City Planning, Development and Transport, Director City Life, Director City Engagement and Director City Projects and Property were also present.

#### Opening Prayer

The Lord Mayor opened the meeting with prayer and an acknowledgement of country.

#### ITEM 1 CONFIRMATION OF MINUTES

Moved by the Chair (the Lord Mayor), seconded by Councillor Kok –

That the minutes of the meeting of Council of Monday 20 February 2017, as circulated to Councillors, be confirmed.

Carried unanimously.

### ITEM 2 DISCLOSURES OF INTEREST

#### (a) Section 451 of the Local Government Act 1993

Councillor Linda Scott disclosed a less than significant, non-pecuniary interest in Item 8.8 on the agenda, in that she is employed by the University of Sydney, which has been recommended for one grant and not recommended for another, but the section for which she works is not related to either of the grant proposals.

Councillor Craig Chung disclosed a less than significant, non-pecuniary interest in Item 9.8 on the agenda, in that he has an interest in a property in the general vicinity of the property under consideration.

Councillor Kerryn Phelps made three disclosures, as follows:

- a less than significant, non-pecuniary interest in Item 7.3 on the agenda, in that a board member of Strata Community Australia (NSW) was also a Clover Moore Independent Team candidate at the Council election in 2016;
- a less than significant, non-pecuniary interest in Item 8.4 on the agenda, in that a
  person involved with the management of 107 Projects Incorporated made a
  donation of \$125 to the Clover Moore Independent Team campaign at the last City
  of Sydney election; and
- a less than significant, non-pecuniary interest in Item 8.9 on the agenda, in that, as
  is well known, Alex Greenwich MP is Co-Chair of Australian Marriage Equality and
  a long-time campaigner for marriage equality. Councillor Phelps said that she has
  a strong desire to see same-sex couples, including the many same-sex couples
  within the City of Sydney, being able to marry if they choose to do so. It is for that
  reason, and that reason only, she will be supporting the recommendation for this
  item.

Councillor Robert Kok made four disclosures, as follows:

- a less than significant, non-pecuniary interest in Item 7.3 on the agenda, in that a board member of Strata Community Australia (NSW) was also a Clover Moore Independent Team candidate at the Sydney Council election in 2016;
- a less than significant, non-pecuniary interest in Item 8.2 on the agenda, in that it
  has been brought to his attention that former Councillor Jenny Green, who was his
  colleague in Council, became a board member of the Australian Design Centre,
  one of the recipients recommended for increased Accommodation Grant support;
- a less than significant, non-pecuniary interest in Item 8.4 on the agenda, in that a
  person involved with the management of 107 Projects Incorporated made a
  donation of \$125 to the Clover Moore Independent Team campaign, of which he is
  a member, at the last City of Sydney election; and
- a less than significant, non-pecuniary interest in Item 8.9 on the agenda, in that Alex Greenwich MP and I were candidates on the Clover Moore Independent Team for the 2012 City of Sydney election. Since then, he and Mr Greenwich have worked together in the interests of the people of Sydney. As is well known, Alex Greenwich is Co-Chair of Australian Marriage Equality and a long-time campaigner for marriage equality. Councillor Kok said that he had a very strong desire to see all same-sex couples being able to marry if they choose to do so. It is for that reason he will be supporting the recommendation for this item.

Councillor Philip Thalis made three disclosures, as follows:

• a less than significant, non-pecuniary interest in Item 7.3 on the agenda, in that a board member of Strata Community Australia (NSW) was also a Clover Moore Independent Team candidate at the Council election in 2016;

- a less than significant, non-pecuniary interest in Item 8.4 on the agenda, in that a
  person involved with the management of 107 Projects Incorporated made a
  donation of \$125 to the Clover Moore Independent Team campaign at the last City
  of Sydney election, for which he (Councillor Thalis) stood; and
- a less than significant, non-pecuniary interest in Item 8.9 on the agenda, in that Alex Greenwich MP is Co-Chair of Australian Marriage Equality and a long-time campaigner for marriage equality, and was also a candidate for the Clover Moore Independent Team in 2012. Even though Councillor Thalis had no involvement with Mr Greenwich at that time, and does not work with him, members of the Clover Moore Independent Team do work closely with him in the interests of the people of Sydney.

Councillor Jess Scully made four disclosures, as follows:

- a less than significant, non-pecuniary interest in Item 7.3 on the agenda, in that a board member of Strata Community Australia (NSW) was also a Clover Moore Independent Team candidate at the Council election in 2016;
- a less than significant, non-pecuniary interest in Item 8.2 on the agenda, in that, in her previous role at Vivid Sydney, she programmed all three organisations into her programs, and has had contact with them over the last 15 years as she has with more organisations in the creative industries;
- a less than significant, non-pecuniary interest in Item 8.4 on the agenda, in that a
  person involved with the management of 107 Projects Incorporated made a
  donation of \$125 to the Clover Moore Independent Team campaign in the 2016
  Council election; and
- a less than significant, non-pecuniary interest in Item 8.9 on the agenda, in that Alex Greenwich MP is Co-Chair of Australian Marriage Equality and a long-time campaigner for marriage equality. Mr Greenwich was also a candidate for the Clover Moore Independent Team in 2012. While Councillor Scully did not work closely with Mr Greenwich at that time, or currently, she knows that other members of the Clover Moore Independent Team do work closely with him in the interests of the people of Sydney.

Councillor Jess Miller made three disclosures, as follows:

- a less than significant, non-pecuniary interest in Item 7.3 on the agenda, in that a board member of Strata Community Australia (NSW) was also a Clover Moore Independent Team candidate at the Council election in 2016;
- a less than significant, non-pecuniary interest in Item 8.4 on the agenda, in that a
  person involved in the management of 107 Projects Incorporated made a donation
  of \$125 to the Clover Moore Independent Team campaign at the last City of Sydney
  election; and
- a less than significant, non-pecuniary interest in Item 8.9 on the agenda, in that Alex Greenwich MP is Co-Chair of Australian Marriage Equality and a long-time campaigner for marriage equality. Mr Greenwich was also a candidate for the Clover Moore Independent Team in 2012. Councillor Miller said that she does not work closely with Mr Greenwich, but knows that members of the Clover Moore Independent Team do.

Councillor Christine Forster disclosed a less than significant, non-pecuniary interest in Item 8.9 on the agenda, in that she has worked in the past, and will continue to work in the future, with members of Australian Marriage Equality. Councillor Forster said that she would gain a great benefit if marriage equality reform happened; she has become engaged to her partner, Virginia, but needs that reform to happen before they can marry. Councillor Forster added that it was an emotionally significant interest.

The Chair (the Lord Mayor) made four disclosures, as follows:

- a less than significant, non-pecuniary interest in Item 7.3 on the agenda, in that a board member of Strata Community Australia (NSW) was also a member of the Clover Moore Independent Team at the Council election in 2016;
- a less than significant, non-pecuniary interest in Item 8.2 on the agenda, in that Jenny Green, who has recently become a board member of the Australian Design Centre, was on the Lord Mayor's team in the 2012 - 2016 period of Council;
- a less than significant, non-pecuniary interest in Item 8.4 on the agenda, in that a
  person involved with the management of 107 Projects Incorporated made a
  donation of \$125 to the Clover Moore Independent Team campaign at the last City
  of Sydney election; and
- a less than significant, non-pecuniary interest in Item 8.9 on the agenda, in that Alex Greenwich MP is Co-Chair of Australian Marriage Equality and a long-time campaigner for marriage equality. Mr Greenwich was also a candidate for the Lord Mayor's team in the 2012 Council election. Subsequently, the Lord Mayor endorsed Mr Greenwich to succeed her when the actions of the New South Wales Government made it impossible for her to continue as Lord Mayor and a Member of Parliament.

#### DA/2016/839 for alterations to 203 Cleveland Street, Redfern

The following Petition (containing 128 signatures), of which notice was given by Councillor Forster, was laid on the table.

To the Councillors of the City of Sydney

The Petition of residents of William, George, Pitt, Stirling and Cleveland Streets Redfern NSW 2016.

Brings to the attention of the Councillors DA/2016/839 for alterations to 203 Cleveland Street Redfern for conversion to a backpackers hostel. We object to this conversion under four headings:

- 1. Neighbourhood amenity
- 2. Heritage
- 3. DA Conditions eg exceeding building height limit, overshadowing of park and neighbouring houses
- 4. Contrary to Council's own Guidelines, which prohibits excess backpacker accommodation adjoining residential areas. See Control Plan 2012 section 4.4.8 objective d)

The undersigned petitioners therefore ask the Councillors to refuse the application and not allow the conversion of this important heritage property to a backpackers hostel.

- (C) authority be delegated to the Chief Executive Officer to negotiate, execute and administer the variation to the contract with Veritec Pty Ltd for the purpose of supplying the Capabiliti LMS learning management system for a term of one year and for a contract sum as indicated in confidential Attachment A to the subject report, and otherwise on terms acceptable to the City.

- (B) Council note the reasons why a satisfactory result would not be achieved by inviting tenders are:

- (i) the implementation of a new integrated HR Information System, including Recruitment Management, is already underway; and
- (ii) the extension of the contract with Mercury Search and Selection Pty Ltd will ensure continuity of recruitment management services during the transition to the new HRIS; and
- (C) authority be delegated to the Chief Executive Officer to negotiate, execute and administer the variation to the contract with Mercury Search and Selection Pty. Ltd. for the purpose of supplying and upgrading the Mercury e-Recruit recruitment management system for a term of one year and for a contract sum as indicated in confidential Attachment A to the subject report, and otherwise on terms acceptable to the City.

#### **ITEM 6.7**

# EXEMPTION FROM TENDER - GREEN SQUARE CREATIVE CENTRE - ADDITIONAL CONTINGENCY FOR HEAD CONTRACTOR AND QUANTITY SURVEYOR CONTRACTS (\$118549.006)

It is resolved that Council:

- (A) approve an exemption from tender, in accordance with section 55(3)(i) of the Local Government Act 1993, for the contracts for the construction and quantity surveyor services, noting that, due to extenuating circumstances, a satisfactory result would not be achieved by inviting tenders;
- (B) note the reasons why a satisfactory outcome would not be achieved by inviting tenders are:
  - (i) a Contractor for the construction works has already been appointed in accordance with the City's procurement processes;
  - (ii) within the current contract, a remediation subcontractor is to complete contract remediation works; and
  - (iii) the additional cost required to establish another remediation contractor on site is not considered value for money. If the work were separately contracted, it is not considered that better value for money or suitable timeframes would be achieved for Council;
- approve increased contract contingency to the existing Head Contractor to cover extended construction work as described in confidential Attachment B to the subject report;
- (D) approve increased contract value for the existing Quantity Surveyor services to cover the extended construction period as described in confidential Attachment B to the subject report;
- (E) note the financial and contractual implications detailed in confidential Attachment B to the subject report; and

(F) approve the budget shortfall to be brought forward from the South Sydney Hospital Stage 2 project forward estimates in 2022/23 into the 2016/17 financial year of this project.

    - (g) Clause 3.13 Social and Environmental Responsibilities of Sydney Development Control Plan 2012.
    - (h) Clause 4.2.1 Building height of Sydney Development Control Plan 2012.

  - (3) The proposal will result in adverse heritage impacts and fails to satisfy:

- (1) The proposal is an overdevelopment of the site and is not in the public interest contrary to Section 79C(e) of the Environmental Planning and Assessment Act 1979.
- (2) The proposal fails to demonstrate compliance with the controls and standards for boarding houses specified in the SEPP (Affordable Rental Housing) 2009 and Section 4.4.1 of the Sydney Development Control Plan 2012 (Sydney DCP 2012) and has insufficient information in regard to flooding and surveying requirements.
- (3) The proposal does not provide for bicycle parking as per the requirements in the SEPP (Affordable Rental Housing) 2009 and Sydney DCP 2012.
- (4) No BASIX certificate has been submitted as per SEPP (Building Sustainability Index: BASIX) 2004 as part of the application nor sufficient information required to satisfy State Environmental Planning Policy 55 - Remediation of Land.
- (5) The proposal fails to exhibit design excellence, as it does not achieve a high standard of architectural design, material and detailing appropriate to the site and surrounding area. The proposal does not result in good internal amenity and design and, as such, does not comply with Clause 6.21 of Sydney Local Environmental Plan 2012.

- (6) The proposal exceeds the maximum floor space ratio under Clause 4.4 of Sydney Local Environmental Plan 2012 and SEPP (Affordable Rental Housing) 2009, resulting in an overdevelopment of the site, and an inappropriate scale and intensity of development. The proposal has not demonstrated that compliance with the floor space ratio development standard is unreasonable or unnecessary or that there are sufficient environmental planning grounds to justify contravening the development standards. The proposal fails to achieve a better outcome by contravening the floor space ratio development standard and therefore fails to satisfy Clause 4.6 of Sydney Local Environmental Plan 2012.
- (7) The proposal exceeds the height in storeys control under section 4.2.1 and does not comply with the internal floor to ceiling heights and floor to floor heights of Section 4.2.1.2 of the Sydney DCP 2012.
- (8) The proposal does not satisfy the requirements for amenity, building setbacks, waste minimisation, as well as heating and cooling infrastructure, as stipulated in Section 4.2 of the Sydney DCP 2012 for mixed use developments.
- (9) The proposal does not exhibit integration with the surrounds and will result in detrimental privacy and noise impacts to the residential property located to the rear of the site at 181 St Johns Road.

Carried unanimously.

It is resolved that, pursuant to Section 80(3) of the Environmental Planning and Assessment Act 1979, a deferred commencement consent be granted to Development Application No. D/2016/853, subject to the conditions as detailed in Attachment A to the subject report to the Planning and Development Committee on 20 March 2017, subject to the amendment of the period of time nominated to satisfy the Deferred Commencement Conditions (Part A) with the Deferred Commencement Conditions (Part A) amended to read as follows (with additions shown in **bold italics** and deletions in **strikethrough**):

## PART A - DEFERRED COMMENCEMENT CONDITIONS

## (CONDITIONS TO BE SATISFIED PRIOR TO CONSENT OPERATING)

The consent is not to operate until the following conditions *is are* satisfied, within *12 24* months of the date of this determination:

# (1) DESIGN MODIFICATIONS

The design of the basement and ground level of the building must be modified to address the following:

## Car parking

(a) Amended plans shall be submitted to illustrate the deletion of all residential and the hotel car parking shown on drawings 1101 Rev E, 1102 Rev E and 1103 E dated 16/06/2016 prepared by Crone.

## Servicing

(b) Amended plans and additional information shall be submitted showing all commercial (hotel and retail) servicing to be undertaken wholly on site.

A revised basement level loading dock design shall be submitted which incorporates an area for vehicles to turn around. The area to be provided shall be designed to meet the requirements of the Australian Standards and be in accordance with Sections 3.11.6 and 3.11.13 of the Sydney DCP 2012. A swept path analysis is to be undertaken to show how the largest vehicle (maximum dimensions 6.4m with a minimum clearance of 3.5m) can turn around within the site and enter and exit the subject site.

#### Waste collection

- (c) Amended plans shall be submitted demonstrating residential waste collection shall be from Clarence Street. A residential waste storage room shall be provided on the Clarence Street frontage and shall be located within a 10m travel distance from the waste collection point. The revised design shall not impact on the activation of the Clarence Street frontage.
- (d) An amended plan shall be submitted showing a non-residential waste storage room provided in the basement.

## Flood levels

(e) The recommendations of the Flood Impact Study prepared by Calibre Consulting dated 24 February 2017 shall be incorporated into the final design modifications required to address the parking, servicing and waste issues as detailed in parts (a) to (c) above.

The recommendation of the Flood Impact Study requires a 50mm increase in the Clarence Street frontage to a 100 Year Flood Level of 17.85m AHD. No further height shall be added to the building as a result of the modification.

## Heritage interpretation devices

(f) An amended plan shall be submitted showing the following:

An interpretation device, a selection of structural elements and materials are to be retained and utilised as an interpretive measure within the new building. The components retained should include at least one of the king post trusses at 422 Kent Street and the supporting stone plinth blocks, cast iron and timber posts and beams from 277 Clarence Street. Timber flooring and pressed metal ceilings should be retained and reused as exposed finishes.

Amended plans to address the above shall be submitted to and approved by Council's Director of City Planning, Development and Transport.

## (2) SYDNEY TRAINS

Sydney Trains has provided the following concurrence conditions under the provisions of Clause 88 of State Environmental Planning Policy (Infrastructure) 2007:

- (a) The owners of the site of the approved development must enter into a Deed of Agreement with TfNSW prior to issue of any Construction Certificate to address the adverse effects of the approved development on the CBDRL identified in State Environmental Planning Policy (Infrastructure) 2007. The Agreement must provide for the following:
  - (i) the design, construction and maintenance of the approved development so as to satisfy the requirements in conditions (c) to (m) below;
  - (ii) allowances for the future construction of railway tunnels in the vicinity of the approved development;
  - (iii) allowances in the design, construction and maintenance of the approved development for the future operation of railway tunnels in the vicinity of the approved development, especially in relation to noise, vibration, stray currents, electromagnetic fields and fire safety and the like to and from railway operations;
  - (iv) consultation with TfNSW;
  - access by representatives of TfNSW and Sydney Trains to the site of the approved development and all structures on that site;
  - (vi) provision to TfNSW and Sydney Trains of drawings, reports and other information related to the design, construction and maintenance of the approved development;
  - (vii) creation of a restrictive covenant on each of the titles which comprise the approved project so as to satisfy condition (j) below;
  - (viii) such other matters which TfNSW and Sydney Trains considers are appropriate to give effect to (i) to (vii) above; and
  - (ix) such other matters as the owners and TfNSW and Sydney Trains may agree.

- (b) All structures which are proposed for construction or installation, or which are constructed or installed, in connection with the approved development which have a potential impact on the CBDRL must be designed, constructed and maintained in accordance with design criteria specified by TfNSW.
- (c) The design and construction of the basement levels, foundations and ground anchors for the approved development are to be completed to the satisfaction of TfNSW. The developer shall develop their foundation design, and any encroachment into the Exclusion Zones as indicated in drawing 482749-261 Rev 2. Cross Sectional drawings showing the proposed basement excavation and structural design of sub ground support adjacent to the rail corridor should be included for the proposed foundations. All ground anchors and rockbolts within the CBDRL protection zone adjacent to the bulk excavation face shall be temporary anchors, or removable type or fibreglass type, to avoid obstruction of any future CBDRL construction.
- (d) Prior to issue of any construction certificate the developer must undertake detailed geotechnical analysis to the satisfaction of TfNSW to demonstrate likely movements of the ground due to the future CBDRL.
- (e) No modifications may be made to that the approved design without the consent of TfNSW.
- (f) A detailed regime is to be prepared for consultation with, and approval by, TfNSW for the excavation of the site and the construction of the building foundations (including ground anchors) for the approved development, which may include geotechnical and structural certification in the form required by TfNSW.
- (g) TfNSW, and persons authorised by it for this purpose, are entitled to inspect the site of the approved development and all structures to enable it to consider whether those structures on that site have been or are being constructed and maintained in accordance with these conditions of consent, on giving reasonable notice to the principal contractor for the approved development or the owner or occupier of the part of the site to which access is sought.
- (h) All requirements contained in the Agreement between TfNSW and the owners of the site must be satisfied during construction and, where appropriate, the operation of the approved development.
- (i) Copies of any certificates, drawings or approvals given to or issued by TfNSW must be delivered to Council for its records.
- (j) Prior to the commencement of any excavation below existing ground level, a restrictive covenant is to be created upon each of the titles which comprise the approved development pursuant to Section 88E of the Conveyancing Act 1919, restricting any alterations or additions to any part of the approved development which are reasonably likely to adversely affect, or which otherwise are likely to interfere with the design, construction and operation of the proposed Sydney Metro the prior written consent of TfNSW.

- (k) All structures must be designed, constructed and maintained so as to avoid any damage or other interference, which may occur as a result of noise and vibration from (future) railway operations. The Applicant is to submit a report to Sydney Trains for review demonstrating how the proposed development will comply with the Department of Planning's document titled "Development Nera Rail Corridors and Busy Roads Interim Guideline". The assessment must consider noise and vibration from future underground rail; tunnel construction and operation. The Proponent must incorporate in the development all the measures recommended in the report.
- (I) Prior to the issue of a Construction Certificate the applicant is to engage an Electrolysis Expert to submit a report to Sydney Trains on Electrolysis Risk to the development from stray currents. The Applicant must incorporate in the development all the measures recommended in the report to control that risk.
- (m) Any contamination issues encountered during the development of the site are to be resolved taking cognizance of the future railway.
- Evidence that will sufficiently enable Council to be satisfied as to those
  matters identified in deferred commencement conditions, as indicated above,
  must be submitted to Council within 42 24 months of the date of this
  determination of this deferred commencement consent failing which, this
  deferred development consent will lapse pursuant to section 95(6) of the
  Environmental Planning and Assessment Act 1979.
- The consent will not operate until such time that the Council notifies the Applicant in writing that deferred commencement consent conditions, as indicated above, have been satisfied.
- Upon Council giving written notification to the Applicant that the deferred commencement conditions have been satisfied, the consent will become operative from the date of that written notification, subject to the conditions of consent, as detailed in Part B – Conditions of Consent (Once the Consent is in Operation), and any other additional conditions reasonably arising from consideration of the deferred commencement consent conditions.

## LOSS OF PARKING SPACES WITHIN THE LGA (S129269)

# 1. By Councillor Forster

#### Question

Since 2012, how many on-street car parking spaces and loading zones have been removed in the City of Sydney local government area as a result of the construction of separated cycleways? How many more on-street parking spaces and loading zones will be removed as a result of planned separated cycleway projects, broken down by individual project?

Since 2012, how many on-street car parking spaces and loading zones have been removed in the City of Sydney local government area as a result of streetscape improvement projects and footpath widening projects, broken down by individual project?

## **Answer by the Lord Mayor**

There are approximately 39,000 spaces in the LGA and losses since 2012 constitute about 0.8% of these spaces. Projects always aim to minimise on-street parking losses.

Since 2012, approximately 150 car parking spaces and six loading zone spaces have been removed as a result of the separated cycleways completed or under construction. A further 111 spaces will be removed as a result of cycleway projects currently in planning or design.

Since 2012, approximately 38 car parking spaces and two loading zone spaces have been removed as a result streetscape improvement and footpath widening projects completed or under construction. A further 13 spaces will be removed as a result of streetscapes projects currently in planning or design.

These losses include projects implemented by other organisations such as by Roads and Maritime Services.

## **LORD MAYOR EXPENSES (S129269)**

There have been 248 formal access applications received up to 1 July 2011 and since 23 April 2015. There have been 8,860 informal access requests received since 23 April 2015.

More details of formal access applications are published annually in the City's Annual Report — Statutory Returns. - requests relating to council expenditure.

A breakdown of categories, numbers in each and summary information relevant to formal access decisions made is published annually in the City's Annual Report – Statutory Returns. ## **Answer by the Lord Mayor**

The NSW Local Government Act provides for the Lord Mayor as the leader of the City, to be the principal spokesperson for the Council, to carry out the civic and ceremonial functions of the office, and to represent the council (section 226). As I routinely attend and officiate at City events, I appear in many official photographs and reports on the city's work.

In each of the 2014/15 and 2015/16 financial years, the City produced and sent out six Business, 12 Creative City and 12 Green Villages electronic emails to subscribers. City billboards were campaign-led material and did not feature the Lord Mayor.

In 2014/15, there were 17 flyers and direct mail items about City programs, projects, policies and decisions of Council that featured a message from the Lord Mayor. These cost approximately \$140,000 to print and distribute. The equivalent figures for 2015/16 are 25 items that cost approximately \$180,000 to print and distribute.

The City does not have technology to scan through the thousands of social media posts during the two year period. The City's social media posts promote the City's work, events and programs. I have my own social media channels.

# (A) Council note:

- (i) there are approximately 800 City of Sydney public street bins located across the local government area, most with a capacity of 90 litres;
- (ii) each year 6,000 tonnes of waste is collected by the City of Sydney from street and park bins across the local government area;
- (iii) street bins located in high pedestrian areas are emptied up to six times per day;
- (iv) other councils, including the City of Melbourne and Canada Bay Council, have begun the installation of solar powered rubbish compacting bins;
- (v) each of these bins has a capacity of 600 litres, more than six times that of common street litter bins;
- (vi) the bins compact rubbish as it is collected, reducing by five the number of collections required compared with a standard public street bin;
- (vii) the bins use cloud technology to alert Council staff when they require emptying, reducing the need for physical monitoring and eliminating waste overflow; and
- (viii) the utilisation of these bins provides a number of environmental and economic benefits, including a reduction in rubbish collection truck movements by up to 80 per cent, resulting in lower greenhouse gas emissions, a decrease in traffic congestion, fuel savings and reduced waste management costs; and
- (B) the Chief Executive Officer be requested to:
  - (i) investigate options for the installation and trial of a number of solar powered rubbish compacting bins in the City of Sydney local government area; and
  - (ii) report back to Councillors via a CEO Update on the results of that investigation at the earliest opportunity.

Carried unanimously.

#### **CITY OF SYDNEY DASHBOARD (\$129260)**

2. Moved by Councillor Forster, seconded by Councillor Chung -

It is resolved that:

#### (A) Council note:

- the municipal governments of many major cities around the world have implemented "dashboard" digital technology, which combines real-time official, observational and social media data onto a single screen for viewing on computers and smart phones;

- (iii) a City of Sydney Dashboard would provide the 1.2 million residents, businesses, students and visitors the City serves each day with valuable real-time information about what is going on around the local government area;
- (iv) at the City of Sydney Council meeting of 29 June 2015, I moved a motion requesting the Chief Executive Officer investigate the possibility of developing and implementing a City of Sydney Dashboard;
- (v) this motion was then amended and it was unanimously resolved that the CEO write to the Department of Premier and Cabinet advocating the NSW Government investigate the feasibility of establishing a Sydney Dashboard; and
- (vi) given the lack of progress on the project to date, the City of Sydney should consider moving forward with developing the Dashboard in its own right; and
- (B) the Chief Executive Officer be requested to:
  - (i) investigate the possibility of developing and implementing a City of Sydney Dashboard; and
  - (ii) report back to Council with the results of that investigation at the earliest opportunity.

# **LIVE STREAMING OF COUNCIL MEETINGS (\$129259)**

4. Moved by Councillor Chung, seconded by Councillor Forster -

- (A) note:
  - (i) live streaming of Council meetings provides access, transparency, accountability, openness and good governance to the conduct of Council meetings;
  - (ii) live streaming of Council meetings is an issue of equity and allows those constituents who are unable to attend meetings in person to engage in the democratic process. This is particularly true for women and families, workers who cannot attend meetings at 5.00pm, residents with disability and access issues, residents with childcare obligations, those with transport challenges and business owners who are unable to attend a Council meeting at 5.00pm;
  - (iii) utilising Council's Facebook page and other direct channels to publicise the live streaming of Council meetings will immediately expose a large number of constituents and stakeholders to the proceedings of Council;
  - (iv) broadcasting is entirely consistent with the long-standing practice of many other NSW metropolitan and regional councils, as well as federal and state parliaments, which televise proceedings in order to make them accessible to all members of the public;
  - (v) as a Global City, Sydney is lagging behind the world's leading cities on openness and transparency by not permitting live streaming of Council meetings;
  - (vi) live streaming of Council meetings meets the Lord Mayor's stated objectives of being consultative, open, transparent and accountable and reinforces her statement that "Peoples' democratic rights should be defended"; and
  - (vii) live streaming provides an archived public record of discussions and resolutions made by Council. It means that all Councillors are equally subject to public scrutiny, which is a fundamental tenet of public office and democracy; and
- (B) request that the Chief Executive Officer:
  - (i) undertake a 12 month trial of live streaming of all City of Sydney Council meetings, such trial to commence no later than May 2017;

- (ii) ensure all live streams are archived permanently for direct public access from Council's website:
- (iii) widely publicise the trial for a period of no less than 12 months with a permanent and prominent first page notice on Councils' website, letter box drops to all residents and businesses, social media and other appropriate media;
- (iv) ensure that the words of each speaker are clear and audible to all viewers listening to the broadcast; and
- (v) amend the City of Sydney Code of Meeting Practice to enable the live streaming of Council meetings.

Moved by the Chair (the Lord Mayor), seconded by Councillor Forster -

That Councillor Chung be granted an extension of time of two minutes to speak on this matter.

Carried.

#### **RESTAURANT COMPOSTING (S129266)**

5. Moved by Councillor Scott, seconded by Councillor Miller -

- (A) note:
  - according to the City of Sydney's website, almost "50 per cent of Sydney's waste is generated from the commercial and industrial sectors, yet only 28 per cent of this waste is recycled";
  - (ii) according to Destination NSW's website <a href="www.sydney.com">www.sydney.com</a>, there are some 658 restaurants listed in Sydney City;
  - (iii) according to <a href="www.goodfood.com.au">www.goodfood.com.au</a>, the average Australian restaurant or café bins 120g of every plate of food it serves, or the equivalent of 250,000 tonnes of food waste each year; and
  - (iv) the City's existing efforts to facilitate community composting; and

(B) request the Chief Executive Officer to assess the viability of establishing a trial of an opt-in green waste and compost service for the City's businesses and residents.

Variation. At the request of Councillor Miller, and by consent, the motion was varied such that it read as follows:

It is resolved that Council note that:

- (A) according to the City of Sydney's website, almost "50 per cent of Sydney's waste is generated from the commercial and industrial sectors, yet only 28 per cent of this waste is recycled";
- (B) according to Destination NSW's website <a href="www.sydney.com">www.sydney.com</a>, there are some 658 restaurants listed in Sydney City;
- (C) according to <a href="www.goodfood.com.au">www.goodfood.com.au</a>, the average Australian restaurant or café bins 120g of every plate of food it serves, or the equivalent of 250,000 tonnes of food waste each year;
- (D) the City's existing efforts to facilitate community composting; and
- (E) the draft Waste Strategy, which will be presented to Council shortly, will assess and recommend actions to improve food and organic waste recovery.

The motion, as varied by consent, was carried.

# **SMART PHONE LOAN PROGRAM FOR ROUGH SLEEPERS (S129266)**

6. By Councillor Scott -

- (A) note:
  - (i) on the night of the February 2017 City of Sydney Street Count, 9% of crisis accommodation beds were not occupied;
  - (ii) the briefing Councillors received on homelessness from NSW Police, NSW Family and Community Services and the City's Homelessness Unit, on Monday, 13 February 2017; and
  - (iii) during the 13 February briefing, Councillors were advised, among other things, that homelessness services could not always fill crisis accommodation because services often had no immediate way to contact the relevant individuals; and
- (B) request the Chief Executive Officer to assess the viability of establishing a smart phone loan program for rough sleepers with the function of:
  - (i) receiving donated smart phones from individuals and businesses; and

(ii) loaning them to rough sleepers for the purposes of receiving updates as to available crisis accommodation as well as other support services, for a period until they are assigned accommodation.

Note – at the meeting of Council, the content of the original Notice of Motion was varied by Councillor Scott. Subsequently, it was:

Moved by Councillor Scott, seconded by Councillor Scully -

It is resolved that Council:

- (A) note:
  - (i) on the night of the February 2017 City of Sydney Street Count, 9% of crisis accommodation beds were not occupied;
  - the briefing Councillors received on homelessness from NSW Police, NSW Family and Community Services and the City's Homelessness Unit, on Monday, 13 February 2017;
  - (iii) during the 13 February briefing, Councillors were advised, among other things, that homelessness services could not always fill crisis accommodation because services often had no immediate way to contact the relevant individuals; and
  - (iv) research has found high rates of mobile phone ownership amongst rough sleepers, but issues with access to charging and funds to pay for usage; and
- (B) request the Chief Executive Officer to:
  - (i) explore options for the establishment of a communication support program to improve access to mobile phone charging and use for rough sleepers with the NSW Government and local service providers, with the aim of connecting them to crisis accommodation as well as other support services; and
  - (ii) report back via the CEO update with options and actions taken by the City to progress options.

Carried unanimously.

#### **CRAFT BEER (S129266)**

7. Moved by Councillor Scott, seconded by Councillor Chung -

- (A) note:
  - (i) that, according to the IBISWorld Industry Report, Craft Beer Production in Australia, the craft beer industry will grow by 5% over the next five years;
  - (ii) that, according to Australian Beer International, the Craft Beer Industry is worth approximately \$400 million;

- (iii) that, according to the Australian Bureau of Statistics, consumption of beer decreased by 7% between 2009 and 2014; and
- (iv) that the growth of craft beer has coincided with the overall decrease in the consumption of beer; and
- (B) request that the Chief Executive Officer consult with the City's craft beer and microbreweries to examine the impact of the City's planning approval process on their businesses.

Foreshadowed Motion. Councillor Thalis foreshadowed that, should the motion moved by Councillor Scott be lost, he would move the following alternative motion.

It is resolved that Council note that:

- (A) according to the IBISWorld Industry Report, Craft Beer Production in Australia, the craft beer industry will grow by 5% over the next five years;
- (B) according to Australian Beer International, the Craft Beer Industry is worth approximately \$400 million;
- (C) the City's planning controls permit craft breweries in a range of areas, but higher land costs and fewer suitable sites for breweries mean development of Sydney's craft breweries is mostly occurring outside of the City in cheaper industrial zones;
- (D) there are very few craft breweries in the City and they are generally secondary to other uses, such as pubs and restaurants, in contrast to many craft breweries outside of the City:
- (E) the City has supported the development of a varied mix of venues, such as small bars, to build a diverse, prosperous, eclectic, active, safe and unique night time culture, which may include a craft brewery; and
- (F) the City has not received any representations about planning barriers to craft breweries, but continues to receive representations from small bar operators about the State Government's liquor licensing laws which is the focus of the City's advocacy.

The motion moved by Councillor Scott was lost on the following show of hands –

- Ayes (4) Councillors Chung, Forster, Scott and Vithoulkas
- Noes (6) The Lord Mayor, Councillors Kok, Miller, Phelps, Scully and Thalis.

Motion lost.

Councillor Thalis then moved his foreshadowed motion, seconded by Councillor Scully.

Carried unanimously.

### **Vote of Thanks**

At this stage of the meeting, the Chair (the Lord Mayor) advised that Jenny Davis, who has been a Committee Secretary at Council for 18 years, has announced her retirement as from 31 March 2017. The Chair (the Lord Mayor) thanked Jenny very much for her work over those years.
