At the completion of the notification period, the City had received 117 submissions objecting to alcohol restrictions and 29 submissions in support.

340 submissions were received which referred to the current lockout laws in place across the CBD Entertainment Precinct and are therefore not relevant to this consultation

An additional 10 submissions were received requesting the establishment of a new alcohol free area and zones that will be considered in the future, as this consultation focused on the renewal of existing zones and areas only.
