SUMMARY

The City of Sydney's Grants and Sponsorship Program supports initiatives and projects that build the social, cultural, environmental and economic life of the city. To achieve the objectives of Sustainable Sydney 2030 requires genuine partnership between government, business and the community.

The provision of grants and sponsorships is a mechanism to further the aims identified in the City's social, economic and environmental policies. Applications are assessed against these policies and against broad City objectives and plans. In this way, the City and the community act collaboratively to bring to life *Sustainable Sydney 2030* and the City of Villages it envisions.

The City advertised the following eight grant programs in our Round One Grants and Sponsorship Allocation:

- Community Services Grant Program;
- Cultural and Creative Grants and Sponsorship Program;
- Environmental Performance Building Operations Grant Program;
- Environmental Performance Innovation Grant Program;
- Environmental Performance Ratings and Assessment Grant Program;
- Festivals and Events Sponsorship Program (Artform or Village and Community);
- Matching Grant Program; and
- Village Business Grant Program.

In total, 152 eligible applications were received across the eight programs. This report recommends a total of 53 grants to a total value of \$1,204,704 and \$260,494 revenue foregone/value-in-kind (VIK) for the 2015/16 and 2016/17 financial year and commitments of \$5,142,498 in cash and \$1,545,046 revenue foregone/value-in-kind (VIK) for future financial years 2017/18 to 2019/20.

This report also includes two out of round grants, \$50,000 in cash to Redfern Legal Services Contract for the extension of the Miller's Point Tenancy Services under the Community Services Grant Program, and multi-year cash support of \$202,437 in 2016/17 and \$207,498 in 2017/18 and VIK of up to \$53,000 per year to Access Sydney Community Transport to continue to operate the Village to Village shuttle bus service for a period of two years.

In addition, this report recommends that Council approve the termination of an existing grant agreement and the grant of a new agreement to a different organisation to deliver the same program due to an operational change related to the previously approved funded program. Negotiations between the relevant parties are still underway (refer confidential Attachment L for further details).

On 15 September 2014, Council adopted a revised Grants and Sponsorship Policy and all grants in this report were assessed against criteria and guidelines set in this revised Policy.

All applications were considered with reference to Sustainable Sydney 2030; the Grants and Sponsorship Policy; the Creative City Cultural Policy and Action Plan; the Economic Development Strategy; OPEN Sydney Strategy and Action Plan; social and environmental policies and plans and the Inclusion (Disability) Action Plan.

All grant recipients will be required to sign a contract, meet specific performance outcomes and acquit their grant.

All figures in this report exclude GST.

BACKGROUND

- 1. The City of Sydney's Grants and Sponsorship Program supports residents, businesses and not-for-profit organisations to undertake initiatives and projects that build the social, cultural, environmental and economic life of the city.
- 2. On 27 January 2016, eight of the City's grants programs were announced as being open for applications on the City's website, with grant applications closing on 7 March 2016.
- 3. The eight promoted programs were:
 - (a) Community Services Grant Program;
 - (b) Cultural and Creative Grants and Sponsorship Program;
 - (c) Environmental Performance Building Operations Grant Program;
 - (d) Environmental Performance Innovation Grant Program;
 - (e) Environmental Performance Ratings and Assessment Grant Program;
 - (f) Festivals and Events Sponsorship Program (Artform or Village and Community);
 - (g) Matching Grant Program; and
 - (h) Village Business Grant Program.
- 4. Information about these grant programs (such as application dates, guidelines, eligibility criteria and sample applications) was made available on the City's website. The City actively promoted the programs through Avant Card distribution, radio live reads, Facebook, Twitter, Instagram, as well as the City's Green Villages and Creative City websites. Email campaigns were also utilised to target interested parties who have applied previously for grants at the City or who have expressed an interest in the City's programs.
- 5. Following adoption of the revised Grants and Sponsorship Policy on 15 September 2014, the Matching Grant Program and Cultural and Creative Grants and Sponsorship Program are open to appropriately incorporated for-profit organisations. 17 applications were received this round from for-profit organisations and the following six for-profit organisations are recommended in this report:
 - (a) Art Pharmacy Pty Ltd;
 - (b) Christopher Domergue;
 - (c) Intimate Spectacle Pty Ltd;
 - (d) M.P Fitzsimmons & R.J Whittington;
 - (e) The Music and Booze Company Pty Ltd; and
 - (f) Wingdings & Things Pty Ltd.

- 6. These applications met the Cultural and Creative Grants and Sponsorship Program and Matching Grant Program for-profit eligibility criteria, clearly demonstrating that the applicants' requests for funding were for the benefit of the community; were grassroots, local initiatives; and evidenced that the applicants were working in collaboration with community and local business. For-profit applicants were also required to evidence a cash or in-kind contribution equivalent to the funding requested from the City to be eligible for funding in these programs.
- 7. Park hire requests are not listed in the table for recommendations, as not-for-profit organisations are eligible for free park hire. However, these organisations must pay the \$100 application fee and other related fees and charges such as electricity and water. Individuals or unincorporated community groups are required to be auspiced by a not-for-profit organisation to be eligible for free park hire. All park hire is subject to availability.
- 8. It is expected that all successful applicants will work co-operatively with relevant City staff throughout the project for which they have received funding. Contact details for the relevant City staff are provided to all successful grant recipients.
- 9. All grants and sponsorships are recommended on the condition that any required approvals, permits and development consents are obtained by the applicant.
- 10. The City's Grants and Sponsorship Program is highly competitive. Applications that are not recommended have either not scored as highly against the assessment criteria as the recommended applications or have incomplete or insufficient information. The City's Grants and Sponsorship team provides feedback and support to unsuccessful applicants.
- 11. The assessment process includes advice and recommendations from the key stakeholders on the assessment panel, depending upon the nature of each submission. The integrity of the proposed budget, project plan, contributions and partnerships are assessed, scored and ranked against defined criteria. Once recommended applications are approved by Council, a contract is developed, which includes conditions that must be adhered to, and acquitted against.
- 12. In assessing the grant applications, the assessment panels included in their considerations and recommendations:
 - (a) Sustainable Sydney 2030;
 - (b) the Grants and Sponsorship Policy;
 - (c) Creative City Cultural Policy and Action Plan;
 - (d) Economic Development Strategy
 - (e) OPEN Sydney Strategy and Action Plan;
 - (f) Social and environmental policies and plans; and
 - (g) Inclusion (Disability) Action Plan.
- 13. City staff consider the contribution from the applicant and other sources in reviewing applications. Applicants are asked to demonstrate a capacity to source other types of funding or contribute their own resources (cash or in-kind).

14. Applicants are requested to list their project's community partners, confirmed funding sources and the contribution the organisation is making to the project (cash or inkind) to demonstrate their contribution.

Community Services Grant Program (\$5,000 to \$50,000 for up to three years funding)

- 15. Community organisations that work in or for the City of Sydney Local Government Area (LGA) provide significant benefits to the city community through the development and delivery of activities, projects or resources. The work they undertake helps meet the needs of the diverse city community, in particular the needs of more disadvantaged residents.
- 16. The Community Services Grant Program recognises the value of this work and contributes to it through grants to non-profit organisations based in, or providing events or services of benefit to the community in the City LGA.
- 17. The panel assessing Community Services Grant Program applications was comprised of the City's Manager Social Programs and Services, Project Manager Childcare, Manager City Spaces with the specialist input of the City's Senior Community Programs Officer, City Spaces Centre Manager, Community Engagement Coordinator, Project Manager, Manager Social Policy and Programs, Social Policy Officer, Area Manager South, City Historian, Manager Child And Family Services and Community Services Worker.
- 18. The applications recommended for the Community Services Grants Program are outlined in Attachment A to this report. The applications that are not recommended are listed in Attachment B to this report.
- 19. Where a grant for more than one year has been recommended, it is noted in the body of the table (under '\$ Amount Recommended') and in Attachment A to this report.

COMMUNITY SERVICES GRANT PROGRAM – OUT OF ROUND APPLICATION

21. The City received one out of round application that was assessed under the Community Services Grants Program. The application is being considered out of round in order to respond to continuing need for legal services through the extension of the existing contract.

Redfern Legal Centre - Extension of the Miller's Point Tenancy Services

- 22. In April 2014, the City provided a grant of \$100,000 to Redfern Legal Centre for the delivery of the Millers Point Tenants Service. This service provides legal support and advice to residents of social housing in the Millers Point area who were affected by the State Government's announcement in March 2014 to sell social housing properties in the area. Council approved two six-month extensions of the grant in April and November 2015, with total funding of \$200,000 provided over the two years.
- 23. Approximately 78 tenants remain in the area, with 64 being assisted under this grant. There continues to be a demand for the service, with an increase in support for residents in more complex circumstances and with the commencement of the Housing NSW 'formal offer' process that can result in termination proceedings. The City has received an application from Redfern Legal Services for grant funding of \$50,000 to extend the service for an additional six months from May 2016 to December 2016. The funding will deliver drop-in advice sessions, individual advice and advocacy, representation in tribunal hearings and legal information and publications for tenants. The panel has recommended supporting the extension of services and a grant of \$50,000. After three months, the grant will be reviewed to assess ongoing demand for the service.

Cultural and Creative Grants and Sponsorship Program (\$5,000 to \$50,000 for up to three years funding)

- 24. The Cultural and Creative Grants and Sponsorship Program supports projects and initiatives that provide opportunities for creative participation, enhance creativity in the public domain and strengthen the sustainability and capacity of the city's cultural and creative industries.
- 25. The assessment panel for Cultural and Creative Grants and Sponsorship was comprised of Cultural Projects Coordinator, Cultural Projects Manager, Program Manager Events, Manager Cultural Strategy with the specialist input of City Historian, Strategy Advisor Live Music, City Business Funding Coordinator, Manager Child and Family Services, Events Officer, Social Policy Officer, Area Manager West, and Public Art Program Manager. The assessment meeting was chaired by Executive Manager, Creative City.
- 26. The applications recommended for the Cultural and Creative Grants and Sponsorship Program are outlined in Attachment C to this report. The applications that are not recommended are listed in Attachment D to this report.

Environmental Performance Grant Program

- 28. The three environmental performance grant programs outlined in the City of Sydney's Grants and Sponsorship Policy are designed to address barriers to action and help catalyse the innovative solutions that are required to deliver the sustainability objectives of Sustainable Sydney 2030.
- 29. The Environmental Performance Building and Operations Grant Program aims to improve the environmental performance of buildings by lowering the costs and mitigating the barriers of implementing building operations efficiency measures, such as water retrofits in apartment buildings.
- 30. Two applications have been assessed and are recommended for funding under the Building and Operations Grant Program to a total value of \$9,000 for water monitoring equipment to be installed at Grand Apartments, Kent Street Sydney, and Sonoma Apartments in Waterloo. Water monitoring will provide timely information for Strata management to reduce potable water consumption through the management of leaks and the operation of water using plant and equipment in the building.
- 31. The Environmental Performance Innovation Grant Program supports feasibility and demonstration projects that seek to prove the feasibility of new technologies and processes that are currently not implemented in the local market, but that have the potential to achieve greenhouse gas emission reductions and resource efficiencies at scale within the City LGA.
- 32. One application has been assessed under the Innovation Grant Program and is not recommended for funding (details are included in Attachment F). City staff will offer feedback to the applicant not awarded funding at this time.

- 33. The Environmental Performance Ratings and Assessment Grant Program aims to address barriers to the uptake of building performance ratings and assessments across energy, water, waste and other sustainability aspects. The ratings and assessments enable the building owner to understand their opportunities to improve environmental performance.
- 34. Three applications have been assessed under the Ratings and Assessment Grant Program and are recommended for funding to a total value of \$16,700 for residential water and energy assessments across three residential apartment buildings, located in Kent Street, Sydney, Sussex Street, Sydney and Alexandria. The information provided by these ratings and assessment will inform energy and water efficiency opportunities for applicants.
- 35. The assessment panel for the Environmental Performance Grants was comprised of the City's Grants Officer, Senior Project Manager, Sustainability Engagement Manager, Sustainability Engagement Coordinator, Manager Carbon Strategy, and Sustainability Programs Officer. The assessment meeting was chaired by Manager Sustainability Programs.
- 36. The applications recommended for Environmental Performance Grants are outlined in Attachment E to this report. The applications that are not recommended or were ineligible for this grant program are listed in Attachment F to this report.

Festivals and Events Sponsorship Program (\$5,000 to \$30,000 for new applicants or localised festivals or by negotiation for established festivals and events)

38. The Festivals and Events Sponsorship Program aims to support festivals and events that celebrate, develop and engage the city's communities. The City provides support for festivals and events under two categories; Artform or Village and Community.

- 39. Artform festivals and events provide a contemporary overview of developments in each artform, including innovative contexts for the work of artists, connect artists to audiences and meet the City's broader cultural priorities.
- 40. The assessment panel for Festivals and Events Sponsorship (Artform) was comprised of the Manager Culture and Creativity, Manager Cultural Projects, Creative Director Producer and Cultural Development Coordinator. The assessment meeting was chaired by Executive Manager, Creative City.
- 41. Village and Community festivals and events celebrate the spirit of a community and build opportunities to share its cultural characteristics with a wider public, or events that nurture and amplify the unique characteristics of the city and village precincts, meet the City's broader place-making objectives and showcase a local community, including local business.
- 42. The assessment panel for Festivals and Events Sponsorship (Village and Community) was comprised of Business Precincts Manager, Area Manager South, Manager Grants, Campaign Manager Cycling and Business Precincts Coordinator. The assessment meeting was chaired by Manager, Social Programs and Services.
- 43. The applications recommended for the Festivals and Events Sponsorship Program are outlined in Attachment G to this report. The applications that are not recommended or were ineligible for this grant program are listed in Attachment H to this report.

- 46. The Matching Grant Program provides matched funding of up to \$10,000 for any projects that improve, enhance, or celebrate the City's Villages. Council approved the development of this program to support identified grassroots community projects by matching with City resources what is contributed in cash or in-kind by the community.
- 47. To be eligible for funding, applications to the Matching Grant Program must demonstrate a matched cash contribution or VIK contribution to the project at least equal to the amount requested from the City.
- 48. The assessment panel for this Matching Grant allocation was comprised of the City's Area Manager North, Grants Program Coordinator, Strategy Advisor Culture with the specialist input of Waste Strategy Manager, Community Engagement Coordinator, Public Art Program Manager, Cycling Manager, Parks Assets and Services Manager, Area Manager East, Social Policy Officer, Area Manager South, Homelessness Project Coordinator, City Historian, Manager Child And Family Services, Policy and Programs Development Officer, Community Garden and Volunteer Coordinator and Senior Community Program Officer. Amendments to grants approved by Council on 21 March 2016

51. The Matching Grant to SUPPORT Opportunity and Care Inc. needs to be amended due to a change in organisational name to Mentor and Support Limited.

Village Business Grant Program

- 52. The City LGA has a number of unique local village economies. The villages have a distinct and diverse character and contribute to the economic, social and cultural life of Sydney. These villages play a fundamental role in the city's economy, collectively generating a quarter of the city's output, or \$25 billion per annum. They are employment hubs, accounting for almost 35 per cent of jobs (more than 151,000) outside the CBD and Chinatown.
- 53. There are an estimated 21,600 small businesses in the City LGA. Approximately 60 per cent (or over 13,000) of these businesses are located in the villages. The Village Business Grant Program supports initiatives and projects that seek to enhance local commercial and retail precincts; build capacity in business; strengthen local business networks; and enhance diversity, precinct brand and character of place. Projects that encourage and stimulate local business and economic activity help build strong and sustainable local economies, and create employment opportunities in local areas.
- 54. The City undertakes a number of programs to support economic development in the City's villages including capacity building events, retail and promotional campaigns. The popular Business 101 seminar series reaches over 1,000 new and existing businesses each year. Retailer workshops also prove popular with topics such as visual merchandising and in-store experiences. Retail / precinct campaigns to leverage major events include the Sydney is Fashion program, Asia on your Doorstep, Good Food Month Village Adventures and Christmas in the Villages. Marketing collateral including flyers, postcards, booklets and media familiarisation tours showcase the village offerings and customer research helps local business to understand the profile of their customer base.

- 55. To provide leveraging opportunities, the City produces major events including Chinese New Year, Lunar Feasts, Art and About, Sydney Christmas and Sydney New Year's Eve in addition to providing support for Mardi Gras, Sydney Fringe Festival, Sydney Writers Festival and Vivid. The City also supports local business through the Business Improvement Grants, NSW Business Chamber Awards and Sydney Food Truck program to achieve the objectives of the Economic Development Strategy.
- 56. Open for applications twice a year, the Village Business Grant Program provides cash funding of up to \$80,000 (excluding GST) for non-profit incorporated associations with strong support from and engagement with business in their local precinct or industry.
- 57. The assessment panel for the Village Business Grant Program Round One was comprised of the Business Precincts Manger, Business Precinct Coordinator and Grants Program Coordinator. The assessment meeting was chaired by Manager City Business and Safety.
- 58. The City has received five applications for support under the Village Business Grant Program 2016/17 Round One.

Potts Point Partnership

- 59. Potts Point Partnership aims to create a thriving, sustainable business community in Potts Point and Woolloomooloo. The organisation has 102 financial members. Potts Point Partnership is working to a three year strategic plan and has submitted a one year operational plan with their application.
- 60. Potts Point Partnership has applied for funding of \$80,000 for 2016/17. Of the four projects applied for, three projects have been recommended for one year funding to a total of \$50,400 as outlined in the table below:

61. Reduced funding is recommended for Project 2 for project management costs, as the application did not adequately demonstrate the need for this cost and investment in time.

- 62. No funding is recommended for Project 3 as assessors are concerned about the capacity of Potts Point Partnership to deliver the project due to the non-completion of previously funded activities. The website is currently inactive and the City has previously provided funding for website enhancement and updates, and social media engagement. Targets have not been met for some, while measurement of the impact of others has not been captured or adequately reported. The information provided in the application and additional information does not demonstrate the need for this project, describe the specific activities/deliverables that form the project or demonstrate the organisation's capacity and capability to deliver the project.
- 63. Project 4 is recommended for reduced funding based on comparative funding offered to other Chambers/Associations for similar activities and concerns about the capacity of the organisation to deliver (demonstrated by non-delivery of similar projects in a previously awarded grant).
- 64. Potts Point Partnership had a project completion rate of 38 per cent against the agreed Key Performance Indicators (KPIs) of their 2014/15 agreement. A project change request was submitted and approved in December 2015 allowing funds to be redirected from a Christmas Activation project to the development of a three year strategic plan, and \$10,000 funding was forfeited at the request of the organisation across four of the five projects funded.
- 65. Feedback about this from the organisation included the suggestion that the agreed KPIs in the grant agreement were too onerous given the size and resources of the Potts Point Partnership, some projects were not able to be delivered due to capacity constraints and other projects were taking longer than expected to deliver.
- 66. Current funding for the partnership was awarded for 2015/16 Round One in June 2015. This contract was executed on 11 March 2016 and includes a media familiarisation tour, digital and other marketing activities, networking events and the first phase of the Villages of East Sydney Partnership Association (VESPA) project.

Darlinghurst Business Partnership

- 67. Darlinghurst Business Partnership aims to foster a creative, individualist community, with a core focus on art, culture, communication, lobbying and advocacy. The organisation has 88 financial members.
- 68. Darlinghurst Business Partnership has submitted a one year strategic business plan with their application. Strong working relationships have been established with adjoining business associations forming the VESPA.
- 69. Darlinghurst Business Partnership has applied for funding of \$78,500 for 2016/17. Of the five projects applied for, five are recommended for one year funding to a total of \$78,500 as outlined in the table below:

70. The contract conditions set out for Project 4 are recommended to ensure that final, key information is provided to the City before the full release of funds for the project. Assessors have made this recommendation to ensure that although Council requires additional information, this does not impact the proposed timeframe for the implementation of this project.

Surry Hills Creative Precinct

- 71. Established in 2014, Surry Hills Creative Precinct seeks to highlight and encourage the area's vitality; support new partnerships; to bring new projects to fruition; and to have Surry Hills as a recognised international destination for outstanding design.
- 72. A one year operation or three year strategic plan was not provided with the application. The organisation has 24 financial members.
- 73. Surry Hills Creative Precinct has applied for funding of \$80,000 for 2016/17. Of the five projects applied for, two are recommended for one year funding to a total of \$25,000 as outlined in the table below:

- 74. The organisation acquitted their 2014/15 grant (project period January 2015 December 2015) in February 2016, having completed the projects funded over a two year period. Projects funded with this grant included precinct brand research, business development workshops and a scoping study for an app.
- 75. The organisation did not submit a strategic or operational plan with this application and noted that whilst ideas had been provided with the previous application, a full strategic plan would be provided in June 2016. Without a strategic or operational plan it is difficult to determine how the projects proposed meet the strategic objectives of the organisation or reflect the views of the organisation's members.
- 76. Project 5 is recommended for funding as it is a collaborative project with a developed project plan, timeline, budget and activities. Key activities are supported for project 1 as assessors could identify (from the previously funded phase of this project) the need for the continued development of the initiative. However the information provided was underdeveloped and assessors could only support a portion of the activities proposed (as outlined in the grant conditions). The information provided for projects 2, 3 and 4 was inadequate. The projects were unclear, budgets were speculative, outcomes were unclear and there is no basis to determine if they align with the objectives of the organisation or its members, there was a lack of demonstrated need for the projects and assessors are concerned about the capacity of the organisation to deliver the projects.

Australian Fashion Chamber

- 77. Australian Fashion Chamber is the peak industry body for fashion designers and works to strengthen, protect and nurture the originality, influence and success of Australian fashion, both domestically and globally. The AFC has 61 financial members, with the majority located within the City LGA and many of its programs, services and activities centred here.
- 78. Australian Fashion Chamber has applied for funding of \$50,000 for 2016/17 and 2017/18. Of the five projects applied for, five are recommended for two year funding to a total of \$40,000 as outlined in the table below:

79. Reduced funding was recommended for all projects to bring the project management costs into line with comparative funding levels.

MusicNSW

- 80. MusicNSW is the peak body for the contemporary music industry in NSW and is working with key industry partners to establish a Sydney Live Music Alliance.
- 81. The objective of the Sydney Live Music Alliance is to strengthen Sydney's live music industry, be responsive to current issues facing the industry, develop strategic responses, advocate with government and key industry bodies, and form working groups for the effective delivery of strategies.
- 82. 15 individual representatives from Sydney's live music and performance industry have committed their support to MusicNSW and will work together to establish the Alliance and its activities. A further 14 organisations (representing a broad range of organisations in the live music and performance industry) have also committed to the Alliance as founding members and will form the Steering Committee that will oversee the development of the Alliance.
- 83. MusicNSW has applied for funding of \$30,000 for one project in 2016/17 to support project management costs, engage a strategic planner, coordinate steering group activities and fund the development of communication and engagement tools and resources. The project has been recommended for funding for the 2016/17 financial year as outlined in the table below:

Out of Round Application - Extension of the Access Sydney Community Transport - Village to Village Shuttle Bus Service

- 86. Village to Village services are free, fixed route shuttle buses that aim to fill the gap between public transport and specialist community transport services. They provide access to shops, medical care, cultural activities, community services and other transport services for people who experience, or are at risk of experiencing transport disadvantage. Reasons for transport disadvantage range from impaired mobility or financial difficulty, to not being serviced by public transport, or not meeting the age or disability eligibility criteria for specialist community transport services. The Village to Village service runs four routes from 9am-5pm on Thursdays and Fridays:
 - Route 1 Redfern to Broadway, via Glebe: serving residents from Redfern, Glebe, Forest Lodge and connecting to Royal Prince Alfred Hospital, and Broadway Shopping Centre.
 - Route 2 Woolloomooloo to Redfern, via Chinatown: serving residents from Woolloomooloo, Waterloo, Potts Point, Darlinghurst, Surry Hills and Redfern, and connecting to St Vincent's Hospital, and Paddy's Markets.
 - Route 3 Redfern to Broadway, via Alexandria: serving residents from Redfern, Roseberry, Beaconsfield, Green Square, Alexandria, Erskineville, Newtown and connecting to Royal Prince Alfred Hospital, and Broadway Shopping Centre.
 - Route 4 Broadway to Woolloomooloo, via CBD serving residents from Glebe, Pyrmont, Millers Point and Woolloomooloo, connecting to Broadway Shopping Centre.
- 87. The City has provided a grant to Access Sydney Community Transport (formerly South East Sydney Community Transport) to operate the Village to Village service since 2007. The current three-year grant ends on 30 June 2016.
- 88. A 2011 review found that the service is highly effective and efficient to run, and recommended it continue. Commonwealth Government aged care and disability reforms will eventually impact on future funding for community transport services however new arrangements have not been announced. Service providers have had current funding extended to June 2018. Implementation of a broader Community Transport Transition Strategy for the City has been placed on hold to allow the full implications of Commonwealth Government aged care reforms to be assessed in the context of both the City's community transport provision and the wider community transport sector. It is anticipated that the outcomes of these reforms will be known during 2016/17 and implemented from 2018/19.
- 89. Sydney's public transport network has changed in recent years, with improved wheelchair accessibility at buses and stations, increased frequency, additional evening and weekend services, revised bus routes and the introduction of Opal ticketing.

- 90. As a result, some of the Village to Village bus routes are now partially duplicating some public bus services and may not be effectively addressing other gaps in the public transport network. These finding are consistent with current usage data provided by the operator that shows Routes 1 and 2 experiencing high demand and Routes 3 and 4 experiencing limited or no demand.
- 91. In addition, construction of light rail will continue to change the face of public transport in the City in coming years.
- 92. It is recommended that the current Village to Village service grant be extended for two years to June 2018, with the grant agreement offering flexibility in determining the frequency and route for services based on an ongoing assessment of demand and public transport gaps.
- 93. Flexible service delivery will be achieved through a costing of services at an hourly rate rather than an annual rate. This will allow for adjustments to routes and frequency of services to better match ongoing need, and up to a limit of 64 total hours of service per week. Any changes to routes will be determined by agreement between the City and the service provider through six-monthly reviews, and in consultation with service users. Access Sydney has requested funding of \$202,437 to provide up to 64 hours of service per week (\$121.65 per hour). This is commensurate with current rates of service provision.
- 94. Access Sydney Community Transport's fleet of 13 buses (used to deliver Village to Village and a range of other community transport services) are housed at the City's Bay Street depot in Ultimo. They have requested that this arrangement be continued, which is an estimated VIK contribution of \$53,300.
- 95. Access Sydney are an Accredited Bus Operator under NSW Roads and Maritime Services requirements. A condition of this accreditation is that vehicles are securely garaged. Access Sydney continue to be unable to identify suitable alternative depot facilities from which to operate. This is largely due to the limited availability of depot space within the City and the high rental value of inner-city facilities. It is anticipated that sufficient space for vehicles will continue to be available during planned upgrades to the Bay Street facility (2016-2018), however Access Sydney Community Transport may need to be relocated temporarily to an alternate location if required.

Amended Grant Recipient

96. This report also recommends that Council approve the termination of an existing grant agreement and the grant of a new agreement to a different organisation to deliver the same program due to an operational change related to the previously approved funded program. Negotiations between the relevant parties are still underway (refer confidential Attachment L for further details).

KEY IMPLICATIONS

Strategic Alignment - Sustainable Sydney 2030

97. This report complies with the Grants and Sponsorship Policy adopted by Council on 15 September 2014. The provision of grants and sponsorships is a mechanism for the City to further the aims identified in its social, economic, environmental and cultural policies. The City of Sydney's Grants and Sponsorship Program is a key element in the delivery of Sustainable Sydney 2030. All applications are considered against the 10 strategic directions and how they can directly deliver, or encourage the further development of the aims and objectives identified in Sustainable Sydney 2030.

Organisational Impact

98. The grants and sponsorships contract management process will involve key staff across the City of Sydney. Identified staff set contract conditions and performance measures for each approved project and review project acquittals, which include both narrative and financial reports.

Social / Cultural / Community

99. The City's Grants and Sponsorship Program provides the City with a platform to support cultural, social and environmental initiatives from the communities, and community organisations, within the City LGA.

BUDGET IMPLICATIONS

- 100. A total of 53 eligible grants are recommended in this report. This includes a total value of:
 - (a) 2015/16 \$25,700 in cash for Environmental Performance Grants from the available \$77,197 budget (the remaining \$51,497 is reserved for the subsequent allocation of the program);
 - (b) 2016/17 \$1,179,002 in cash and \$207,494 in revenue foregone/VIK from the proposed draft 2016/17 budget, details are as follows:
 - (i) Community Services Grant Program \$418,760 recommended from the proposed draft budget of \$418,814 (the remaining \$54 is reserved in the Grants and Sponsorship budget);
 - (ii) Cultural and Creative Grants and Sponsorship Program \$228,500 recommended from the proposed draft budget of \$645,000 (the remaining \$416,500 is reserved for the subsequent allocation of the program);
 - (iii) Festivals and Events Sponsorship (Artform) \$260,000 recommended from the proposed draft budget of \$553,938 (the remaining \$293,938 is reserved for the subsequent allocation of the program);
 - (iv) Festivals and Events Sponsorship (Village and Community) \$125,000 recommended from the proposed draft budget of \$175,000 budget (the remaining \$50,000 is reserved for the subsequent allocation of the program);

- (v) Matching Grant Program \$139,165 recommended from the proposed draft budget of \$450,000 (the remaining \$310,835 is reserved for the subsequent allocations of the program);
- (vi) Village Business Grant Program \$223,900 recommended from the proposed draft budget of \$444,205 (the remaining \$220,305 is reserved for the subsequent allocations of the program); and
- (vii) Village to Village Shuttle Bus \$202,437 from the \$202,437 available in the Grants and Sponsorship budget; and
- (c) Forward Commitments 2017/18 to 2019/20 \$5,142,498 in cash and \$1,545,046 revenue foregone/VIK (this amount will be incorporated in future budgets proposed).

RELEVANT LEGISLATION

- 101. Section 356 of the Local Government Act 1993. Section 356(3)(a) to (d) is satisfied for the purpose of providing grant funding to for-profit organisations.
- 102. Attachment L contains confidential information which, if disclosed, would prejudice the commercial position of the person who supplied it.
- 103. Discussion of the matter in an open meeting would, on balance, be contrary to the public interest because it would compromise the commercial position of the person to which the confidential attachment relates.

CRITICAL DATES / TIME FRAMES

- 104. The funding period for the Round One Grants and Sponsorship Allocation for 2016/17 is for activity taking place from 1 July 2016 to 30 June 2017. Contracts will be developed for all successful applications after Council approval to ensure their funding is released in time for projects starting in July.
- 105. The funding period for grants and sponsorship awarded under the Environmental Performance Grant Program in this report is for activity taking place between 1 June 2016 and 30 June 2017. Contracts will be developed for all successful applications after Council approval to ensure their funding is released in time for projects starting in June.

PUBLIC CONSULTATION

- 106. Two grants and sponsorship drop-in sessions were held in Town Hall House to assist potential applicants with their applications on the following dates:
 - (a) Tuesday 9 February 2016 at 4.30pm; and
 - (b) Tuesday 23 February 2016 at 4.15pm.
- 107. 68 organisations made 77 registrations to attend the grants and sponsorship dropin sessions.
- 108. 49 organisations attended 53 drop-in sessions seeking advice from City staff about their project proposals and the application process.

109. 64 per cent of the attendees at the drop-in sessions advised they had not applied for a City of Sydney grant previously.
