ITEM 8. GRANTS AND SPONSORSHIP - ROUND ONE 2017/18 - SOCIAL GRANTS - COMMUNITY SERVICES GRANTS, FESTIVALS AND EVENTS SPONSORSHIP (VILLAGE AND COMMUNITY) AND MATCHING GRANTS

SUMMARY

The City of Sydney's Grants and Sponsorship Program supports initiatives and projects that build the social, cultural, environmental and economic life of the city. To achieve the objectives of *Sustainable Sydney 2030* requires genuine partnership between government, business and the community.

The provision of grants and sponsorships is a mechanism to further the aims identified in the City's social, economic and environmental policies. Applications are assessed against these policies and against broad City objectives and plans. In this way, the City and the community act collaboratively to bring to life *Sustainable Sydney 2030* and the City of Villages it envisions.

The City advertised the following three grant programs in Round One of the annual grants and sponsorship program for 2017/18:

- Community Services Grant Program;
- Festivals and Events Sponsorship Program (Village and Community); and
- Matching Grant Program.

For the Community Services Grant Program which pursues social outcomes, 37 eligible applications were received. This report recommends a total of 10 grants to a total value of \$316,300 and \$343 revenue foregone/value-in-kind for the 2017/18 financial year and commitments of \$55,000 in cash and \$159 revenue foregone/value-in-kind for the 2018/19 financial year.

For the Festivals and Events Sponsorship Program (Village and Community) Program which pursues social and economic outcomes, 17 eligible applications were received. This report recommends a total of 13 grants to a total value of \$402,600 and \$65,639 in revenue foregone/value-in-kind for the 2017/18 financial year and commitments of \$69,500 in cash and \$2,000 revenue foregone/value-in-kind for future financial years 2018/19 and 2019/20.

For the Matching Grant Program which pursues social, economic, cultural and environmental outcomes, 33 eligible applications were received. This report recommends a total of 18 grants to a total value of \$118,720 and \$5,911 revenue foregone/value-in-kind for the 2017/18 financial year.

On 15 September 2014, Council adopted a revised Grants and Sponsorship Policy and all grants in this report were assessed against criteria and guidelines set in this revised Policy.

All applications were considered with reference to *Sustainable Sydney 2030*, the Grants and Sponsorship Policy, the Creative City Cultural Policy and Action Plan, the Economic Development Strategy, the Environmental Action 2016-2021 Strategy and Action Plan, the Inclusion (Disability) Action Plan, OPEN Sydney Strategy and Action Plan, and the Social Sustainability Policy.

All grant recipients will be required to sign a contract, meet specific performance outcomes and acquit their grant.

All figures in this report exclude GST.

BACKGROUND

- 1. The City of Sydney's Grants and Sponsorship Program supports residents, businesses and not-for-profit organisations to undertake initiatives and projects that build the social, cultural, environmental and economic life of the city.
- 2. On 8 February 2017, the City announced Round One of the annual grants program for 2017/18 as being open for applications on the City's website, with grant applications closing on 13 March 2017.
- 3. The three social programs promoted were:
 - (a) Community Services Grant Program;
 - (b) Festivals and Events Sponsorship Program (Village and Community); and
 - (c) Matching Grant Program.
- 4. Information about these grant programs (such as application dates, guidelines, eligibility criteria and sample applications) was made available on the City's website. The City actively promoted the programs through radio live reads, Facebook, Twitter, Instagram, What's On and Multicultural NSW's mailing list, as well as the City's Green Villages and Creative City websites. Email campaigns were also utilised to target interested parties who have applied previously for grants at the City or who have expressed an interest in the City's programs.
- 5. Following adoption of the revised Grants and Sponsorship Policy on 15 September 2014, the Matching Grants Program is open to appropriately incorporated for-profit organisations and partnerships. Three applications were received this round from for-profit organisations and a partnership and the following for-profit organisation and partnership are recommended in this report:
 - (a) M.p Fitzsimmons & R.j Whittington; and
 - (b) Wingdings & Things Pty Ltd.
- 6. All applicants are required to evidence a cash or in-kind contribution equivalent to the funding requested from the City to be eligible for funding in these programs.
- 7. Park hire requests are not listed in the table for recommendations, as not-for-profit organisations are eligible for free park hire. However, these organisations must pay the \$100 application fee and other related fees and charges, such as electricity and water. Individuals or unincorporated community groups are required to be auspiced by a not-for-profit organisation to be eligible for free park hire. All park hire is subject to availability.
- 8. It is expected that all successful applicants will work co-operatively with relevant City staff throughout the project for which they have received funding. Contact details for the relevant City staff are provided to all successful grant recipients.
- 9. All grants and sponsorships are recommended on the condition that any required approvals, permits and development consents are obtained by the applicant.

- 10. The City's Grants and Sponsorship Program is highly competitive. Applications that are not recommended have either not scored as highly against the assessment criteria as the recommended applications or have incomplete or insufficient information. The City's Grants and Sponsorship team provides feedback and support to unsuccessful applicants.
- 11. The assessment process includes advice and recommendations from the key stakeholders on the assessment panel, depending upon the nature of each submission. The integrity of the proposed budget, project plan, contributions and partnerships are assessed, scored and ranked against defined criteria. Once recommended applications are approved by Council, a contract is developed, which includes conditions that must be adhered to, and acquitted against.
- 12. In assessing the grant applications, the assessment panels included in their considerations and recommendations:
 - (a) Sustainable Sydney 2030;
 - (b) Grants and Sponsorship Policy;
 - (c) Creative City Cultural Policy and Action Plan;
 - (d) Economic Development Strategy;
 - (e) Environmental Action 2016-2021 Strategy and Action Plan;
 - (f) Inclusion (Disability) Action Plan;
 - (g) OPEN Sydney Strategy and Action Plan; and
 - (h) Social Sustainability Policy.
- 13. City staff consider the contribution from the applicant and other sources in reviewing applications. Applicants are asked to demonstrate a capacity to source other types of funding or contribute their own resources (cash or in-kind).
- 14. Applicants are requested to list their project's community partners, confirmed funding sources and the contribution the organisation is making to the project (cash or inkind) to demonstrate their contribution.

Community Services Grant Program (\$5,000 to \$50,000 for up to three years funding)

- 15. Community organisations that work in or for the City of Sydney local government area provide significant benefits to the city community through the development and delivery of activities, projects or resources. The work they undertake helps meet the needs of the diverse city community, in particular the needs of more disadvantaged residents.
- 16. The Community Services Grant Program recognises the value of this work and contributes to it through grants to non-profit organisations based in, or providing events or services of benefit to the community in the local area.

- 17. The panel assessing Community Services Grant Program applications was comprised of the City's Social Policy Officer, the Acting Grants Coordinator, the Community Programs Officer (LGBTIQ), with the specialist input of the City's Executive Manager Research, Strategy and Corporate Planning, the Manager Social Policy and Programs, the Homelessness Project Coordinator, the Middle Childhood Services Coordinator, the Community Engagement Coordinator, the Social Policy Officer, the Youth and Community Officer and the Public Space Liaison Officer. The assessment meeting was chaired by the Manager, Social Programs and Services.
- 18. The applications recommended for the Community Services Grants Program are outlined in Attachment A to this report. The applications that are not recommended are listed in Attachment B to this report.
- 19. Where a grant for more than one year has been recommended, it is noted in the body of the table (under '\$ Amount Recommended') and in Attachment A to this report.

Overview of 2017/18 Community Services Grant Program

Festivals and Events Sponsorship (Village and Community) Program (\$5,000 to \$30,000 for new applicants or localised festivals or by negotiation for established festivals and events)

20. The Festivals and Events Sponsorship Program aims to support festivals and events that celebrate, develop and engage the City's communities. The City provides support for festivals and events under two categories; Artform or Village and Community.

- 21. Village and Community festivals and events celebrate the spirit of a community and build opportunities to share its cultural characteristics with a wider public, or events that nurture and amplify the unique characteristics of the city and village precincts, meet the City's broader place-making objectives and showcase a local community, including local business.
- 22. The assessment panel for Festivals and Events Sponsorship (Village and Community) was comprised of the City Business Coordinator (Industry and Place), the Area Manager East and Acting Manager Grants. The assessment meeting was chaired by the Manager City Business and Safety.
- 23. The applications recommended for the Festivals and Events Sponsorship Program are outlined in Attachment C to this report. The applications that are not recommended are listed in Attachment D to this report.

Centipede at Glebe School Incorporated

24. Centipede at Glebe School Inc is a not-for-profit organisation that operates an Outside School Hours Care service catering for school-aged children aged 4-12 on the school grounds of Glebe Public School. The City has been providing support to the service since 2006. Without this support the service would not be financially viable. However, City staff have been working closely with Centipede to help them improve their financial planning and ability to work within their budget. As a result of this work, the City has been able to incrementally reduce the value of the grant to Centipede from \$50,000 provided in 2015/16 and previous years to \$45,000 in 2016/17, and a further reduction to \$40,000 in 2017/18 is recommended. It is noted that support for the organisation's core business is outside the Grants and Sponsorship Guidelines.

Sydney Gay and Lesbian Mardi Gras

- 25. The City of Sydney has provided cash and in-kind support to the Sydney Gay and Lesbian Mardi Gras for over 20 years. In 2014, Council resolved for Sydney Gay and Lesbian Mardi Gras to conduct a review to improve its longer term sustainability by way of a \$20,000 grant. In response, the organisation has completed a Parade Transformation Feasibility Study to determine whether it is possible and/or desirable to change the current route of the parade in order to improve the sustainability and viability of the event. An initial study has been conducted that considered the broad viability of alternative parade routes, including crowd capacity and crowd management, as well as space requirements at the beginning and end of the route. This work is continuing, however, the parade route will not change for the 2018 season.
- 26. The organisation has applied for a triennial grant of \$320,000 cash in year 1 and \$240,000 cash in years 2 and 3, in addition to \$49,700 value-in-kind in each year. The additional request for \$80,000 cash in year 1 is to support activities associated with the 40th Anniversary of the first parade and protest in 1978.
- 27. Mardi Gras is entering a period of change, including progressing with parade route feasibility studies, changing board membership, continuing strategic planning for the future and improving governance arrangements. On this basis, the recommendation is to provide triennial funding in the following format and with the following conditions:

- Year 1 \$240,000 cash and \$49,700 value-in-kind in support of core festival costs and an additional \$80,000 cash for a public art installation celebrating the festival's 40th anniversary and includes the following conditions;
 - (i) applicant to provide a revised budget;
 - (ii) applicant to submit a revised marketing plan in consultation; and
 - (iii) applicant to submit an engagement plan for local businesses; and
- (b) Years 2 and 3 \$240,000 cash and \$49,700 value-in-kind each year for the 2019 and 2020 festivals and includes the following conditions:
 - funding for years 2 and 3 to only be released with Chief Executive Officer satisfaction towards the organisation's delivery of the previous year's festival and governance structures.

Matching Grant Program (up to \$10,000 for up to 12 months funding)

- 28. The Matching Grant Program provides matched funding of up to \$10,000 for any projects that improve, enhance, or celebrate the City's Villages. Council approved the development of this program to support identified grassroots community projects by matching with City resources what is contributed in cash or in-kind by the community.
- 29. To be eligible for funding, applications to the Matching Grant Program must demonstrate a matched cash contribution or value-in-kind contribution to the project at least equal to the amount requested from the City.
- 30. The assessment panel for this Matching Grant allocation was comprised of the City's Manager City Spaces, the Library and Learning Programs Coordinator Technology and Grants Officer with the specialist input of the Manager, Culture and Creativity, the Manager Social Policy, the City Historian, the Community Engagement Coordinator, the Urban Ecology Coordinator, the Senior Community Program Officer, the Senior Social Programs Officer, the Sustainability Engagement Officer, the Community Garden and Volunteer Coordinator, the Public Spaces Liaison Officer, the Community Programs Officer (LGBTIQ) and the Social Policy Officer. The assessment meeting was chaired by the Acting Manager Grants.
- 31. The applications recommended for the Matching Grant Program are outlined in Attachment E to this report. The applications that are not recommended are listed in Attachment F to this report.

Overview of 2017/18 Matching Grant Program

KEY IMPLICATIONS

Strategic Alignment - Sustainable Sydney 2030

32. This report complies with the Grants and Sponsorship Policy adopted by Council on 15 September 2014. The provision of grants and sponsorships is a mechanism for the City to further the aims identified in its social, economic, environmental and cultural policies. The City of Sydney's Grants and Sponsorship Program is a key element in the delivery of *Sustainable Sydney 2030*. All applications are considered against the 10 strategic directions and how they can directly deliver, or encourage the further development of the aims and objectives identified in *Sustainable Sydney 2030*.

Organisational Impact

33. The grants and sponsorships contract management process will involve key staff across the City of Sydney. Identified staff set contract conditions and performance measures for each approved project and review project acquittals, which include both narrative and financial reports.

Cultural / Economic / Environment / Social

34. The City's Grants and Sponsorship Program provides the City with a platform to support cultural, economic, environmental and social initiatives from the communities, and community organisations, within the local area.

BUDGET IMPLICATIONS

- 35. A total of \$917,620 in cash and \$71,893 in revenue foregone/value-in-kind from the proposed draft 2017/18 budget is provided as follows:
 - (a) Community Services Grant Program \$316,300 in the draft budget of \$1,081,000;
 - (b) Festivals and Events Sponsorship (Village and Community) \$482,600 in the draft budget of \$1,139,000;
 - (c) Matching Grant Program \$118,720 in the draft budget of \$410,000; and
 - (d) Revenue foregone/value-in-kind \$71,893 is provided in the draft venue hire and street banner hire budgets which total \$1,280,000.
- 36. Additionally, this report includes forwards commitments of \$604,500 in cash and \$101,559 revenue foregone/value-in-kind (these amounts will be incorporated in future budgets proposed).

RELEVANT LEGISLATION

37. Section 356 of the *Local Government Act 1993*. Section 356(3)(a) to (d) is satisfied for the purpose of providing grant funding to for-profit organisations.

CRITICAL DATES / TIME FRAMES

38. The funding period for Round One of the grants and sponsorship annual program for 2017/18 is for activity taking place from 1 August 2017 to 31 July 2018. Contracts will be developed for all successful applications after Council approval to ensure their funding is released in time for projects starting in August.

PUBLIC CONSULTATION

- 39. For all programs open to application in Round One of the annual grants and sponsorship program for 2017/18, two Q&A sessions were held in Town Hall House to assist potential applicants with their applications on the following dates:
 - (a) Wednesday 15 February 2017 at 4pm 6.30pm; and
 - (b) Tuesday 28 February 2017 at 4pm 7pm.
- 40. Sixty-five meetings were held across the two Q&A sessions where prospective applications sought advice from City staff about their project proposals and the application process.
- 41. Seventy-five per cent of these attendees advised they had not applied for a City of Sydney grant previously.
