The new areas increase opportunities for picnicking, ball sports etc., and to visually connect them to the existing parklands. The Master Plan balances a range of landscape settings to and guides the evolution of a diverse, sustainable and activated parklands.	
1	Please remove palms close to canal	The Master Plan does not propose removal of the palms. A Tree Management Plan will be prepared by the City Arborist to facilitate ongoing tree management and future replacements.	
1	Please don't remove too many trees	The Master Plan does not outline specific tree removals. Detailed site investigations will be undertaken at the individual project level to minimise tree loss. An aim of the Sydney 2030 Strategy is to increase tree canopy across the Local Government Area	
1	Want trees for shade	Shade and trees in our parks are an integral element. The Master Plan proposes to improve existing canopies with new trees, and proposes opportunities for more substantial areas of vegetation areas around The Hill and in Harold Park.	Additional trees in The Crescent have been included to increase shade and amenity.
1	Want more trees along The Crescent	The Master Plan includes street trees along The Crescent where possible between Nelson Street and Johnston Street. The existing and new trees in Federal Park south bring the parklands to the edge of the street. New trees are proposed in the Crescent open space area to provide shade, define park areas and focus view through the parklands and heritage viaducts	Additional street trees to The Crescent are included in the north of the Crescent and shown adjacent to Harold Park redevelopment.

1	Don't remove or destroy any habitat for native animals	The Master Plan does not include the removal of any habitat. A key strategy of the Master Plan is to increase areas of habitat and includes, improved canopy, areas for revegetation, protection and expansion of saltmarsh communities, expansion of wetlands, and new cliff face habitat.	
1	Don't create habitat areas at the expense of recreational/open space	The Master Plan balances the requirements for passive and active recreation and areas of habitat. The areas of habitat expand on existing communities around the Hill and existing saltmarsh in Federal Park, and is opportunistic in capturing and treating stormwater.	The amended Master Plan will reduce the size of the proposed saltmarsh at the foreshore by 40%, to ensure a balance between maintaining open lawn areas at the foreshore and expanding this ecologically endangered community.

4	Flooding/stormwater is a problem	The parklands are located at the bottom of a large stormwater catchment and some areas of the parkland are subject to flooding and poor drainage. The Master Plan proposes strategies to improve the usability of waterlogged active sports areas such as Federal Park field and Jubilee Oval. The water treatment proposals including new wetlands, saltmarsh and canal naturalisation improve the impact of flooding in the parklands.	
2	Water quality is a problem	A key strategy of the Master Plan is to improve the quality of water before it reaches the canal and Rozelle Bay. Water quality is improved with treatment by vegetation-lined swales, rain gardens and freshwater wetlands.	
3	Like all the water management proposals	Noted.	
1	Like all the proposals to manage stormwater - please extend them	Noted for further consideration in the design development of individual projects.	
1	Want WSUD	Water Sustainable Design is a key element in the Master Plan. Water quality is improved with treatment by vegetation-lined swales, rain gardens and freshwater wetlands. These components are incorporated in Harold Park, and new freshwater wetland across the canal in Federal Park South and in the Crescent. These systems will treat stormwater from the surrounding residential catchments before it enters the canal and Rozelle Bay.	
1	Manage stormwater further back in catchment	The WSUD proposals in the Master Plan consider the treatment of the Toxteth Estate catchment, up to the ridge of Glebe Point Road, and a portion of lower Anandale catchment, to the ridge beyond Johnston Street. The Sydney's 2030 Strategy also sets targets for water reuse and stormwater improvement across the LGA. Raingardens to filter run-off and reduce peak load and water reuse tanks for irrigation use are implemented in projects across the whole catchment.	
1	Manage gross pollutants via boom gate over Johnstons Creek	There are several gross pollutant traps proposed in association with the water management scheme.	
1	Use stormwater for irrigation	The Master Plan proposes stormwater capture for treatment and irrigation, to align with the City of Sydney's 2030 strategy to reduce drinkable water demand for irrigation.	
1	Use stormwater to generate hydro power	City of Sydney's 2030 strategy identifies a range of opportunities to reduce energy consumption and generate energy through sustainable methods. Current projects include wind turbine and solar collectors. Unfortunately the use of stormwater to generate hydro power is not achievable at this stage.	
1	Would like to be able to swim in Rozelle Bay	The proposed stormwater treatment will improve quality of the water in the Bay. Further stormwater treatment projects, monitoring and testing would be required all with the aspiration to be able to swim in the Bay one day.

Supporting material to better explain the proposed character of the new spaces has been included in the Master Plan. The amended Master Plan will remove the courts at the Crescent.

The proposals include improving the existing playing fields at Jubilee and Federal Park, and including an additional junior playing field at the Crescent. In addition, the parklands will support a range of sporting facilities such as skate, cycling, play spaces, and courts.	
5	Want multi-purpose sports facilities	Noted. A key strategy is to ensure all spaces are flexible and available for a broad range of users. This ensures multi-purpose facilities throughout the parklands.
