# ITEM 2 CONFIRMATION OF MINUTES OF MEETING 2014/06 HELD ON 16 JULY 2014

## DECISION

The Committee endorsed the Minutes.

#### ITEM 3 ITEM FOR COMMITTEE INFORMATION – SAFETY IMPROVEMENTS – INTERSECTION OF EUSTON ROAD AND MADDOX STREET ALEXANDRIA (2013/217908)

#### RECOMMENDATION

It is recommended that the Committee note and support:

- (A) The introduction of a dedicated right-turn arrow for motorists travelling north on Euston Road turning right into Maddox Street;
- (B) The introduction of a signalised pedestrian crossing across Maddox Street (west);
- (C) The banning of the right-turn traffic movement from Euston Road (south) into Maddox Street (west); and
- (D) The City to commission traffic surveys in Lawrence Street, Alexandria six months after the signal upgrade to determine if further traffic calming is required in the local area.

#### DECISION

The Committee carried the recommendation unanimously.

#### BACKGROUND

The Roads and Maritime Service (RMS) invited Council to nominate projects for the Federal Government's Nation Building Black Spot and the NSW Government's Black Spot Programs which seeks to reduce crashes on Australian roads. These programs fund treatments at dangerous "black spot" locations where high rates of road crashes occur.

To be considered for funding, a location must have a minimum of three (3) casualty crashes over a five year period with the proposed treatment having a Benefit Cost Ratio (BCR) of 2.0 or more.

The City nominated the intersection of Euston Road and Maddox Street for the 2014/15 Black Spot Program. Between 1 July 2007 and 30 June 2012, this intersection recorded a total of 13 crashes of which 11 resulted in injuries and ten involved the right-turn movement from Euston Road into Maddox Street. Between 1 July 2012 and 30 June 2013, a further two crashes involving the right-turn from Euston Road into Maddox Street have occurred at this intersection.

On 4 July 2014, the City received confirmation from the RMS that this location had received 50/50 funding to upgrade the traffic signals as part of the 2014/15 Black Spot Program. The City has accepted this funding to upgrade the intersection.

The funds from the 2014/15 Program will be used to upgrade the traffic signals to provide:

- a dedicated right-turn arrow for motorists travelling north on Euston Road turning right into Maddox Street;
- a signalised pedestrian crossing across Maddox Street (west); and

• the banning of the right-turn traffic movement from Euston Road (south) into Maddox Street (west).

Euston Road is a State Road under the control of the RMS while Maddox Street is local road under the control of the City. The RMS is the consent authority for all traffic signals and they must give support to any proposed change to traffic signals.

This intersection is currently controlled by traffic signals. All approaches have through movements with filtered left and right-turns. Both arms of Euston Road and only the eastern arm of Maddox Street have signalised pedestrian crossings over them.

#### ITEM 4 ITEM FOR COMMITTEE INFORMATION – INSTALLATION OF TRAFFIC SIGNALS – WILLIAM HENRY AND JONES STREETS ULTIMO (2014/309509)

#### RECOMMENDATION

It is recommended that the Committee note and support:

- (A) The introduction of traffic signals at the intersection of William Henry and Jones Streets, Ultimo;
- (B) Signalised pedestrian crossings across all intersection approaches;
- (C) A "No Right Turn" restriction for vehicles turning right from William Henry Street (west) into Jones Street (south); and
- (D) The City to undertake traffic surveys on local roads around the intersection six months after the introduction of the signals to determine if traffic calming is required.

#### DECISION

The Committee carried the recommendation unanimously.

#### BACKGROUND

The City nominated the intersection of William Henry and Jones Streets for the 2014/15 Black Spot Program due to the high number of injury crashes that have occurred at this intersection in the last five years.

#### ITEM 5 ITEM FOR COMMITTEE INFORMATION – KERB EXTENSION – MARLBOROUGH STREET GLEBE (2014/280399)

#### RECOMMENDATION

It is recommended that the Committee note the new kerb extension on the north-eastern corner of the intersection of Glebe Point Road and Marlborough Street, Glebe.

#### DECISION

The Committee carried the recommendation unanimously.

#### BACKGROUND

The new kerb extension would allow a pram ramp to be constructed on the northern kerb of Marlborough Street, Glebe that is compliant with the City's Sydney Streets Technical Specifications. A compliant pram ramp already exists on the southern kerb of Marlborough Street.

#### ITEM 6 ITEM FOR COMMITTEE INFORMATION – SEPARATED BI-DIRECTIONAL CYCLEWAY – GEORGE STREET REDFERN (2012/091176)

#### RECOMMENDATION

It is recommended that the Committee note the attached line marking and signposting as installed with the separated bi-directional cycleway on George Street Redfern.

#### DECISION

The Committee carried the recommendation unanimously and noted the following comments from the RMS:

- Along the eastern kerb of George Street, just south of Cleveland Street, the signage and line-marking plan shows separate "No Stopping" left and "No Stopping" right signs these should be combined into a bi-directional "No Stopping" sign; and
- In Phillip Street, just east of the intersection with George Street, the signage and linemarking shows a "Give Way" sign with a separate "Cyclists" plate underneath orientated towards approaching traffic in Phillip Street – the "Give Way" and separate "Cyclists" signs should be reorientated to face approaching cyclists on the George Street Cycleway.

#### BACKGROUND

The George Street cycleway project connects Bourke Street at Green Square to Cleveland Street at Prince Alfred Park near Central Station (1.7km). The project also includes an east-west connection from Mandible Street to Bourke Street via Botany Road/Allen and Short Streets (0.7km).

George Street is a critical link along the proposed Green Square to City Centre Regional Route. The east-west route is a key link along the University of NSW to University of Sydney Regional Cycleway Route.

### ITEM 7 STREET EVENTS – TEMPORARY ROAD CLOSURES – CHRISTMAS IN PYRMONT (2014/149595)

#### RECOMMENDATION

It is recommended that the Committee endorse the temporary road closure of John Street between Harris and Mount Streets, Pyrmont for the Christmas in Pyrmont Street Event on Sunday 30 November 2014 from 7am to 8pm, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closures conditions as stipulated in Schedule B of this Agenda.
- (B) The Applicant must contact the Sydney City Police to discuss deployment of user pay police for the event.
- (C) The Applicant must contact the City's Venue Management Unit to discuss the event.
- (D) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to commencement of works.
- (E) The Applicant must contact Sydney Buses and arrange and pay for the rerouting of bus services around the closures, the temporary relocation of bus stops and any additional staff required.
- (F) The Applicant must provide a telephone number of the supervisor responsible for the proposed event and include contact details in the notification letters to be distributed to affected stakeholders.

#### DECISION

The Committee carried the recommendation unanimously.

#### BACKGROUND

The Friends of Pyrmont Community Centre has applied for the temporary road closure of John Street between Harris to Mount Streets, Pyrmont for the Christmas in Pyrmont Street Event on Sunday 30 November 2014 from 7am to 8pm.

#### ITEM 8 TEMPORARY ROAD CLOSURES – BEAMS ART FESTIVAL 2014 CHIPPENDALE (2014/292982)

#### RECOMMENDATION

It is recommended that the Committee endorse the temporary road closures for the Beams Arts Festival 2014, Chippendale from midnight on Friday 19 September 2014 to 1.30am on Sunday 21 September 2014, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as stipulated in Schedule B of this Agenda.
- (B) The Applicant must contact Redfern Police to discuss deployment of user pay police for the event.
- (C) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to commencement of works.
- (D) The Applicant must contact the City's Venue Management Unit to discuss the event.
- (E) The Applicant must provide a telephone number of the supervisor responsible for the proposed event and include contact details in the notification letters to be distributed to affected stakeholders.

#### DECISION

The Committee carried the recommendation unanimously and noted that although the City did not receive complaints about traffic and parking related issues associated with the 2013 Beams Art Festival, the City did receive complaints about other event issues such as noise and waste.

The Committee also noted that:

- both City staff and the Applicant have addressed issues raised by residents relating to noise and emergency access for the 2014 Beams Art Festival; and
- Residents who live within the event precinct will have access to exclusive alternate resident parking if required within the Central Park Car Park by pre-registering with the festival organiser prior to the event.

Chippendale Creative Precinct has applied for the temporary road closures of Wellington, O'Connor, Queen, Henrietta, Balfour, Dick and Little Queen Streets and Teggs Lane from midnight on Friday 19 September 2014 to 1.30am on Sunday 21 September 2014.

# DECISION

The Committee carried the recommendation unanimously and noted the concerns raised by the representative from Surry Hills Police. This Item however falls within the jurisdiction of the Redfern Police who has confirmed support for the proposed changes.

# BACKGROUND

Abercrombie Street is the main street of Darlington Village and runs between Cleveland and Golden Grove Streets. The City proposes a more pedestrian friendly street between Redfern Station and Sydney University as it is a major walking route for students and residents.

The Newtown, Darlington, Erskineville and Camperdown Pedestrian Cycling and Traffic Calming (PCTC) Plan adopted by Council in 2010 includes proposals to enhance amenity of the local area, provide safe and convenient walking and cycle access, while maintaining appropriate vehicle access for residents and businesses. The introduction of thresholds along Abercrombie, Shepherd and Lawson Streets, Darlington, would reinforce the commitments in the PCTC and enable the introduction of a 40km/h High Pedestrian Activity Area (HPAA) by the RMS.

# ITEM 46 TRAFFIC TREATMENT – RAISED PEDESTRIAN CROSSING – HARRIS STREET PYRMONT (2014/263909)

# RECOMMENDATION

It is recommended that the Committee endorse;

- (A) The installation of a 75mm high raised pedestrian crossing across Harris Street at John Street, Pyrmont as shown in the attached sketch.
- (B) The reallocation of parking along the western side of Harris Street as follows;
  - Between the points 0.0 metres and 25.0 metres south of John Street as "No Stopping" (5 car parking spaces)
  - Between the points 25.0 metres and 50.3 metres (5 car parking spaces) as "Bus Zone".

# DECISION

# BACKGROUND

At a community meeting in Pyrmont, residents raised concerns about safety for children accessing the bus stop near the intersection of Harris and John Streets.
