ITEM 33. PARKING - PERIOD PARKING - O'DEA AVENUE AMELIA STREET ACCESS ROAD ARCHIBALD AVENUE MYSTIC LANE AND HATBOX PLACE WATERLOO

RECOMMENDATION

It is recommended that the Committee endorse the following:

- (A) Allocation of parking on the northern side of O'Dea Avenue, Waterloo, east of Amelia Street as:
 - "No Stopping" between the points 0 metres and 10 metres (two car spaces);
 - "Bus Zone" between the points 10 metres and 40 metres (five car spaces);
 and
 - "No Stopping" between the points 40 metres and 85 metres (eight car spaces).
- (B) Allocation of parking on the western side of Amelia Street, Waterloo, between O'Dea Avenue and the Access Road as "No Stopping";
- (C) Allocation of parking on the eastern side of Amelia Street, Waterloo, north of O'Dea Avenue as:
 - "No Stopping" between the points 0 metres and 15 metres (three car spaces);
 - "2P 8am-8pm" between the points 15 metres and 51 metres (five car spaces); and
 - "No Stopping" between the points 51 metres and 77 metres (four car spaces).
- (D) Allocation of parking on the western and eastern side of the Access Road, Waterloo, between Amelia Street and Archibald Avenue as "No Stopping";
- (E) Allocation of parking on the northern side of Archibald Avenue, Waterloo, between Amelia Street and Mystic Lane as "No Stopping";
- (F) Allocation of parking on the southern side of Archibald Avenue, Waterloo, east of Amelia Street as:

- "No Stopping" between the points 0 metres and 25.2 metres (four car spaces);
- "No Parking 6am-8am" and "2P 8am-8pm Mon-Fri" between the points 25.2 metres and 37.8 metres (two car spaces); and
- "No Stopping" between the points 37.8 metres and 47.8 metres (two car spaces).
- (G) Allocation of parking on the western side of Mystic Lane, Waterloo, between Archibald Avenue and Hatbox Place as "No Stopping";
- (H) Allocation of parking on the eastern side of Mystic Lane, Waterloo, south of Archibald Avenue as:
 - "No Stopping" between the points 0 metres and 16.8 metres (three car spaces);
 - "2P 8am-8pm" between the points 16.8 metres and 30 metres (two car spaces);
 - "No Stopping" between the points 30 metres and 43.5 metres (two car spaces);
 - "2P 8am-8pm" between the points 43.5 metres and 56.7 metres (two car spaces); and
 - "No Stopping" between the points 56.7 metres and 83.7 metres (five car spaces).
- (I) Allocation of parking on the northern side of Hatbox Place, Waterloo, between Amelia Street and Mystic Lane as "No Stopping"; and
- (J) Allocation of parking on the southern side of Hatbox Place, Waterloo, east of Amelia Street as:
 - "No Stopping" between the points 0 metres and 17.6 metres (three car spaces);
 - "2P 8am-8pm" between the points 17.6 metres and 37.1 metres (three car spaces); and
 - "No Stopping" between the points 37.1 metres and 62.1 metres (four car spaces);

DECISION

BACKGROUND

Consent Condition 139 of Development Application D/2012/2000 requires the Developer of 56-60 O'Dea Avenue, Waterloo, to submit a parking plan for the street frontages of the development.

The parking plan is to be reviewed by the City before referral to the Committee for consideration.

COMMENTS

As part of their Development Consent, the Developer is required to build Amelia Street, the Access Road, Archibald Avenue, Mystic Lane and Hatbox Place which are new streets within the Lachlan Precinct.

The proposed "2P 8am-8pm" restriction is consistent with the City's Neighbourhood Parking Policy for new streets in urban renewal areas.

The "No Parking 6am-8am Mon-Fri" restriction is to facilitate on-street waste collection for only Building 5 as permitted by Condition 33 of D/2012/2000.

CONSULTATION

Consultation is not required as the parking changes are proposed on new streets and are Conditions of Development Consent.

FINANCIAL

All costs associated with the parking changes will be borne by the Developer.
