ITEM 32. PARKING – WOOLLEY STREET GLEBE

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of parking on Woolley Street, Glebe as follows:

- (A). On the northern side of Woolley Street, west of St James Lane:
- Between points 4.2 metres and 16.2 metres as "No Parking 8am-6pm Wedding and Funeral Vehicles Excepted"
- Between points 16.2 metres and 33.5 metres as "P10 Minutes 8am-9am 2.30pm-3.30pm School Days" and "1P 9am-2.30pm 3.30pm-6pm School Days".
- Between points 51.5 metres and 95.4 metres as "P10 Minutes 8am-9am 2.30pm-3.30pm School Days" and "1P 9am-2.30pm 3.30pm-6pm School Days".
- (B). On the southern side of Woolley Street, west of Woolley Lane between points 29 metres and 34 metres as "No Parking Authorised Car Share Vehicles Excepted"

DECISION

BACKGROUND

St James Catholic Primary School on Woolley Street, Glebe has requested changes to parking in the street to improve the drop off and pick up of students attending the school.

The St James Catholic Church has also requested parking for wedding and funeral vehicles in front of the entrance to the church.

COMMENTS

The School has requested consideration of 10 minute parking to replace the current 5 minute parking to improve the Pick Up and Drop Off facility at the school.

The kerb space on the northern side of Woolley Street, Glebe between St James Lane and Hereford Street is currently signposted as "No Parking 8am-9am 2.30pm-3.30pm School Days"; "P5 Minute 8am-9am 2.30pm-3.30pm School Days" and "No Parking Authorised Car Share Vehicles Excepted".

The kerb space on the southern side of Woolley Street between Woolley Lane and Hereford Street is currently signposted as "1P 8am-10pm Permit Holders Excepted Area G".

The City is also proposing to relocate the existing Car Share space on the northern side of the street to the southern side to provide additional kerb space for drop off and pick up parking.

CONSULTATION

The City consulted local residents and businesses in the area. There were 35 letters sent out with no responses supporting the proposal or opposing the proposal.

One resident suggested that the parking for Wedding and Funeral vehicles be modified and the Car Share space located at the western end of Woolley Street near Hereford Street. These comments have been accommodated in this proposal. The resident affected by the change in the location of the Car Share space was consulted and raised no objections to the proposed relocation.

GOGET has been consulted regarding the relocation of the Car Share space and raised no objections to this proposal.

FINANCIAL

Funds are available in the current budget.
