ITEM 12. ROAD WORKS – TEMPORARY ROAD CLOSURES – IVY LANE DARLINGTON

RECOMMENDATION

It is recommended that the Committee endorse the temporary road closure of Ivy Lane, between Lawson Street and Little Eveleigh Street, Darlington, from Thursday 15 January to Saturday 17 January 2015 between 7:30am and 5:30pm each day, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as mentioned in Schedule C of this agenda.
- (B) The Applicant must comply with any other conditions imposed by City's Construction Regulation Unit.
- (C) The applicant has indicated 22 to 24 January 2015 as an additional period for the road works as a contingency for inclement weather.
- (D) The Applicant must contact the Redfern Police to obtain a separate police permit and to discuss deployment of user pay police for the road closure.
- (E) The Applicant must notify the operator of the University of Sydney shuttle bus about the temporary diversion.
- (F) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to commencement of works.
- (G) The Applicant must provide a telephone number of the supervisor responsible for the proposed closure and include contact details in the notification letters to be distributed to affected stakeholders.
- (H) The Applicant must temporarily open the Wilson Street closure between Ivy Lane and Ivy Street to detour westbound traffic for the duration of the closure.

DECISION

BACKGROUND

The City's contractor, Sydney Civil, has applied for the temporary road closure of lvy Lane, between Lawson Street and Little Eveleigh Street, Darlington, from Thursday 15 January to Saturday 17 January 2015 between 7:30am and 5:30pm each day.

COMMENTS

The proposed temporary road closure is required to enable trenching works to be undertaken in Ivy Lane as part of the City's Abercrombie Street Darlington Streetscape Upgrade works. The trenching is part of electrical undergrounding component of the project and will extend along Ivy Lane from Lawson St to the electrical substation at the rear of 181 Lawson Street, Darlington. In order to maintain traffic flow in Little Eveleigh Street and provide egress from Ivy Lane, it is proposed to divert vehicular traffic in westbound direction through Wilson Street closure between Ivy Lane and Ivy Street. This would require the temporary removal of bollards at either end of the Wilson St closure.

A temporary contra flow bicycle lane will be provided in Wilson Street and separated by barricades. Certified traffic control personnel will manage vehicles, cyclists and pedestrians in the closed section of Wilson Street.

The Applicant has provided a site-specific Traffic Control Plan that includes details of barricades, signs, flagmen and other traffic devices to implement the proposed road closure.

There are currently no other approved temporary road closures proposed to take place on the same day.

The temporary road closure will not affect other properties, as local access will be provided at all times and alternative access routes are available nearby.

CONSULTATION

The Applicant will be required to notify affected stakeholders as stipulated in Schedule C.

FINANCIAL

All costs associated with the proposed closure will be borne by the applicant.
