ITEM 2 CONFIRMATION OF MINUTES OF MEETING 2014/10 HELD ON 19 NOVEMBER 2014

DECISION

The Committee endorsed the Minutes.

ITEM 3 ITEM FOR COMMITTEE INFORMATION – TEMPORARY LOADING AND TAXI ZONES – BRIDGE PITT AND BOND STREETS SYDNEY (2014/526865)

RECOMMENDATION

It is recommended that the Committee note the extension of time for the temporary parking arrangements on Bridge Street, Pitt Street and Bond Street until 6 February 2015.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

On 18 June 2014, the Local Pedestrian, Cycling and Traffic Calming Committee endorsed temporary parking changes in Bridge, Bond and Pitt Streets to facilitate the CBD Laneways Upgrade Project for Abercrombie and Bridge Lanes and Tank Stream Way as item 14.

The temporary parking changes were to occur between 7 July 2014 and 28 November 2014 (20 weeks) with the kerb space reverting back to existing restrictions at the conclusion of the works.

The permanent traffic arrangements for Abercrombie, Bridge Lane and Tank Stream Way were endorsed by the Committee on 19 March 2014.

ITEM 4 STREET EVENTS – TEMPORARY ROAD CLOSURES – AUSTRALIA DAY CELEBRATIONS (2014/519447)

RECOMMENDATION

- (C) The Applicant must contact the City's Venue Management Unit to discuss the event.

ITEM 14 WORKS ZONE – BARR STREET CAMPERDOWN (2014/512894)

RECOMMENDATION

It is recommended that the Committee endorse the allocation of the kerb space on the eastern side of Barr Street, Camperdown, between the points 16 metres and 39 metres (four car spaces), 54.5 metres and 82.5 metres (five car spaces) and 128.8 metres and 159.8 metres (five car spaces) south of Pyrmont Bridge Road as "Works Zone 7.30am-5.30pm Mon-Fri, 7.30am-3.30pm Sat" and "2P 3.30pm-6pm Sat, 8am-6pm Sun Permit Holders Excepted Area 30", subject to the following conditions:

- (A) The Applicant must comply with the Works Zone conditions as stipulated in Schedule D of this Agenda.
- (B) The Applicant is not permitted to swing or hoist goods from a Works Zone across or over any part of a public road by means of a lift, hoist or crane unless a separate approval has been obtained from the City's Building Approvals Unit under Section 68 of the Local Government Act 1993.
- (C) The Applicant must notify local residents of the Works Zones at least seven days prior to installation.
- (D) The Applicant must provide a telephone number of the Site Manager.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

Ceerose Pty Ltd has applied for a 23 metre, 28 metre and 31 metre long Works Zones in Barr Street, Camperdown.

The Works Zones are to facilitate construction works at 13-17 Pyrmont Bridge Road and 96 Parramatta Road for a period of approximately 52 weeks.

ITEM 15 WORKS ZONE – BURTON AND LANGLEY STREETS DARLINGHURST (2014/508965)

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of the kerb space as follows:

- On northern side of Burton Street, Darlinghurst, between points 7.1 metres and 22.1 metres (two car spaces) west of Palmer Street as "Works Zone 7.30am-5.30pm Mon-Fri, 7.30am-3.30pm Sat" and "2P Ticket 5.30pm-10pm Mon-Fri, 3.30pm-10pm Sat, 8am-10pm Sun and Public Holidays Permit Holders Excepted Area 21".
- On eastern side of Langley Street, Darlinghurst, between points 17.5 metres and 29.5 metres (two car spaces) south of Kings Lane as "Works Zone 7.30am-5.30pm Mon-Fri, 7.30am-3.30pm Sat" and "1P 5.30pm-10pm Mon-Fri, 3.30pm-10pm Sat Permit Holders Excepted Area 21".

Subject to the following conditions:

- (A) The Applicant must comply with the Works Zone conditions as stipulated in Schedule D of this Agenda.
- (B) The Applicant is not permitted to swing or hoist goods from a Works Zone across or over any part of a public road by means of a lift, hoist or crane unless a separate approval has been obtained from the City's Building Approvals Unit under Section 68 of the Local Government Act 1993.
- (C) The Langley Street Works Zone shall only be used by vehicles up to an Australian Standard Small Rigid Vehicle (SRV). The Applicant must implement appropriate traffic control measures and provide accredited traffic controllers to manage local access in Langley Street when the Works Zone is used by construction vehicles.
- (D) The Applicant must maintain local access in Langley Street at all times. If a construction vehicle using the Works Zone restricts another vehicle from passing in the street, then the traffic controllers must organise the construction vehicle in the Works Zone to move so that the other vehicle can pass safely.
- (E) The Applicant must notify local residents of Works Zones at least seven days prior to installation.
- (F) The Applicant must provide a telephone number of the Site Manager.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

Gledhill Construction Pty Ltd has applied for two Works Zones along two frontages of their site. They are 15 metre long Works Zone in Burton Street and a 12 metre long Works Zone in Langley Street, Darlinghurst.

The Works Zones are to facilitate refurbishment works for the City's Heffron Hall at 225-245 Palmer Street for a period of approximately 40 weeks. The Works Zones will also facilitate upgrade works at the nearby Albert Sloss Reserve.

ITEM 16 ITEM 14. WORKS ZONE – CARLTON STREET CHIPPENDALE (2014/491828)

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of the kerb space on the eastern side of Carlton Street, Chippendale, between the points 20 metres and 45 metres (four car spaces) south of Broadway as "Works Zone 7am-7pm Mon-Fri, 7am-5pm Sat" and "No Stopping Other Times" and the associated temporary closure of the southbound traffic during the hours of Works Zone, subject to the following conditions:

DECISION

The Committee carried the recommendation unanimously and noted that:

 A stop/slow contraflow will be put in place in Carlton Street during work hours with all south bound traffic being given preference to ensure that there is no impact on Broadway (as per the attached TCP).

This will mean that no diversion of traffic will be necessary and the temporary road closure in Carlton Street will only be implemented if problems occur.

If a construction vehicle using the Works Zone restricts another vehicle from passing in the street, then the traffic controllers must organise the construction vehicle in the Works Zone to move so that the other vehicle can pass safely.
- (G) The Applicant must notify adjacent properties of the Works Zone at least seven days prior to installation.
- (H) The Applicant must provide a telephone number of the Site Manager.

DECISION

Residents of Norfolk Street have requested consideration of permit parking in Norfolk Street which has a high demand for parking in the street.

ITEM 28 PARKING - TICKET - WENTWORTH AVENUE SURRY HILLS (2014/476908)

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of Ticket parking on the eastern side of Wentworth Avenue, Surry Hills between the points 52.0 metres and 61.0 metres (3 car spaces) north of Campbell Street as "1P Ticket 8am-6pm Mon-Fri" and "4P Ticket 6pm-10pm Mon-Fri 8am-10pm Sat-Sun & Public Holidays".

DECISION

The Committee carried the recommendation unanimously.

The City conducted surveys which found a high level of occupancy and non-compliance with existing restrictions which reduced available space for visitors to the area.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

The City is committed to providing dedicated parking for car sharing across the Local Government Area as part of a Council approved Car Share Policy. A submission has been received from GoGet for a car share space in Maddison Street, west of South Dowling Street.

ITEM 32 CAR SHARE - POTTINGER STREET DAWES POINT (2014/493474)

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of parking on Pottinger Street, Dawes Point as follows:

- (A) On the southern side of Pottinger Street , west of Hickson Road:
 - (1) between the points 106 metres and 111 metres (1 car space) as "No Parking Car Share Vehicles Excepted";
 - (2) between the points 98 metres and 106 metres (2 car spaces) as "4P Ticket 8am 10pm";
- (B) The City will only install signage for the car share space when GoGet has a car to occupy the space.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

ITEM 33 PARKING – TICKET – COWPER WHARF ROADWAY WOOLLOOMOOLOO (2014/305095)

RECOMMENDATION

It is recommended that the Committee endorse the allocation of Ticket Parking "2P Ticket 8am-6pm Mon-Fri, 4P Ticket 6pm-10pm Mon-Fri, 4P Ticket 8am-10pm Sat-Sun and Public Holidays" on the southern side of Cowper Wharf Roadway, Woolloomooloo in the following locations;

- (A) Between the points 10 metres and 22 metres (2 car spaces) east of Dowling Street and,
- (B) Between the points 10 metres and 25 metres (2 car spaces) east of McElhone Street.

DECISION

The Committee carried the recommendation, but noted the objection by the Kings Cross Police and Roads and Maritime Services (RMS).

BACKGROUND

The City East Pedestrian Cycling Traffic Calming Study adopted by Council, identified the potential for additional parking on Cowper Wharf Roadway which can narrow the road and calm traffic.

On 17 September 2014, the proposed ticket parking was deferred by the Local Pedestrian, Cycling and Traffic Calming Committee to provide an opportunity for the Department of Defence to comment on the proposal.

ITEM 34 TRAFFIC TREATMENT – TRAFFIC CONTROL – EVE AND COULSON STREETS ERSKINEVILLE (2014/541016)

RECOMMENDATION

It is recommended that the Committee endorse the installation of Give Way control and centre lines at the intersection of Eve and Coulson Streets, Erskineville.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

The intersection of Coulson and Eve Streets consists of three legs with Coulson Street as the major approach in Erskineville.

The City has received safety concerns at the intersection about vehicles crossing over onto the wrong side of the road when turning right into Eve Street from Coulson Street.

ITEM 35 TRAFFIC TREATMENT – FOOTWAY WIDENINGS – STIRLING AND ELGER STREETS GLEBE (2014/544893)

RECOMMENDATION

It is recommended that the Committee endorse footway widenings at the following locations:

- (A) On the eastern side of Stirling Street at Wentworth Street, between the points 24 metres and 32 metres south of Wentworth Street and at the intersection of Elger Street;

DECISION

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of the kerb space on the western side of Sussex Street, Sydney, between the points 114 metres and 146.3 metres (five car spaces) south of King Street as "Works Zone 7am-7pm Mon-Fri, 7am-5pm Sat; and "No Parking Other Times", subject to the following conditions:

- (A) The Applicant must comply with the Works Zone conditions as stipulated in Schedule D of this Agenda.
- (B) The Applicant is not permitted to swing or hoist goods from a Works Zone across or over any part of a public road by means of a lift, hoist or crane unless a separate approval has been obtained from the City's Building Approvals Unit under Section 68 of the Local Government Act 1993.
- (C) Works for major transport projects, such as the Sydney Light Rail Project and the Sydney City Centre Access Strategy, are currently being undertaken in the City's Local Government Area and have priority access and use rights over City owned or controlled land including roads and footpaths. The City may at any time, and with at least 1 business days' notice to the applicant, revoke, suspend or restrict the Works Zone:
 - if the Works Zone is required for a major transport project; or
 - is impracticable due to changes arising from a major transport project, such as traffic diversions; or
 - is otherwise unsuitable due to a major transport project.

The applicant must make its own enquiries, on a regular basis, about the potential impact of major transport projects on the Works Zone and the construction program for its development site.

- (D) The Applicant must notify adjacent properties of the Works Zone at least seven days prior to installation.
- (E) The Applicant must provide a telephone number of the Site Manager.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

Brookfield Multiplex has applied for a 32.3 metre long Works Zone in Sussex Street, Sydney.

The Works Zone is to facilitate refurbishment works at 161 Sussex Street for a period of approximately 55 weeks.

COMMENTS

The kerb space on the western side of Sussex Street, Sydney between King and Market Streets where the Works Zone is proposed, is currently signposted as "No Parking" across their driveways and "2P 8am-10pm Motor Bikes Only".

The Applicant currently has a Works Zone in Sussex Street on the northern end of their development site where they are presently undertaking refurbishment works. The new Works Zone is on the southern end of their site and it will allow them to undertake refurbishment works on the southern part of their site.

The Works Zone is intended to operate from 7am to 7pm, Monday to Friday and from 7am to 5pm on Saturday in accordance with the Development Consent conditions.

The development site has no provision for off-street parking for large trucks and as the approved development takes up the entire site, the developer is unable to carry out construction works unless a Works Zone is provided directly in the front of the site. The street is wide enough to allow the Works Zone to be installed without affecting traffic flow or property access.

CONSULTATION

The Applicant must notify adjacent properties at least seven days prior to the implementation of the Works Zone.

FINANCIAL

All costs associated with the Works Zone will be borne by the Applicant.

BACKGROUND

Brookfield Multiplex has requested the temporary reallocation of parking on Sussex Street outside the Sheraton Four Points Hotel at 161 Sussex Street, Sydney to assist with hotel operations while construction works are occurring at this property.

COMMENTS

The kerb space on the western side of Sussex Street at this location is currently signposted as 'Taxi Zone'.

Brookfield Multiplex has requested the City consider reallocating a section of the 'Taxi Zone' kerbspace as 'No Parking' outside the property for the Hotel's valet service while construction is occurring to the porte-cochere. It is anticipated that the temporary onstreet parking arrangements will be required for eight months.

The proposed 'No Parking' restriction would limit motorists to a maximum of 2 minutes of parking providing the drivers is no further than 3 metres away from the vehicle. This is consistent with other hotels in central Sydney that operate on-street valet services.

Once construction at the property is complete, the kerbspace will revert back to 'Taxi Zone'.

The applicant has contacted the NSW Taxi Council and has received their consent for the proposed reduction of the 'Taxi Zone' on Sussex Street.

CONSULTATION

As the proposal affects the frontage of one property being the applicant's, the City has notified surrounding buildings of the proposed temporary parking arrangements by letterbox drop.

FINANCIAL

Funds are available in the current budget.

DECISION

BACKGROUND

Sydney Private Hospital has requested consideration of Loading Zone in Kennedy Street as some delivery vehicles servicing this site are unable to make deliveries off street as the vehicles are taller than the building's delivery dock.

COMMENTS

The kerb space on the southern side of Kennedy Street Woolloomooloo between Crown Street and Riley Street is currently signposted as "No Parking 8.30am-6pm Mon-Fri.

An inspection of the site has shown that the height clearance of the off street parking at this property is 2.2 metres. Some delivery vehicles can be up to 3.5 metres making them unable to access the off street loading dock. It is envisaged that an on-street Loading Zone would allow deliveries to be made to the hospital and surrounding properties without the need for drivers to park illegally.

CONSULTATION

The City consulted local residents and businesses in the area. There were 155 letters sent out with no responses supporting or opposing the proposal.

FINANCIAL

Funds are available in the current budget.

- (D) The Applicant must comply with any other conditions imposed by City's Construction Regulation Unit.
- (E) The Applicant must contact the Sydney City Police to discuss deployment of user pay police for the road closures.
- (F) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to commencement of works.
- (G) The Applicant must contact Sydney Buses and arrange and pay for the rerouting of bus services around the closures, the temporary relocation of bus stops and any additional staff required.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

Transport for NSW's CBD and South East Light Rail has applied for the temporary road closures of

 Eddy Avenue, westbound between Elizabeth Street and Pitt Street, Haymarket, at various periods from 1am Sunday 28 December 2014 to 5am Tuesday 30 December 2014;

17 DECEMBER 2014

- Pitt Street, south of Eddy Avenue and Rawson Place, Haymarket, at various periods from 1am Sunday 28 December 2014 to 5am Tuesday 30 December 2014; and
- Rawson Place, between George Street and Pitt Street, Haymarket, at various periods from
 - 1am Sunday 28 December 2014 to 5am Tuesday 30 December 2014,
 - 1am Friday 2 January 2015 to 5am Saturday 3 January 2015 and
 - 1am Friday 9 January 2015 to 5am Saturday 10 January 2015.

COMMENTS

The proposed temporary road closures are required to enable works at the Pitt Street, Eddy Avenue and Rawson Place, Haymarket intersection.

The work is primarily to locate and identify services to assist with the delivery of the Light Rail project. Traffic management plans have been developed specifically for works being undertaken at the intersection.

There are a number of traffic management and access constraints identified, so works are programed to ensure traffic delays remain at an acceptable and manageable level.

Constraints are as follows:

- Works period will be from 28 to 30 December 2014;
- One-way westbound traffic will be available at all times from Eddy Avenue to Rawson Place:
- There will be no access to Pitt Street northbound from either George Street or Lee Street, local traffic and coaches excepted; and
- Southbound traffic on Pitt Street will be diverted at Campbell Street.

Works will be undertaken from 1am on Sunday 28 December to 5am on Tuesday 30 December 2014.

Intersection arrangements are as follows:

Eddy Avenue, Pitt Street and Rawson Place

- Maintain 1 lane westbound from Eddy Avenue to Rawson Place;
- Maintain the left turn from Pitt Street to Eddy Avenue (south to east);
- No eastbound traffic from Rawson Place to Eddy Avenue; and
- The Eddy Avenue, Pitt Street and Rawson Place intersection will operate under traffic controllers.

Pitt and Hay Streets

- Hay Street traffic diverted to Pitt Street northbound and Campbell Street to George Street;
- Local traffic only south of Hay Street and left to Eddy Avenue (Eastbound);
- Buses and coaches permitted to turn left into Pitt Street southbound;
- Central Station concourse ramp unaffected; and
- No left turn from Hay Street to Pitt Street and detour via Campbell Street.

Pitt and Campbell Streets

- Half road closure of Pitt Street (eastern side), south of Campbell Street;
- Southbound traffic on Pitt Street detour via Campbell Street to George Street and then to Broadway or to Campbell Street east to access Elizabeth Street.

George Street and Rawson Place

- Half road closure of Rawson Place (northern side) east of George Street;
- Westbound traffic only on Rawson Place between Pitt and George Streets;
- Closure of southern pedestrian crossing to facilitate heavy westbound left turn; and
- Pedestrians redirected to mid-block crossing of George Street approximately 50m south of Rawson Place, or to cross at the Ultimo Road intersection.

George, Pitt and Lee Streets (Railway Square)

- Full road closure of Pitt Street (except for local and emergency access, and for country and interstate coaches);
- All Lee Street traffic diverted to George Street; and
- All citybound traffic on Broadway traffic must turn left into George Street.

The Applicant has provided site-specific Traffic Control Plans that includes details of barricades, signs, flagmen and other traffic devices to implement the proposed road closures.

There are currently no other approved temporary road closures proposed to take place on the same day.

The temporary road closures will affect traffic access in the area and works will be advertised to advise people of the traffic arrangements.

CONSULTATION

The Applicant will be required to notify affected stakeholders as stipulated in Schedule C.

The Transport Management Centre has been consulted and accepts the work arrangements.

The State Transit Authority has been consulted and organised bus diversions for the duration of the closures.

FINANCIAL

All costs associated with the proposed closures will be borne by the applicant.

TEMPORARY ROAD CLOSURES - GEORGE STREET SYDNEY

Transport for NSW's CBD and South East Light Rail Project have advised the City that they will have temporary road closures of George Street 24 hours, every day from Friday 2 January 2015 to Sunday 11 January 2015.

George Street will be closed between King Street and Essex Street with a single westbound lane from Bridge Street to Grosvenor Street.

There will also be two other intersection closures during this period at George Street/Liverpool Street and George Street/Goulburn Street. Note the intersection will not be closed at the same time.

The temporary road closures are required primarily to locate and identify underground services to assist with the delivery of the Light Rail project. Traffic management plans have been developed in consultation with RMS, Transport for NSW, Transport Management Centre, State Transit Authority, City and contractor.
