RECOMMENDATION

It is recommended that the Committee note the temporary road closures associated with the St Patrick's Day Parade on Sunday 15 March 2015 between 7am and 2pm subject to the following conditions:

- (A) The Applicant must comply with the temporary road closures conditions as stipulated in Schedule B of this Agenda.
- (B) The Applicant must contact the Sydney City Police to discuss deployment of user pay police for the event.
- (C) The Applicant must contact the City's Venue Management Unit to discuss the event.
- (D) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to the event.
- (E) The Applicant must submit a Traffic Control Plan for approval prior to the road closure.
- (F) The Applicant must provide a telephone number of the supervisor responsible for the proposed event and include contact details in the notification letters to affected stakeholders.

DECISION

BACKGROUND

The Sydney St Patrick's Day Parade Committee has applied for the temporary road closures associated with the 2015 St Patrick's Day Parade on Sunday 15 March 2015 between 7am and 2pm.

COMMENTS

A Working Group consisting of representatives from the NSW Police, Roads and Maritime Services, Transport Management Centre, State Traffic Authority, the City and the event organisers met on 2 February to discuss the temporary road closures associated with the event.

The City advised that the St Patrick's Day Parade route has been changed a number of times to reduce traffic impacts and minimise the time roads are closed.

Route and Time of Event

The Parade floats will form up in George Street between Bathurst and Liverpool Streets with one traffic lane kept clear for emergency access.

Local access will be provided on Castlereagh Street south of Market Street by a temporary two-way traffic flow managed under traffic control.

Guest and taxi access to the Hilton Hotel will be maintained via George Street southbound into the hotel and out onto Pitt Street.

The Parade will start in George Street at 12 noon and go past Town Hall for viewing by the Lord Mayor and VIP's, turn right into Park Street, left into Elizabeth Street around into St James Road and finish in at Hyde Park North at approximately 1pm.

All floats, expect for two semi-trailers, will be dismantled and dispersed in Phillip Street between King and Hunter Streets. The two semi-trailers will be dismantled in Elizabeth Street between King and Hunter Streets.

The Applicant will need to seek separate approval from the City's Greening and Leisure Unit for the use of Hyde Park.

There are currently no other approved temporary road closures proposed to take place on the same day.

CONSULTATION

The Applicant will be required to notify affected stakeholders as stipulated in Schedule B.

FINANCIAL

All costs associated with the proposed closures will be borne by the Applicant.
