ITEM 3 ITEM FOR COMMITTEE INFORMATION – NO PARKING – WILSON STREET DARLINGTON (2015/125612)

RECOMMENDATION

It is recommended that the Committee note the temporary reallocation of parking on the southern side of Wilson Street, Darlington between the points 12 metres and 84 metres (twelve car spaces) east of Codrington Street as "No Parking 8:30am-8.30pm" between Sunday 12 April to Thursday 16 April 2015.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

IMG Fashion Events & Properties in conjunction with Carriageworks was seeking approval to temporarily install a "No Parking" restriction on Wilson Street, Darlington to provide for set-down and pick-up of taxis and hire cars during the 2015 Mercedes-Benz Fashion Week Australia.

ITEM 4 ITEM FOR COMMITTEE INFORMATION – TEMPORARY ROAD CLOSURES – ROADWORKS – GEORGE STREET FROM KING TO ESSEX STREETS SYDNEY (2015/187363)

RECOMMENDATION

It is recommended that the Committee note the following temporary road closures of George Street from King Street to Essex Street, Sydney;

- 5am Sunday 3 May 2015 to 5am Monday 4 May 2015;
- 10am Sunday 10 May 2015 to 5am Monday 11 May 2015; and

- (C) The Applicant must contact the Sydney City Local Area Command to discuss deployment of user pay police for the road closure.
- (D) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to commencement of works.
- (E) The Applicant must provide a telephone number of the supervisor responsible for the proposed George Street closures and include contact details in the notification letters to be distributed to affected stakeholders.
- (F) The Applicant must contact Sydney Buses and arrange and pay for the rerouting of bus services around the George Street closures, the temporary relocation of bus stops and any additional staff required.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

Transport for NSW's (TfNSW) 'CBD and South East Light Rail' (CSELR) project requires a check of underground services along the rail corridor especially through the CBD as part of the light rail works.

ALTRAC Light Rail partners have been appointed by Transport for NSW to deliver and operate Sydney's new CBD and South East Light Rail.

ALTRAC Light Rail is a group comprising of Transdev Sydney, Alstom Transport Australia, Acciona Infrastructure Australia and Capella Capital and will work closely with the NSW Government to construct the CSELR.

RECOMMENDATION

ITEM 6 ITEM FOR COMMITTEE INFORMATION – UPDATED SIGNPOSTING AND LINE MARKING – CROWN STREET SURRY HILLS BETWEEN CLEVELAND AND DEVONSHIRE STREETS (2015/187755)

RECOMMENDATION

It is recommended that the Committee note the attached line marking and sign posting as installed on Crown Street as part of the upgrade between Cleveland and Devonshire Streets.

DECISION

The Committee carried the recommendation unanimously and noted the request from RMS for the southbound in-lane bus stop to be monitored by the City for the first six months after commencement.

BACKGROUND

A comprehensive streetscape upgrade was endorsed by Council on 26th August 2013 for Crown Street, Surry Hills between Cleveland and Devonshire Streets. This upgrade aimed to improve pedestrian amenity and to activate the street with more opportunities for street dining and improve street planting.

ITEM 7 STREET EVENTS – TEMPORARY ROAD CLOSURES – 2015 AROMA COFFEE FESTIVAL (2015/184651)

RECOMMENDATION

It is recommended that the Committee endorse the temporary road closures associated with the 2015 Aroma Coffee Festival from 5pm on Saturday 25 July to 11pm Sunday 26 July 2015 subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as stipulated in Schedule B of this Agenda.
- (B) The Applicant must contact the Sydney City Police to discuss deployment of user pay police for the event.
- (C) The Applicant must contact the City's Venue Management Unit to discuss the event.
- (D) The Applicant must obtain a Road Occupancy Licence (ROL) from the Transport Management Centre prior to commencement of works.
- (E) The Applicant must contact Sydney Buses and arrange and pay for the rerouting of bus services around the closures, the temporary relocation of bus stops and any additional staff required.
- (F) The Applicant must submit a Traffic Control Plan for approval prior to the temporary road closures.
- (G) The Applicant must provide a telephone number of the supervisor responsible for the proposed event and include contact details in the notification letters to be distributed to affected stakeholders.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

Sydney Harbour Foreshore Authority (SHFA) has applied for the temporary road closures of George Street and Hickson Road for the 2015 Aroma Coffee Festival.

The event will be held on Sunday 26 July from 10am to 5pm however the temporary road closures are required from 5pm on Saturday 25 July to 11pm Sunday 26 July 2015.

ITEM 8 STREET EVENTS – TEMPORARY ROAD CLOSURES – PROCESSION OF THE BLESSED SACRAMENT 2015 (2014/128740)

RECOMMENDATION

It is recommended that the Committee endorse the temporary road closures associated with the Procession of the Blessed Sacrament on Sunday 7 June 2015 from 12pm to 4.30pm subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as stipulated in Schedule B of this Agenda.
- (B) The Applicant must contact the Sydney City Police to discuss deployment of user pay police for the event.
- (C) The Applicant must contact the City's Venue Management Unit to discuss the event.
- (D) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to commencement of works.
- (E) The Applicant must provide a telephone number of the supervisor responsible for the proposed event and include contact details in the notification letters to be distributed to affected stakeholders.
- (F) The Applicant must contact Sydney Buses and arrange and pay for the rerouting of bus services around the road closures, the temporary relocation of bus stops and any additional staff required.
- (G) The Applicant must submit a Traffic Control Plan for approval prior to the temporary road closures.

DECISION

The Committee carried the recommendation unanimously.

Epic Event Pty Limited, on behalf of the Catholic Archdiocese of Sydney, has applied for a number of temporary road closures within the Sydney CBD on Sunday 7 June 2015 from 12pm to 4.30pm for the 'Procession of the Blessed Sacrament'.

ITEM 9 MOBILE CRANES – TEMPORARY ROAD CLOSURES – CODRINGTON STREET DARLINGTON (2015/147399)

RECOMMENDATION

It is recommended that the Committee endorse the temporary road closure of Codrington Street, between Darlington Road and Abercrombie Street, Darlington, from 7am on Saturday 20 June to 6pm on Sunday 21 June 2015, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as mentioned in Schedule C of this Agenda.
- (B) The Applicant must comply with any other conditions imposed by City's Construction Regulation Unit.
- (C) The Applicant has indicated 27 June and 28 June 2015 as an alternative dates for the above work as a contingency for inclement weather.
- (D) The Applicant must contact the Newtown Police to obtain a separate police permit and to discuss deployment of user pay police for the road closure.
- (E) The Applicant must provide a telephone number of the supervisor responsible for the proposed closure and include contact details in the notification letters to be distributed to affected stakeholders.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

John Holland Pty Ltd has applied for the temporary road closure of Codrington Street, between Darlington Road and Abercrombie Street, Darlington, from 7am on Saturday 20 June to 6pm on Sunday 21 June 2015.

The Committee meeting on 18 March 2015 endorsed the closure of Codrington Street, for 11 and 12 April 2015, but due to unforeseeable delays the Applicant could not proceed with the closure. The Applicant has now requested for new closure dates.

ITEM 10 MOBILE CRANES – TEMPORARY ROAD CLOSURES – GEORGE STREET SYDNEY (2015/148008)

RECOMMENDATION

It is recommended that the Committee endorse the temporary road closure of George Street, between Park and Market Streets, Sydney, from 3am on Sunday 14 June to 4am on Monday 15 June 2015; and from 3am on Sunday 28 June to 4am on Monday 29 June 2015, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as mentioned in Schedule C of this Agenda.
- (B) The Applicant must comply with any other conditions imposed by City's Construction Regulation Unit.
- (C) The Applicant has indicated the 12 and 19 July 2015 as an alternative date for the above work as a contingency for inclement weather.
- (D) The Applicant must contact the Sydney City Police to obtain a separate police permit and to discuss deployment of user pay police for the road closure.
- (E) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to commencement of works.
- (F) The Applicant must consult the Hilton Hotel and resolve any reasonable concerns about the proposed closure to the satisfaction of the City.
- (G) If the above closure dates conflict with any Light Rail works, other major works or special events, they may be changed to new dates in consultation with the Transport Management Centre and the Sydney City Police.
- (H) The Applicant must provide a telephone number of the supervisor responsible for the proposed closure and include contact details in the notification letters to be distributed to affected stakeholders.
- (I) The Applicant must contact Sydney Buses and arrange and pay for the rerouting of bus services around the closures, the temporary relocation of bus stops and any additional staff required.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

Built Pty Ltd has applied for the temporary road closure of George Street, between Park and Market Streets, Sydney, from 3am Sunday 14 June to 4am Monday 15 June 2015; and from 3am Sunday 28 June to 4am Monday 29 June 2015.

ITEM 11 MOBILE CRANES – TEMPORARY ROAD CLOSURES – GEORGE STREET WATERLOO (2015/166768)

RECOMMENDATION

It is recommended that the Committee endorse the temporary road closure of George Street, between McEvoy and Allen Streets, Waterloo, on Saturday 30 May and Sunday 31 May 2015 from 7am to 10pm, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as mentioned in Schedule C of this Agenda.
- (B) The Applicant must comply with any other conditions imposed by City's Construction Regulation Unit.
- (C) The Applicant has indicated the 6 and 7 June 2015 as alternative dates for the above work as a contingency for inclement weather.
- (D) The Applicant must contact the Redfern Police to obtain a separate police permit and to discuss deployment of user pay police for the road closure.
- (E) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to commencement of works.

It is recommended that the Committee endorse the temporary road closure of Surrey Street, between Surrey Lane and Craigend Street, Darlinghurst, on Saturday 23 May 2015 from 8am to 5pm, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as mentioned in Schedule C of this Agenda.
- (B) The Applicant must comply with any other conditions imposed by City's Construction Regulation Unit.
- (C) The Applicant has indicated the Saturday 30 May 2015 as an alternative date for the above work as a contingency for inclement weather.
- (D) The Applicant must contact the Kings Cross Police to obtain a separate police permit and to discuss deployment of user pay police for the road closure.
- (E) The Applicant must provide a telephone number of the supervisor responsible for the proposed closure and include contact details in the notification letters to be distributed to affected stakeholders.

DECISION

The Committee carried the recommendation unanimously.

Lifts for Life Pty Ltd has applied for the temporary road closure of Surrey Street, between Surrey Lane and Craigend Street, Darlinghurst, on Saturday 23 May 2015 from 8am to 5pm.

ITEM 13 ROAD WORKS – TEMPORARY ROAD CLOSURES – THOMAS STREET ULTIMO (2015/182762)

RECOMMENDATION

It is recommended that the Committee endorse the temporary road closure of Thomas Street, between Ultimo Road and Thomas Lane, Ultimo from 27 May 2015 until 19 July 2015, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as mentioned in Schedule C of this Agenda.
- (B) The Applicant must comply with any other conditions imposed by City's Construction Regulation Unit.
- (C) The Applicant must provide a telephone number of the supervisor responsible for the proposed closure and include contact details in the notification letters to be distributed to affected stakeholders.

DECISION

The Committee carried the recommendation unanimously and noted the request from RMS for congestion to be monitored at the intersection of Hay, Sussex and Thomas Streets during construction.

BACKGROUND

City Projects has applied for the temporary road closure of Thomas Street, Ultimo, between Ultimo Road and Thomas Lane, from 27 May 2015 until 19 July 2015.

On 17 September 2014, the Local Pedestrian, Cycling and Traffic Calming Committee endorsed the construction of a Shared Zone in Thomas Street between Ultimo Road and Thomas Lane as part of the Chinatown Upgrade works.

ITEM 14 WORKS ZONE – BOURKE STREET SURRY HILLS (2015/110183)

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of the kerb space on the eastern side of Bourke Street, Surry Hills, between the points 7.5 metres and 23.0 metres (three car spaces) north of Hill Street as "Works Zone 7.30am-5.30pm Mon-Fri, 7.30am-3.30pm Sat" subject to the following conditions:

- (A) The Applicant must comply with the Works Zone conditions as stipulated in Schedule D of this Agenda.
- (B) The Applicant is not permitted to swing or hoist goods from a Works Zone across or over any part of a public road by means of a lift, hoist or crane unless a separate approval has been obtained from the City's Building Approvals Unit under Section 68 of the Local Government Act 1993.
- (C) The Applicant must notify local residents of the Works Zone at least seven days prior to installation.
- (D) The Applicant must provide a telephone number of the Site Manager.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

Komplete Construction Pty Ltd has applied for a 15.5 metre long Works Zone in Bourke Street, Surry Hills.

The Works Zone is to facilitate construction works at 350 Bourke Street for a period of approximately 52 weeks.

ITEM 15 WORKS ZONE – COMMONWEALTH STREET SURRY HILLS (2015/129866)

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of the kerb space on the eastern side of Commonwealth Street, Surry Hills, between the points 27 metres and 46 metres (three car spaces) south of Reservoir Street as "Works Zone 7.30am-5.30pm Mon-Fri, 7.30am-3.30pm Sat" subject to the following conditions:

- (A) The Applicant must comply with the Works Zone conditions as stipulated in Schedule D of this Agenda.
- (B) The Applicant is not permitted to swing or hoist goods from a Works Zone across or over any part of a public road by means of a lift, hoist or crane unless a separate approval has been obtained from the City's Building Approvals Unit under Section 68 of the Local Government Act 1993.
- (C) The Applicant must notify local residents of the Works Zone at least seven days prior to installation.
- (D) The Applicant must provide a telephone number of the Site Manager.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

Growth Built Pty Ltd has applied for a 19 metre long Works Zone in Commonwealth Street, Surry Hills.

The Works Zone is to facilitate construction works at 144-154 Commonwealth Street for a period of approximately 35 weeks.

ITEM 16 WORKS ZONE – ELIZABETH STREET SYDNEY (2015/204548)

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of the kerb space on the eastern side of Elizabeth Street, Sydney, between the points 40 metres and 71.5 metres (five car spaces) north of Liverpool Street as "Bus Lane 6am-10am, 3pm-8pm Mon-Fri", "Works Zone 10am-3pm Mon-Fri, 8am-1pm Sat, 4P Ticket 1pm-8pm Sat, 8am-8pm Sun and Public Holidays" and "Taxi Zone 8pm-6am", subject to the following conditions:

- (A) The Applicant must comply with the Works Zone conditions as stipulated in Schedule D of this Agenda.
- (B) The Applicant is not permitted to swing or hoist goods from a Works Zone across or over any part of a public road by means of a lift, hoist or crane unless a separate approval has been obtained from the City's Building Approvals Unit under Section 68 of the Local Government Act 1993.
- (C) Works for major transport projects, such as the Sydney Light Rail Project and the Sydney City Centre Access Strategy, are currently being undertaken in the City's Local Government Area and have priority access and use rights over City owned or controlled land including roads and footpaths. The City may at any time, and with at least 1 business days' notice to the Applicant, revoke, suspend or restrict the Works Zone:
 - if the Works Zone is required for a major transport project; or
 - is impracticable due to changes arising from a major transport project, such as traffic diversions; or
 - is otherwise unsuitable due to a major transport project.

The Applicant must make its own enquiries, on a regular basis, about the potential impact of major transport projects on the Works Zone and the construction program for its development site.

- (D) The Applicant must notify adjacent properties of the Works Zone at least seven days prior to installation.
- (E) The Applicant must provide a telephone number of the Site Manager.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

Arenco (NSW) Pty Ltd has applied for a 31.5 metre long Works Zone in Elizabeth Street, Sydney. They are the contractor engaged by Transport for NSW for the upgrade of Museum Station and the surrounding area.

The Works Zone is to facilitate construction works for the upgrade of Museum Station for a period of approximately 17 weeks.

ITEM 17 WORKS ZONE - HAYES ROAD ROSEBERY (2015/145773)

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of the kerb space on the northern side of Hayes Road, Rosebery, between the points 9.2 metres and 39.2 metres (five car spaces) east of Botany Road as "Works Zone 7.30am-5.30pm Mon-Fri, 7.30am-3.30pm Sat" subject to the following conditions:

- (A) The Applicant must comply with the Works Zone conditions as stipulated in Schedule D of this Agenda.
- (B) The Applicant is not permitted to swing or hoist goods from a Works Zone across or over any part of a public road by means of a lift, hoist or crane unless a separate approval has been obtained from the City's Building Approvals Unit under Section 68 of the Local Government Act 1993.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

The Works Zone is to facilitate construction works at 767-779 Botany Road for a period of approximately 26 weeks.

ITEM 18 WORKS ZONE - KETTLE LANE ULTIMO (2015/138892)

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of the kerb space on the western side of Kettle Lane, Ultimo, between the points 16.5 metres and 31.5 metres (three car spaces) south of Smail Street as "Works Zone 7.30am - 5.30pm Mon-Fri, 7.30am - 3.30pm Sat" and "No Stopping Other Times", subject to the following conditions:

- (A) The Applicant must comply with the Works Zone conditions as stipulated in Schedule D of this Agenda.

- (E) The Applicant must replace the existing barrier kerb with a temporary rollover kerb so that vehicles using the Works Zone can park up to the property line of the site. At the completion of the project the Applicant must reinstate the original barrier kerb to the satisfaction of the City.
- (F) The Applicant must notify adjacent properties of the Works Zone at least seven days prior to installation.
- (G) The Applicant must provide a telephone number of the Site Manager.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

Tricon Builder's Group has applied for a 15 metre long Works Zone in Kettle Lane, Ultimo.

The Works Zone is to facilitate construction works at 68-74 Bay Street for a period of approximately 20 weeks.

ITEM 19 WORKS ZONE - PELICAN STREET SURRY HILLS (2015/134735)

RECOMMENDATION

A resident of Brocks Lane has requested consideration of "No Parking" to ensure unobstructed access to their rear off-street parking.

A resident of William Lane has requested consideration of "No Stopping" to ensure unobstructed access to their rear off-street parking.

ITEM 23 PARKING – PERMIT PARKING – FLORA STREET ERSKINEVILLE (2015/109669)

It is recommended that the Committee endorse the allocation of the following parking on the eastern side of Flora Street, Erskineville as "2P 8am-10pm Permit Holders Excepted Area 36":

In April 2015, the City consulted residents in Flora Street for support to introduce timed permit parking in the street.

ITEM 24 PARKING – PERMIT PARKING – MACDONALD STREET ERSKINEVILLE (2015/057430)

RECOMMENDATION

It is recommended that the Committee endorse the allocation of the following parking in Macdonald Street, Erskineville as "2P 8am-10pm Permit Holders Excepted Area 36":

BACKGROUND

In November 2012, the City consulted with residents to identify streets with strong support for timed permit parking as part of the Erskineville Parking Study.

At that time, residents in Macdonald Street did not support the timed permit parking proposal. It was noted that the City would monitor parking conditions in the street and reconsider the permit parking proposal if there was strong support from residents in the future.

In January 2015, the City has received requests from residents to consider timed permit parking in Macdonald Street, Erskineville.

ITEM 25 PARKING – PERMIT PARKING – PITT STREET REDFERN (2015/167731)

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of parking on the eastern side of Pitt Street, Redfern between the points 12.0 metres and 23.5 metres (2 car spaces) north of Phillip Street as "2P 8am-8pm Mon-Fri Permit Holders Excepted Area 41".

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

A resident of Pitt Street has requested consideration to replace the existing "Loading Zone 8am-3pm Mon-Fri" with "2P 8am-8pm Mon-Fri Permit Holders Excepted Area 41" in Pitt Street north of Phillip Street. The Loading Zone was allocated for the hotel which has closed no longer requiring the Loading Zone.

ITEM 26 PARKING – TICKET – UPPER FORT STREET MILLERS POINT (2015/119645)

RECOMMENDATION

DECISION

The Committee carried the recommendation unanimously.

MATTERS RAISED

ITEM 37 INTERSECTION OF DRUITT AND CLARENCE STREETS SYDNEY (2015/236511)

RECOMMENDATION

It is recommended that the Committee note:

- (A) The amendment to the LPCTCC-supported signal layout for Druitt and Clarence Streets, Sydney;
- (B) City of Sydney does not support the amended signal layout for Druitt and Clarence Streets, Sydney; and
- (C) That the City of Sydney and Roads and Maritime Services (RMS) work collaboratively to develop a solution for the intersection of Druitt and Clarence Streets that is agreeable to both parties

DECISION

The Committee noted that the City does not support the amended signal layout for Druitt and Clarence Streets, Sydney. The City will arrange a meeting with representatives from RMS to develop a solution for this intersection.

BACKGROUND

On 19 December 2013, the NSW Government adopted the Sydney City Centre Access Strategy (Access Strategy). The Access Strategy provides a clear direction for how the different transport modes will work together in the Sydney CBD to reduce congestion, provide for future growth and improve the customer experience. The Access Strategy includes a suite of bus improvements.

As part of the Access Strategy, on 17 March 2015 Local Pedestrian, Cycling and Traffic Calming Committee (LPCTCC) endorsed the following changes to Druitt Street:

- The provision of a dedicated right-turn lane for westbound vehicles from Druitt Street accessing Clarence Street;
- The removal of the existing westbound Bus Lane between George and Clarence Streets; and
- The provision of a painted T1 guideline across the intersection of Druitt and Clarence Streets to define the path of travel for right-turning vehicles from Druitt Street into Clarence Street.

However since the LPCTCC endorsement, RMS has since amended the signal design for the intersection of Druitt and Clarence Streets to remove the T1 guideline and replace with a large painted island.

The RMS informed the City the amendment was instigated due to a perceived risk that it directed right-turning vehicles from Druitt into Clarence Street into the path of travel of opposing vehicles.

COMMENTS

While RMS is the Consent Authority for signalised intersections and as such, can change the signal layout for the intersection of Druitt and Clarence Streets, the City believes that the amendment has its own associated safety and operational issues like:

- Pedestrians may perceive the painted island as additional queuing space and use it to cross the intersection;
- Given that during peak periods buses waiting to access the bus stops further west on Druitt Street queue back east through the intersection, the dedicated right-turn lane is likely to be used illegally by through traffic travelling west; and
- The need for additional capacity at the intersection of Druitt and Clarence Streets is questionable given that under the Access Strategy Park Street will be limited to one general traffic lane in the westbound direction.

The City considers that the guideline provided across the intersection of Druitt and Clarence Streets, in addition to the BB line on approach to the intersection, provides sufficient guidance to prevent right-turning vehicles from Druitt into Clarence Street into the path of travel of opposing vehicles.

Alternatively, the City would also support leaving the intersection in its current state for an agreed time period after the implementation of the bus changes to establish whether the capacity improvements.





SCEGGS – Traffic Congestion

Kings Cross Police raised traffic congestion and road safety issues associated with SCEGGS, Darlinghurst on Bourke Street during the after-school peak.

The Police have suggested two possible solutions to the issue and would like to discuss these further with representatives from the City, RMS and SCEGGS. The City will now facilitate that meeting in the coming weeks.
