RECOMMENDATION

It is recommended that the Committee endorse the temporary road closure of Dalley Street, between Pitt and George Streets, Sydney and Underwood Street, between Pitt and Dalley Streets, Sydney, on the weekends of 21-22 May, 28-29 May and 4-5 June 2016 from 7am to 9pm, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as mentioned in Schedule C of this Agenda.
- (B) The Applicant must comply with any other conditions imposed by City's Construction Regulation Unit.
- (C) The Applicant has indicated the weekends of the 11-12 June and 18-19 June 2016 as alternative dates for the above work as a contingency for inclement weather.
- (D) The Applicant must contact the Sydney City Police to obtain a separate police permit and to discuss deployment of user pay police for the road closures.
- (E) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to commencement of works.
- (F) The Applicant must contact ALTRAC Light Rail team to maintain local access to Dalley Street from George Street during the proposed weekend closures.
- (G) If the above closure dates conflict with any works associated with the CBD and South East Light Rail (CSELR) project, other major works or special events, they may be changed to new dates in consultation with the Transport Management Centre and the Sydney City Police.
- (H) The Applicant must provide a telephone number of the supervisor responsible for the proposed closures and include contact details in the notification letters to be distributed to affected stakeholders.

DECISION

BACKGROUND

Sydney Traffic Control has applied for the temporary road closure of Dalley Street, between Pitt and George Streets, Sydney and Underwood Street, between Pitt and Dalley Streets, Sydney, on the weekends of 21-22 May, 28-29 May and 4-5 June 2016 from 7am to 9pm.

COMMENTS

The proposed temporary road closures are required to allow a mobile crane to install art work in Underwood Street.

The Applicant has provided a site-specific Traffic Control Plans that includes details of barricades, signs, flagmen and other traffic devices to implement the proposed road closures.

As a result of the CBD and South East Light Rail (CSELR) project, George Street is currently closed to all southbound traffic between Alfred and Grosvenor Streets – northbound traffic flow between Alfred and Grosvenor Streets is however maintained but reduced to a single lane.

As such, the Applicant must contact the ALTRAC Light Rail team to maintain local access to Dalley Street from George Street during the proposed weekend closures.

CONSULTATION

The Applicant will be required to notify affected stakeholders as stipulated in Schedule C.

FINANCIAL

All costs associated with the proposed closures will be borne by the Applicant.
