At the March 2016 meeting of the Local Pedestrian, Cycling and Traffic Calming Committee, the Committee endorsed the installation of a 10 metre long Works Zone in Birmingham Street, Alexandria for the Hadd Group Pty Ltd.

DECISION

The Committee carried the recommendation unanimously.

BACKGROUND

In April 2014, the City received correspondence from the Sydney Local Health District (SLHD) raising concerns about pedestrian safety in the vicinity of Royal Prince Alfred Hospital (RPAH).

In response to the safety concerns, the City met with representatives from both Roads and Maritime Services (RMS) and the SLHD to workshop potential safety improvements. The meeting identified the following issues:

- a need to improve pedestrian accessibility, particularly in the vicinity of RPAH, across side streets and at known pinch points like at the existing bus shelters; and
