The City has received a request to change the date for the temporary road closure of Elizabeth Street, between McEvoy and Powell Streets, Waterloo to 17 July 2016 from 6am to 6pm.

COMMENTS

The Committee at its meeting on 18 May 2016 endorsed the temporary closure of Elizabeth Street for 5 June 2016 with alternative date as 19 June 2016. The Applicant has informed that the closure was postponed on both dates due to inclement weather.

Agreement has been obtained from the Roads and Maritime Services, Transport Management Centre and the Police for the new closure date and the alternative date.

All costs associated with the proposed closures were borne by the Applicant.

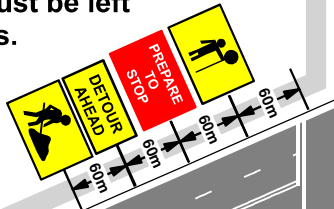

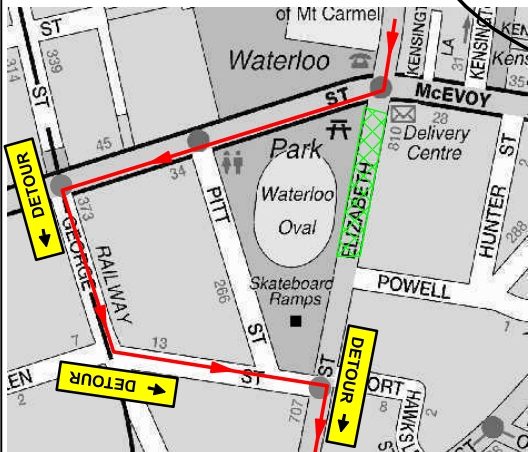

A minimum 3.25m must be left for the buses.

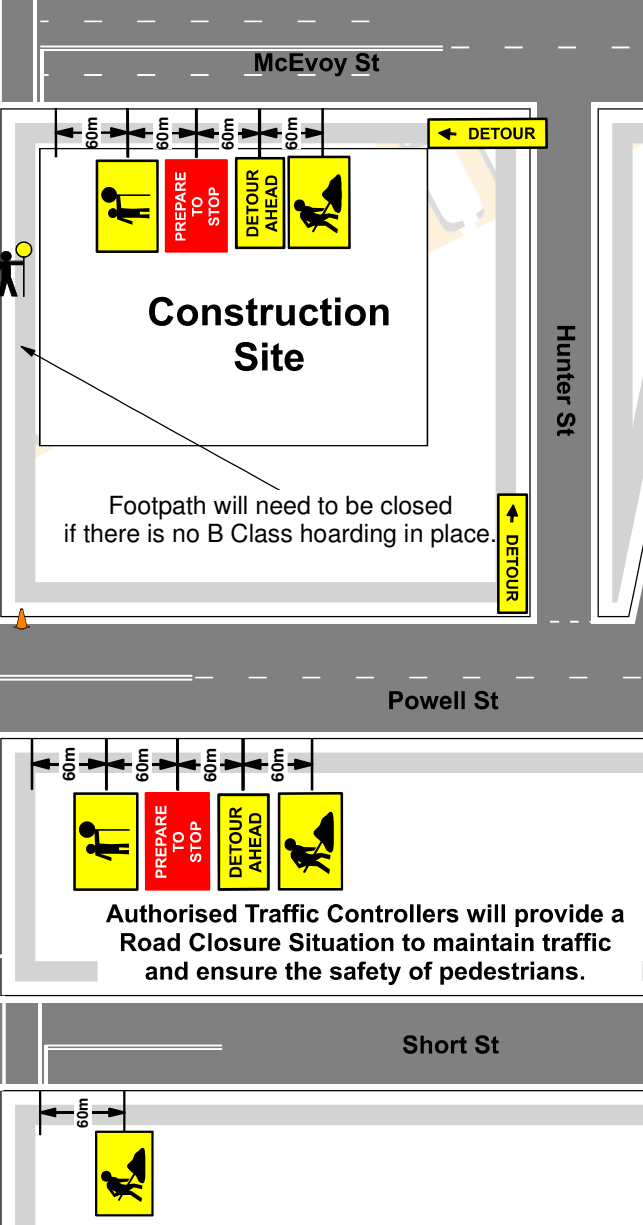
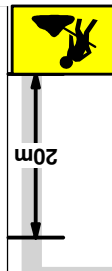


Detour Route for the South Bound Vehicles.
