

**ITEM 12. MOBILE CRANES – TEMPORARY ROAD CLOSURES –
MACQUARIE STREET SYDNEY**

RECOMMENDATION

It is recommended that the Committee endorse the temporary road closure of Macquarie Street, between St James Road and Hunter Street, Sydney, on Sunday 4 September 2016 from 4am to 10pm, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as mentioned in Schedule C of this Agenda.
- (B) The Applicant must comply with any other conditions imposed by City's Construction Regulation Unit.
- (C) The Applicant has indicated Sunday 11 September 2016 as an alternative date for the above work as a contingency for inclement weather.
- (D) The Applicant must contact Sydney City Police to obtain a separate police permit and to discuss deployment of user pay police for the road closure.
- (E) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to commencement of works.
- (F) The Applicant must notify the Sydney Hospital and Sydney Eye Hospital, the State Library, Reserve Bank of Australia, Parliament of New South Wales, The Mint and Hyde Park Barracks Museum at least two weeks before the proposed road closure and accommodate any reasonable request from these significant stakeholders to the satisfaction of the City.
- (G) If the above closure dates conflict with any works associated with the Central and South East Light Rail (CSELR) project, Sydney City Centre Access Strategy (SCCAS) or any other major works or special events, they may be changed to new dates in consultation with the Transport Management Centre and NSW Police.
- (H) The Applicant must provide a telephone number of the supervisor responsible for the proposed closure and include contact details in the notification letters to be distributed to affected stakeholders.
- (I) The Applicant must contact Sydney Buses and arrange and pay for the rerouting of bus services around the closure, the temporary relocation of bus stops and any additional staff required.

DECISION

BACKGROUND

Marr Contracting Pty Ltd has applied for the temporary road closure of Macquarie Street, between St James Road and Hunter Street, Sydney, on Sunday 4 September 2016 from 4am to 10pm.

COMMENTS

The proposed temporary road closure is required to allow a mobile crane to install a tower crane on the frontage of 60 Martin Place, Sydney.

The Applicant has provided a site-specific Traffic Control Plan that includes details of barricades, signs, flagmen and other traffic devices to implement the proposed road closure.

There are currently no other approved temporary road closures proposed to take place on the same day in close proximity of this closure.

The temporary road closure will not affect any other properties, as local access will be provided at all times and alternative access routes are available nearby.

CONSULTATION

The Applicant will be required to notify affected stakeholders as stipulated in Schedule C.

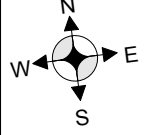
FINANCIAL
