  - is otherwise unsuitable due to a major transport project.

The Applicant must make their own enquiries, on a regular basis, about the potential impact of major transport projects on the Works Zone and the construction program for its development site.

- (D) The Applicant must notify adjacent properties of the Works Zone at least seven days prior to installation.
- (E) The Applicant must provide a telephone number of the Site Manager.

#### BACKGROUND

The Developer of 27 Boundary Street, Darlinghurst, has requested consideration for a temporary "No Stopping" zone in Lindsay Lane until 30 November 2016 to facilitate access for construction vehicles (6.4 metres small rigid vehicles) for development works.

## COMMENTS

The kerb space on the western side of Lindsay Lane, north of Boundary Street is currently unrestricted.

Lindsay Lane is 4.4 metres wide. Under existing conditions, when a vehicle is parked in Lindsay Lane, there is inadequate width for a construction vehicle to enter and exit the site of 27 Boundary Street safely.

A review of the Construction Traffic Management Plan and on-site inspection show there is a need to provide a temporary "No Stopping" restriction on the western side of Lindsay Lane during Stage 1 of construction to facilitate construction vehicle access.

## CONSULTATION

The Applicant must notify adjacent properties and affected stakeholders at least seven days prior to the implementation of the temporary "No Stopping" restriction.


