#### **BACKGROUND**

Sydney Traffic Control has applied for the temporary road closure of Briggs Street, between Church Street and Missenden Road, Camperdown, on Thursday 11 August 2016 from 9am to 6pm.

## **COMMENTS**

The proposed temporary road closure is required to allow a mobile crane to lift building materials onto the roof of 54-60 Briggs Street, Camperdown.

The Applicant has provided a site-specific Traffic Control Plan that includes details of barricades, signs, flagmen and other traffic devices to implement the proposed road closure.

The temporary road closure will not affect any other properties, as local access will be provided at all times and alternative access routes are available nearby.

A Traffic Management Plan (TMP) for the temporary road closure was approved by Roads and Maritime Services (RMS).

#### **FINANCIAL**


All costs associated with the proposed closure will be borne by the Applicant.


