RECOMMENDATION

It is recommended that the Committee endorse the following reallocation of parking in Glebe:

- (A) Southern side of Wentworth Park Road, between the points 0 metres and 20 metres (three car spaces), and 106.5 metres and 119.5 metres (two car spaces), west of Bay Street as "No Stopping";
- (B) Southern side of Wentworth Park Road, between the points 20 metres and 106.5 metres (14 car spaces), west of Bay Street as "2P Ticket 8am-6pm Mon-Fri" and "4P Ticket 6pm-10pm Mon-Fri";
- (C) Eastern side of Cowper Street, between the points 0 metres and 22.6 metres (four car spaces), and 52.9 metres and 63.4 metres (two car spaces), north of Wentworth Street as "No Stopping";
- (D) Eastern side of Cowper Street between the points 22.6 metres and 52.8 metres (five car spaces) as "2P Ticket 8am-6pm Mon-Fri Permit Holders Excepted Area G" and "4P Ticket 6pm-10pm Mon-Fri Permit Holders Excepted Area G";
- (E) Northern side of Wentworth Street, between the points 0 metres and 10 metres (two car spaces), and 27.1 metres and 37.1 metres (two car spaces), west of Cowper Street as "No Stopping"; and
- (F) Northern side of Wentworth Street, between the points 10 metres and 127.1 metres (20 car spaces), west of Cowper Street as "2P Ticket 8am-6pm Mon-Fri Permit Holders Excepted Area G" and "4P Ticket 6pm-10pm Mon-Fri Permit Holders Excepted Area G".

DECISION

BACKGROUND

Development Consent Condition 24 of D/2014/1521 requires the Developer of 87 Bay Street, Glebe, to refer any traffic and parking changes associated with the development to the Committee for consideration.

The traffic and parking arrangement plans are to be reviewed by the City before referral to the Committee for consideration.

COMMENTS

Parking around the development in Wentworth Park Road and Cowper and Wentworth Streets is a mixture of "2P/4P Ticket", "Loading Zones" and "No Parking".

To improve access to on-street parking, it is proposed to introduce "2P Ticket 8am-6pm" and "4P Ticket 6pm-10pm Mon-Fri Permit Holders Area G Excepted". The proposed parking restrictions are consistent with the parking controls in nearby streets.

CONSULTATION

The City has consulted local residents and businesses in the area. There were 57 letters sent out with no responses supporting or opposing the proposal.

FINANCIAL

All cost associated with the proposal will be borne by the Developer.
