

**ITEM 40. PARKING – REALLOCATION OF PARKING – MISSENDEN ROAD  
CAMPERDOWN**

**RECOMMENDATION**

It is recommended that the Committee endorse the following reallocation of parking in Camperdown:

- (A) Eastern side of Missenden Road, between the points 37 metres and 43 metres (one car space), north of Grose Street as “Bus Zone Aus Post Vehicles Excepted 2min Limit”;
- (B) Western side of Missenden Road, between the points 32 metres and 39 metres (one car space), south of Salisbury Road as “No Parking Council Vehicles Excepted”; and
- (C) Western side of Missenden Road, between the points 39 metres and 48 metres (one car space), south of Salisbury Road as “2P Ticket 8am-6pm Mon-Fri, 4P Ticket 6pm-10pm Mon-Fri, 8am-10pm Sat, Sun and Public Holidays.

**DECISION**

**BACKGROUND**

The Missenden Road Post Office is relocating to a new location at 8 Missenden Road, north of Grose Street. As part of the relocation, Australia Post is requesting consideration for “Bus Zone Aus Post Vehicles Excepted 2min Limit” restrictions near the new Post Office to pick up mail.

**COMMENTS**

In June 2016, the Local Pedestrian, Cycling and Traffic Calming Committee endorsed a proposal to improve pedestrian safety and accessibility in Missenden Road between Parramatta Road and King Street. As part of the proposal, a “Bus Zone” is proposed on the eastern kerb space in Missenden Road between Grose Street and Lucas Street.

It is proposed for part of the proposed “Bus Zone” to be reallocated as “Bus Zone Aus Post Vehicles Excepted 2min Limit” to facilitate mail pick up and for buses to enter the bus bay safely.

The existing "Mail Zone" on the western side of Missenden Road, south of Salisbury Road is therefore no longer required and is proposed to be reallocated as "2P/4P Ticket" parking.

There are no net loss of parking spaces in Missenden Road due to this proposal.

### **CONSULTATION**

Sydney Buses and Australia Post have been consulted and have provide support for this proposal.

### **FINANCIAL**

Funds are available in the current budget.

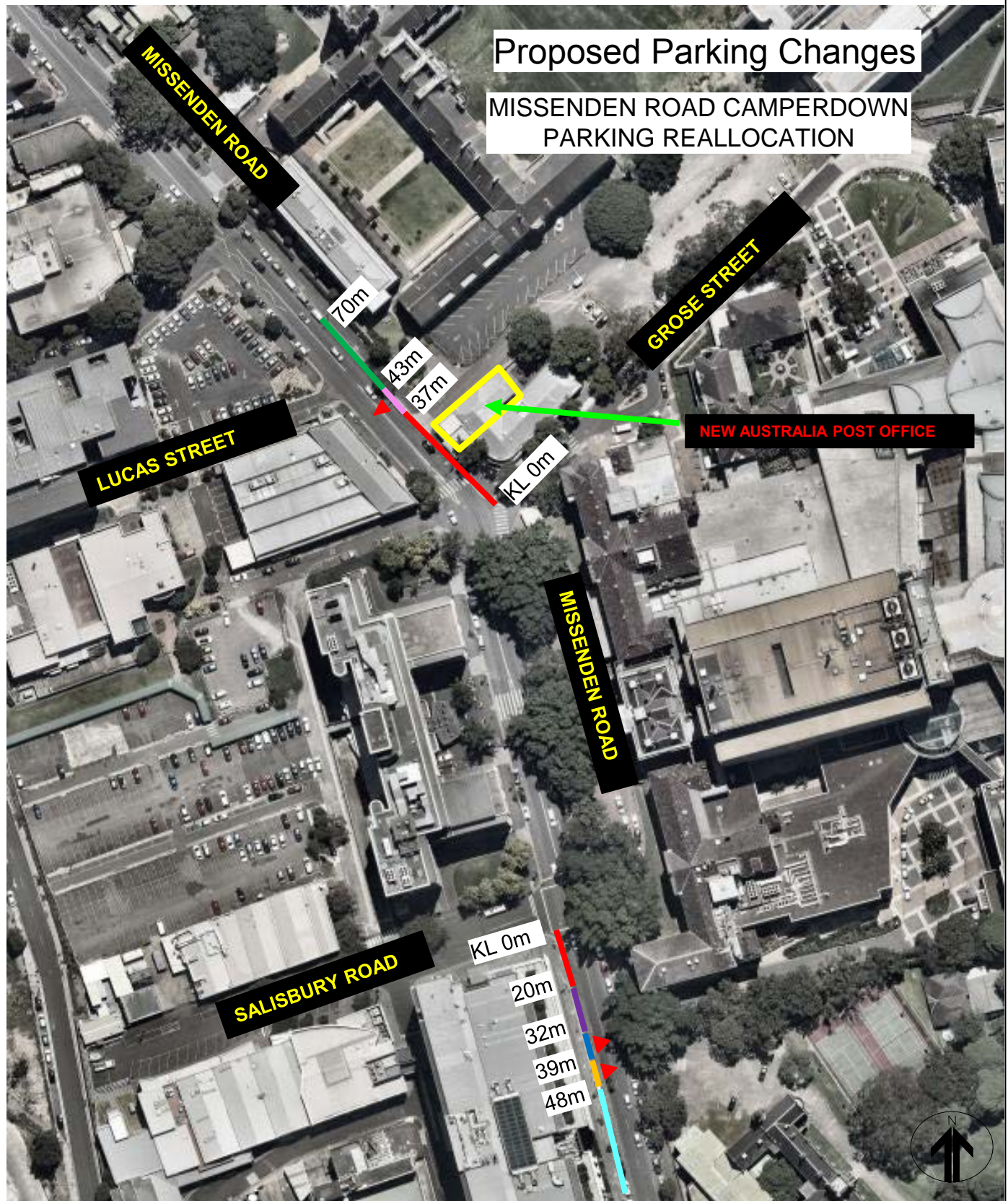
