# **BACKGROUND**

In November 2015, the City consulted the local community on a proposal to permanently close the one-way section of Ashmore Street, east of Binning Street, Erskineville. Feedback received during the consultation raised concerns about the safety of pedestrians, particualry school children, crossing Malcolm Street, just south of Swanson Street.

In December 2015 when the permanent road closure was referred to the Local Pedestrian, Cycling and Traffic Calming Committee (LPCTCC) for consideration and endorsement, the Committee also resolved that the City work collaboratively with Roads and Maritime Services (RMS) to secure support for a pedestrian crossing across Malcolm Street, just south of Swanson Street to address the local safety concerns.

In May 2016, the City commissioned traffic and pedestrian counts at the intersection of Malcolm and Swanson Streets, Erskineville to establish whether current volumes were consistent with RMS warrants for a pedestrian crossing. Counts were undertaken on Tuesday 3 May 2016 between 7am and 7pm.

A summary of the peak data is presented in *Table 1* below.

The RMS Supplement for the *Manual of Uniform Traffic Control Devices* (AS 1742.10-2009) notes that a reduced warrant for pedestrian crossings can be considered if the crossing is to be used by children. Given the crossing of Malcolm Street, just south of Swanson Street, is on a pedestrian desire line between two primary schools, namely Erskineville Public School and St Mary's Catholic Primary School, it has been assumed that the reduced warrant is applicable to this proposal.

Under the reduced warrant, in the two hours immediately before and after school the desire line must exceed 30 pedestrians and 200 vehicles.

The data presented in *Table 1* shows that the reduced warrant is well met during the Before School Peak (0800-0900) however falls short during the After School Peak (1500-1600). It should be noted however that the After School Peak did record a total of 138 pedestrians, or just over two pedestrians per minute, crossing Malcolm Street which is still a considerable volume given the vulnerability of school children.

The count data did however meet the reduced warrant during the Weekday PM Peak (1645-1745). Although this time period is not the After School Peak, given both nearby primary schools have after-school care until 6pm, a considerable volume of school children still use this desire line during the Weekday PM Peak following pick-up.

#### **BACKGROUND**

Development consent has been granted by NSW Planning and Environment (DPE) for a proposed mixed use development on land located between the Western Distributor elevated roadways and within the Darling Harbour/ Cockle Bay tourist and entertainment precinct in the western fringe of Sydney CBD.

The proposed development includes demolition of the existing IMAX building and the construction of a new 25-storey ribbon building and a separate two storey building, incorporating hotel and serviced apartments, retail, restaurant, function space and a new IMAX cinema.

The current programme for the redevelopment includes six months of demolition works, followed by 35 months of main structure works.

As part of the redevelopment of the site, the existing taxi rank and time-restricted bus zone on Wheat Road, adjacent to the IMAX site, will be required to be temporarily closed in order to realign Wheat Road and construct the hotel porte cochère. The closure of Wheat Road is expected to occur in early 2017, after the summer school holidays.

Outside the bus zone period (9:00pm to 6:00am), the zone becomes an overflow taxi zone, with capacity for five vehicles, to support the taxi rank located immediately to the north. It is understood that the taxi rank is a 'Secure Taxi Rank' between 10:00pm and 5:00am on Friday, Saturday and Sunday (only for Public Holidays).

Sydney Explorer buses currently use Wheat Road, with a stop (stop 18) located within the above bus zone. The proposed Wheat Road closure will occur after Sydney Explorer's Convention Centre stop 17 on Darling Drive is reopened in December 2016, following the completion of the Sydney International Convention Exhibition & Entertainment Precinct redevelopment.

Coaches also use the Wheat Road bus zone at times for set-down and pick-up activities.

#### **DECISION**

The Committee carried the recommendation unanimously and noted that from Monday 28 November 2016, Sydney Buses is proposing to terminate University of New South Wales (UNSW) bus services in Foveaux Street, just east of Elizabeth Street.

Representatives from the City, Roads and Maritime Services (RMS), Transport for NSW (TfNSW) and the CBD Coordination Office (CCO) will meet to discuss the proposed route change and identify options for additional bus layover capacity in either Foveaux Street west of Commonwealth Street, or Elizabeth Street south of Foveaux Street.

## **BACKGROUND**

In March 2015, the City received part funding from the Roads and Maritime Services (RMS) under the 2015/16 Active Transport Program to undertake streetscape improvements in Foveaux Street, Surry Hills. This funding has been carried over into 2016/17. The Active Transport Program funds treatments to make walking and cycling safer, more convenient and enjoyable transport option that benefit everyone.

Key elements of the streetscape improvements include:

- Footpath widening and kerb extensions on the northern side of Foveaux Street between Crown and Mary Streets;
- Continuous footpath treatments across Norton, Little Norton, Little Riley, Corben, Waterloo, Bellevue, Belmore and Commonwealth Streets;
- A new mid-block signalised pedestrian crossing in Foveaux Street, east of Commonwealth Street – subject to RMS approval;
- Upgrades to the signalised intersections of Foveaux Street with both Crown and Riley Streets – subject to RMS approval; and
- Streetscape improvements including new garden beds and street furniture.

#### **19 OCTOBER 2016**

Following discussions with the CBD Coordination Office (CCO), Roads and Maritime Services (RMS) and Transport for NSW (TfNSW), the proposed works will also include the following:

- Dedicated right turn bays with right turn pavement markings on Foveaux Street on approach to Riley, Little Riley, Corben, Bellevue, Belmore and Commonwealth Streets;
- Restrict northbound traffic on Little Riley Street onto Foveaux Street to left turn only;
- Removal of parking on the southern side of Foveaux Street between Commonwealth and Elizabeth Streets; and
- Linemark the edge of the parking lane on the northern side of Foveaux Street.

It was agreed between the key stakeholders that the traffic treatments will be reviewed six months after construction to determine if the full suite of streetscape improvements can be implemented.

To address the high volume of pedestrians crossing Mary Street, north of Foveaux Street, consideration to introduce a marked pedestrian crossing was deferred to allow the City, RMS and TfNSW to work together to address the actual and potential conflict between pedestrians and vehicles at this location.

Once delivered, the streetscape improvements will significantly improve pedestrian accessibility and safety, calm traffic, enrich the streetscape and address the significant crash history that has been recorded in Foveaux Street.

Parking restrictions in Foveaux Street will be rationalised in line with the City's Neighbourhood Parking Policy. The 1/2P, 1P, 2P and 4P ticket parking will be rationalised to "2P Ticket 8am-6pm Mon-Fri" and "4P Ticket 6pm-10pm Mon-Fri 8am-10pm Sat, Sun & Public Holidays". Seven ticket parking spaces will be lost to accommodate the proposed traffic signal works and ensure compliance with RMS Technical Direction *Stopping and Parking Restrictions at Intersections and Crossings*. However, to support business continuity, all existing Loading Zones will be maintained, their times extended and rationalised as "Loading Zone Ticket 8am-6pm Mon-Fri" and "4P Ticket 6pm-10pm Mon-Fri 8am-10pm Sat, Sun & Public Holidays".

Since 2014, the City has worked collaboratively and has received in-principal support to deliver the streetscape improvements from the CCO, RMS, Sydney Buses, TfNSW, TMC and the local residents and businesses.

The streetscape improvements have been approved by Council on 14 December 2015 and endorsed by the Central Sydney Traffic and Transport Committee (CSTTC) on 29 September 2016.

#### **COMMENTS**

Foveaux Street, Surry Hills, is a 50km/h, one-way westbound regional road with two central travel lanes and a parking lane on each side of the street.

Foveaux Street is considered one of the main gateways into Surry Hills from Central Station with frontages activated, particularly along the northern kerb, by businesses, education institutions, residential properties, retail shops, restaurants, cafes, pubs and bars.

**19 OCTOBER 2016** 

Foveaux Street is also the most direct and desired pedestrian route between Central Station and the Moore Park Entertainment Precinct which includes the Sydney Cricket Ground, Sydney Football Stadium, Fox Studios and Centennial Park.

# **Policy Context**

In 2008, Council adopted the Surry Hills Pedestrian, Cycling and Traffic Calming (PCTC) Plan. The Plan, developed in conjunction with local residents and businesses, identified key treatments to improve pedestrian safety and accessibility in Surry Hills.

The following three treatments were recommended for Foveaux Street:

- A new signalised pedestrian crossing across Foveaux Street at Commonwealth Street;
- Kerb extensions at all intersecting streets with Foveaux Street between Mary and Crown Streets; and
- Consideration for footpath widening.

Similarly, in 2011, Council adopted the Liveable Green Network (LGN) Strategy and Master Plan. The LGN aims to create a pedestrian and cycling network that connects people with the city and village centres, as well as major transport and entertainment hubs, cultural precincts, parks and open spaces.

Key LGN routes will comprise widened footpaths and upgraded crossings to improve pedestrian safety and accessibility, as well as enhanced street furniture, like seats and bubblers, to further encourage walking as a viable mode of transport.

Foveaux Street was identified in the Master Plan as a key pedestrian link between Central and Moore Park and proposed the following improvements:

- Upgrade the urban space to create a distinctive nodal point/rest area; and
- Encourage further ground floor activation along Foveaux Street to improve street amenity.

The traffic treatments and streetscape improvements proposed for Foveaux Street are consistent with both the Surry Hills PCTC Plan and Liveable Green Network (LGN) Strategy and Master Plan.

#### **Proposal Development**

In 2014, the City commenced work on developing a solution for Foveaux Street that was consistent with the recommendations from both the Surry Hills PCTC Plan and the LGN Strategy and Master Plan, as well as address the significant crash history – a total of **127** *crashes* between 1 July 2008 and 30 June 2015, of which 85 (more than half) were classified as injury crashes and 24 involved collisions with pedestrians – that had been recorded for the corridor.

The original proposal included kerb extensions and continuous footpath treatments at all intersecting streets between Mary and Crown Streets, a raised marked pedestrian crossing across Mary Street, a new signalised pedestrian crossing across Foveaux Street at Commonwealth Street, and footpath widening on both the northern and southern footpaths. This proposal was subsequently forwarded to Roads and Maritime Services (RMS), Transport for NSW (TfNSW), Sydney Buses and the CBD Coordination Office (CCO) for review and comment.

#### **19 OCTOBER 2016**

Following the review, the City received 'in principle' support from the key stakeholders, subject to the removal of all footpath widening proposed for the southern kerb, and the continuous footpath treatment proposed for Waterloo Street, just south of Foveaux Street.

Both the RMS and TfNSW requested retention of the southern kerbside lane for use as a Special Event Clearway during major events at Moore Park. Furthermore, Sydney Buses also requested retention of the southern kerbside lane to maintain continuity for bus services along Fitzroy and Foveaux Streets, and to ensure passengers can safely board and alight services on the left side of the road.

RMS rejected the continuous footpath treatment proposed for Waterloo Street, just south of Foveaux Street, in favour of kerb extensions. The City subsequently amended the proposal to reflect the RMS response.

Detailed design analysis undertaken by the City also identified flooding concerns for adjacent properties if the continuous footpath treatment proposed for Terry Street, just south of Foveaux Street, was delivered. As such, the proposal for Terry Street was subsequently removed.

On 12 January 2016, a report on the streetscape improvements was sent to the Central Sydney Traffic and Transport Committee (CSTTC) for endorsement.

On 19 February 2016, CSTTC members attended a Working Group Meeting where the CCO, RMS and TfNSW raised the following concerns:

- Traffic impacts of the proposed kerb extensions;
- Traffic impacts of the proposed continuous footpath treatments;
- Traffic impacts during the construction of the streetscape improvements;
- Non-compliance with RMS warrants for the proposed pedestrian crossing across Mary Street; and
- Non-compliance with RMS warrants for the proposed continuous footpaths treatments.

On 10 May 2016, RMS wrote to the City advising that RMS and the CCO:

- Support the removal of all kerb extensions on approach to the intersections.
- Support the removal of all kerb extensions on the approach to Commonwealth Street, but do not support a new signalised leg across Commonwealth Street.
- Require the installation of right turn pavement markings at each of the side streets to further enhance the lanes function and improve compliance.
- Support the request to remove parking full time from the No Stopping zone on the approach to the new pedestrian signals at Commonwealth Street to Elizabeth Street.
- Suggest an alternative location for the No Parking zone should be sought (for example, rearranging the bus zone and No Parking zone but maintain no extended parking areas).
- Require that Council clarifies the width of the parking lanes at each of the new bays.
   In accordance with Australian Standard 2890.5, continuous line marking should be provided for all parking bays that are 2.1 metres wide.
- Require that Council line mark the Riley Street right turn as a separate lane and not as indicated on the plans sent.

 Require that Council clarify the width and traffic control for the southern leg of Waterloo Street.

It was also stated in RMS's letter that:

- RMS and CCO could not support the proposed streetscape improvements until they
  were satisfied that the construction activities would not restrict traffic flow on Foveaux
  Street;
- RMS have no plans at this stage to introduce 40km/h speed limits in Foveaux Street and the streets bounded by Cleveland, Chalmers, Elizabeth, Liverpool and Oxford Streets; and
- The crash history at the intersection of Foveaux and Riley Streets at this time does not meet the criteria for a red light speed camera.

On 23 June 2016, representatives of the City, CCO, RMS, TfNSW and TMC met to address concerns raised in RMS's letter. Following the meeting, the proposed streetscape improvements received 'in principle' support from the key stakeholders, subject to the following:

- Removal of all footpath widening and kerb extensions proposed for the southern kerb;
- Removal of the continuous footpath treatment proposed for Waterloo Street, on the southern side of Foveaux Street;
- Removal of the raised marked pedestrian crossing proposed across Mary Street and for the City, RMS and TfNSW to work together to address the actual and potential conflict between pedestrians and vehicles at this location;
- Removal of kerb extensions and installation of dedicated right turn bays with right turn pavement markings on approach to Riley, Little Riley, Corben, Bellevue, Belmore and Commonwealth Streets;
- Restrict northbound traffic on Little Riley Street onto Foveaux Street to left turn only;
- Removal of parking on the southern side of Foveaux Street between Commonwealth and Elizabeth Streets; and
- Linemark the edge of the parking lane on the northern side of Foveaux Street.

As part of the City's original submission, data was collected (*Table 1*) at Mary Street, north of Foveaux Street, to show support for a proposed marked pedestrian crossing at this location.

The results show that although more than 350 pedestrians cross Mary Street during the three peak-hour periods, a marked pedestrian crossing at this location would not meet the numerical RMS warrants due to the relatively low number of vehicles that travel on Mary Street.

It was agreed to remove the proposed raised marked pedestrian crossing across Mary Street, north of Foveaux Street, so that the City, RMS and TfNSW can work together to address the actual and potential conflict between pedestrians and vehicles at this location.

# **Construction Methodology and Schedule**

The CCO and Traffic Management Centre (TMC) have agreed to the construction schedule of the streetscape improvements and construction methodology to:

- Maintain two 3.25 metres wide travel lanes at all times;
- Apply for a temporary 40km/h work zone speed limit;
- Construction works to begin from Crown Street and work towards Mary Street; and
- Consider options to temporarily remove parking on the southern side of Foveaux Street if required.

# **Submission for Active Transport Funding**

Taking into consideration advice from key stakeholders, the City amended the original proposal as follows:

#### Northern Kerb

- Continuous footpath treatments at all intersecting streets with Foveaux Street between Commonwealth and Crown Streets; and
- Footpath widening between Mary and Crown Streets to improve pedestrian accessibility, provide opportunities for footpath dining, and deliver garden beds and street furniture.

#### Southern Kerb

- Upgrade existing footpath between Elizabeth and Crown Streets;
- Continuous footpath treatments across Little Riley and Norton Streets, just south of Foveaux Street;
- Kerb extensions in Waterloo Street, just south of Foveaux Street, to reduce the crossing distance for pedestrians.

## Foveaux Street Corridor

- A new signalised pedestrian crossing across Foveaux Street at Commonwealth Street
   subject to RMS approval;
- Upgrades to the signalised intersections of Foveaux Street with both Crown and Riley Streets – subject to RMS approval; and
- Streetscape improvements, including new garden beds, grass verges, street furniture and lighting.

The footpath widening along the northern kerb of Foveaux Street will require upgrades (pram ramps, linemarking and signal post changes) to the existing signalised intersections of Foveaux Street with both Crown and Riley Streets. The upgrade to the signalised intersection of Foveaux and Riley Streets also includes expanded bicycle storage areas on Riley Street which will have no impact on Foveaux Street.

To further improve safety in association with the Streetscape Improvements, the expanded bicycle storage areas on Riley Street improves safety for cyclists and is in accordance with

RMS Technical Direction TDT 2009/06 *Bicycle Storage Areas and Advanced Bicycle Stop Lines* and Action 18 of TfNSW's *Cycling Safety Action Plan 2014-2016*.

The proposed signalised pedestrian crossing and upgrades to the existing signalised intersections will be subject to RMS approval.

In late 2014, the City submitted the amended proposal to RMS for funding consideration under the NSW Government's 2015/16 Active Transport Program. The Program funds initiatives that deliver significant improvements to pedestrian safety and accessibility.

In March 2015, the City received funding (\$715,836) from RMS under the 2015/16 Active Transport Program to deliver the amended proposal for Foveaux Street. In May 2015, the City's Chief Executive Officer subsequently accepted the funding subject to the requirement that the City delivered the streetscape improvements no later than **30 June 2016**.

Following delays outside of the City's control to the approval and delivery of the streetscape improvements, the City's Chief Executive Officer wrote to RMS on 6 May 2016 requesting to carry over funding to the 2016/17 Financial Year. On 6 July 2016, RMS wrote to the City confirming that a total of \$83,817 of funding has already been claimed within the 2014/15 and 2015/16 Financial Year and that \$632,019 of funding has been approved to be carried over into the 2016/17 Financial Year.

# **Support for Amended Proposal**

The amended proposal will significantly improve pedestrian safety and accessibility on both sides of Foveaux Street by:

- Providing priority for pedestrians at most intersecting streets between Mary and Crown Streets;
- Footpath widening, which will provide opportunities to install additional street furniture such as seats and bubblers which are particularly important for mobility-impaired pedestrians, given the topography of Foveaux Street;
- Narrowing the carriageway, which will support lower vehicle speeds this safety treatment has been referenced in the Austroads Guide to Traffic Management Part 8: Local Area Traffic Management which notes that lane narrowing contributes to reduced vehicle speeds; and
- Improved sight lines at intersecting streets, which will increase visibility between pedestrians and approaching vehicles.

Parking restrictions in Foveaux Street will be rationalised in line with the City's Neighbourhood Parking Policy. The 1/2P, 1P, 2P and 4P ticket parking will be rationalised to "2P Ticket 8am-6pm Mon-Fri" and "4P Ticket 6pm-10pm Mon-Fri 8am-10pm Sat, Sun & Public Holidays". Seven ticket parking spaces will be lost to accommodate the proposed traffic signal works and ensure compliance with RMS Technical Direction *Stopping and Parking Restrictions at Intersections and Crossings*. However, to support business continuity, all existing Loading Zones will be maintained, their times extended and rationalised as "Loading Zone Ticket 8am-6pm Mon-Fri" and "4P Ticket 6pm-10pm Mon-Fri 8am-10pm Sat, Sun & Public Holidays".

Consultation with local residents and businesses on the amended proposal was well received, particularly during the door-knocking exercise in June 2015. Many businesses fronting the northern kerb were particularly excited about the prospect of improved amenity, as well as future opportunities for footpath dining. Over 500 letters were sent out to the local community.

The streetscape improvements have been approved by Council on 14 December 2015 and endorsed by the Central Sydney Traffic and Transport Committee (CSTTC) on 29 September 2016.

#### **CONSULTATION**

Consultation on the proposed streetscape improvements was undertaken in two stages. The first stage involved face-to-face consultation with local businesses. The second stage involved consultation with affected residents and businesses via letterbox drop.

560 letters were sent out with one response supporting the proposal and no responses opposing the proposal.

Since 2014, the City has worked collaboratively and has received in-principal support to deliver the streetscape improvements from the CCO, RMS, Sydney Buses, TfNSW, TMC and the local residents and businesses.

The streetscape improvements have been approved by Council on 14 December 2015 and endorsed by the Central Sydney Traffic and Transport Committee (CSTTC) on 29 September 2016.

## **FINANCIAL**

The proposal will be funded under a 50/50 arrangement between RMS and the City as part of the NSW Government's 2015/16 Active Transport Program. RMS has approved for funding to be carried over into the 2016/17 Financial Year.
