 - if the Works Zone is required for a major transport project; or
 - is impracticable due to changes arising from a major transport project, such as traffic diversions; or
 - is otherwise unsuitable due to a major transport project.

The Applicant must make their own enquiries, on a regular basis, about the potential impact of major transport projects on the Works Zone and the construction program for its development site.

- (D) The Applicant must notify adjacent properties of the Works Zone at least seven days prior to installation.
- (E) The Applicant must provide a telephone number of the Site Manager.

Under existing conditions, the footpath width in this section of Phillip Street is restricted, particularly between Pitt and Douglas Streets, which forces most pedestrians to walk on the road. Pedestrian counts commissioned by the City in May 2016 confirmed this issue.

Of the 992 pedestrians recorded using Phillip Street between 7am and 7pm, almost 80 per cent walked on the road.

To improve pedestrian safety and accessibility in Phillip Street, and lower vehicle speeds, it is recommended that a Shared Zone be considered between Pitt and Chalmers Streets. A Shared Zone would make it legal for pedestrians to walk on the carriageway and restrict through traffic to a maximum speed limit of 10km/h.
