RECOMMENDATION

It is recommended that the Committee endorse the following reallocation of parking in Hickson Road, Millers Point, south of Pottinger Street:

- (A) On the western side of Hickson Road, between the points 51.5 metres and 75.4 metres (four car spaces) as "Loading Zone Ticket 6am-3pm Mon-Fri", "Bus Zone 3pm-6.30pm Mon-Fri" and "4P Ticket 6.30pm-10pm Mon-Fri, 10am-10pm Sat, 8am-10pm Sun and Public Holidays";
- (B) On the western side of the central median of Hickson Road, between the points 16.9 metres and 70 metres (nine car spaces) as "2P Ticket 8am-6pm" and "4P Ticket 6pm-10pm Mon-Fri, 8am-10pm Sat, Sun and Public Holidays; and
- (C) On the eastern side of the central median of Hickson Road, between the points 12.7 metres and 49.8 metres (six car spaces) as "2P Ticket 8am-6pm" and "4P Ticket 6pm-10pm Mon-Fri, 8am-10pm Sat, Sun and Public Holidays".

DECISION

BACKGROUND

At the September 2015 meeting of the Local Pedestrian, Cycling and Traffic Calming Committee (LPCTCC), it was recommended that the City review the provision of bus parking in Hickson Road following the introduction of bus routes 311, 324 and 325.

COMMENTS

Following the introduction of bus routes 311, 324 and 325, parking in Hickson Road, south of Pottinger Street, is a mixture of "Bus Zone", "Loading Zone" and "2P/4P Ticket Parking".

In June 2016, the City reviewed the bus parking provisions in Hickson Road and found that some of the parking was not required and could be reallocated back to 2P/4P Ticket parking.

CONSULTATION

The City consulted local residents and businesses in the area. There were 312 letters sent out with no responses supporting or opposing the proposal. Transport for NSW (TfNSW) has been consulted and raised no objection to the proposal.


FINANCIAL
