It is recommended that the Committee endorse the reallocation of parking on the eastern side of Kent Street, Millers Point, between the points 21.2 metres and 40.4 metres (three car spaces), north of High Street, as “2P Ticket 8am-10pm Authorised Resident Vehicles Excepted Area 16”.

DECISION

BACKGROUND

The City has received a request from the public to investigate the utilisation of the part-time Bus Zone on the eastern side of Kent Street, Sydney.

COMMENTS

Transport for New South Wales (TfNSW) has advised that the part-time “Bus Zone” in Kent Street is not being used by route service buses and can be reallocated to “2P Ticket 8am-10pm Authorised Resident Vehicles Excepted Area 16”.

On-site inspection shows that if the part-time “Bus Zone” is not being used, there is a need to reallocated parking to timed permit parking to increase parking turnover and improve resident access to on-street parking.

The proposed changes would limit any vehicles which does not have a permit to two (2) hours of parking from 8am to 10pm where the signs are installed.

Residents with an Area 16 parking permit will be exempt from the two-hour time limit.

CONSULTATION

The City consulted local residents and businesses in the area. There were 95 letters sent out with no responses supporting or opposing the proposal.

The proposal was supported by the Millers Point Resident Action Group.

FINANCIAL

Funds are available in the current budget.
