

**ITEM 16. ROAD WORKS – TEMPORARY ROAD CLOSURES – LITTLE
ALBION STREET SURRY HILLS**

RECOMMENDATION

It is recommended that the Committee endorse the temporary road closure of Little Albion Street, Surry Hills between Commonwealth Street and Crawford Place, from Monday 3 April 2017 to Saturday 13 May 2017 from 7.30am to 5.30pm, excluding Sundays and Public Holidays, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as mentioned in Schedule C of this Agenda.
- (B) The Applicant must comply with any other conditions imposed by City's Construction Regulation Unit.
- (C) The Applicant has indicated 15 May to 3 June 2017 as an additional period for the road works as a contingency for inclement weather.
- (D) The Applicant must contact Surry Hills Police to obtain a separate police permit and to discuss deployment of user pay police for the road closure.
- (E) If the above closure dates conflict with any works associated with the CBD and South East Light Rail (CSELR) project, Sydney City Centre Access Strategy (SCCAS) or any other major works or special events, they may be changed to new dates in consultation with the Transport Management Centre and Surry Hills Police.
- (F) The Applicant must provide a telephone number of the supervisor responsible for the proposed closure and include contact details in the notification letters to be distributed to affected stakeholders.

DECISION

BACKGROUND

Taylor Construction Group has applied for the temporary road closure of Little Albion Street, Surry Hills between Commonwealth Street and Crawford Place, from Monday 3 April 2017 to Saturday 13 May 2017 from 7.30am to 5.30pm, excluding Sundays and Public Holidays.

COMMENTS

The proposed temporary road closure is required to facilitate the installation of high voltage cables, as well as stormwater, sewage and gas connections to 66-78 Albion Street, Surry Hills

The Applicant has provided a site-specific Traffic Control Plan (TCP) that includes details of barricades, signs, flagmen and other traffic devices to implement the proposed road closure.

There are currently no other approved temporary road closures proposed to take place on the same day in close proximity of this closure.

The temporary road closure will not affect any other properties, as local access will be provided at all times and alternative access routes are available nearby.

A Traffic Management Plan (TMP) for the temporary road closure was approved by Roads and Maritime Services (RMS) on 18 January 2017.

CONSULTATION

The Applicant will be required to notify affected stakeholders as stipulated in Schedule C.

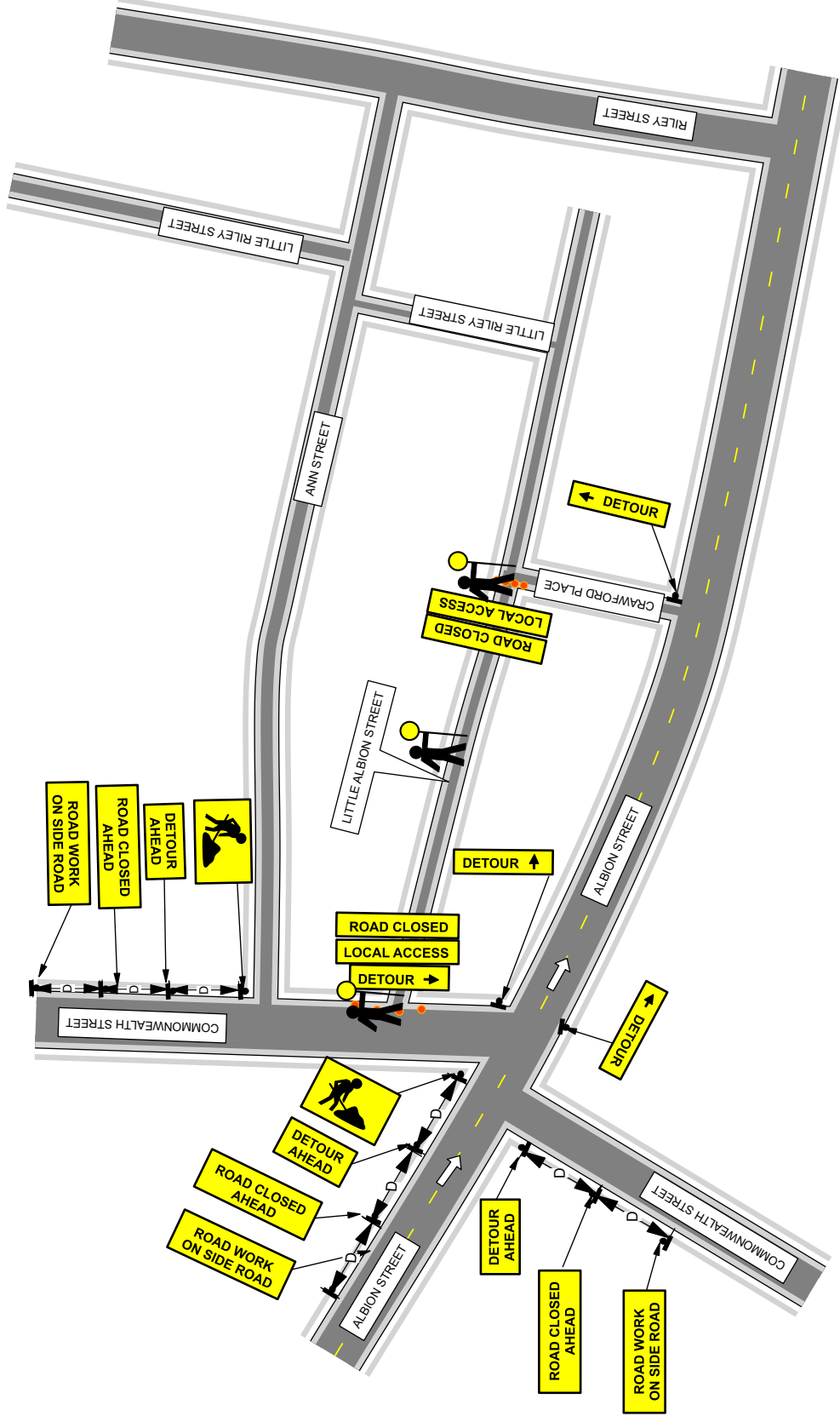
FINANCIAL

GENERAL NOTES

1. No works that represent a hazard to vehicular or pedestrian movement are to occur prior to the erection of signage or control devices detailed in this plan.
2. Traffic control devices and signs shall be placed in the most safe and practicable location available.
3. Work zones subject to relevant council approval.
4. Aerial images taken from Nearmap - Accuracy not guaranteed and is intended as a guide only.
5. All temporary signs indicated on this plan are to be covered/removed after completion of nominated stage of works or operational hours.
6. All temporary signs are to be implemented as per RMS Traffic Control Artwork Sizes.
7. Assume D value (Distance between signages) is 50 metres in accordance with RMS Traffic Control at Work Sites. Local speed limit taken as 50km/h.
8. Safety barriers (A-Frame) installed at Little Albion Street
