RECOMMENDATION

It is recommended that the Committee endorse the reallocation of ticket parking on the eastern side of Brisbane Street, Surry Hills, between the points 23.1 metres and 110.5 metres (15 car spaces) south of Goulburn Street, as "2P Ticket 8am-6pm Mon-Fri" and "4P Ticket 6pm-10pm Mon-Fri, 8am-10pm Sat, Sun and Public Holidays".

DECISION

BACKGROUND

The City proposes to change the parking restriction on the eastern side of Brisbane Street, Surry Hills, between Goulburn and Hunt Streets, to "2P Ticket 8am-6pm Mon-Fri" and "4P Ticket 6pm-10pm Mon-Fri, 8am-10pm Sat, Sun and Public Holidays".

COMMENTS

The kerb space on the eastern side of Brisbane Street, Surry Hills, between Goulburn and Hunt Streets, is currently signposted as "2P Ticket 8am-6pm Mon-Sat" while the western side of Brisbane Street is signposted as "2P Ticket 8am-10pm Authorised Residents Vehicles Excepted Area 18".

The City proposes to extend the restriction on the eastern side of Brisbane Street, immediately adjacent to Harmony Park, to "2P Ticket 8am-6pm Mon-Fri" and "4P Ticket 6pm-10pm Mon-Fri, 8am-10pm Sat, Sun and Public Holidays".

The proposal will improve the turnover and availability of parking for visitors to surrounding properties and Harmony Park, as well as ensure consistency with other ticketed non-resident permit parking in nearby streets. The existing resident permit parking on the western side of Brisbane Street will remain unchanged.

CONSULTATION

The City consulted local residents and businesses in the area. There were 549 letters sent out with no responses supporting the proposal and two responses opposing the proposal.

The responses opposing the proposal were concerned about the loss of unrestricted parking in the evenings and on Sundays.

The City originally proposed to update the parking restriction on the eastern side of Brisbane Street to "2P Ticket 8am-10pm" to ensure operational consistency with the restrictions on the western side of Brisbane Street.

Following feedback from local residents, the City amended the proposal to "2P Ticket 8am-6pm Mon-Fri" and "4P Ticket 6pm-10pm Mon-Fri, 8am-10pm Sat, Sun and Public Holidays". This amended proposal increases the time visitors can park on-street on weekday evenings and weekends (i.e. from a maximum of two hours in the original proposal to four hours in the amended proposal), increases the turnover and availability of parking on weekday evenings and weekends, and ensures consistency with other ticketed non-resident permit parking in nearby streets.


