#### **RECOMMENDATION**

It is recommended that the Committee note the permanent removal of the temporary road closures at the following locations on Friday and Saturday nights:

- (A) Cowper Wharf Roadway, Woolloomooloo, between Brougham and Wylde Streets (northbound), between 11pm and 3am; and
- (B) Temporary removal of the left-turn vehicular movement from Greenknowe Avenue into Macleay Street, Potts Point, between 11 pm and 5 am.

#### **DECISION**

The Committee noted the recommendation unanimously.

#### **BACKGROUND**

Following concerns raised by the local community and NSW Police, in December 2009 the City initiated the temporary closure of Cowper Wharf Roadway, Woolloomooloo on Friday and Saturday nights to deter anti-social behaviour (e.g. street racing, playing loud music from a car stereo, etc.) from both Woolloomooloo and Potts Point (particularly Kings Cross).

In 2014, at the request of the NSW Police, the temporary closures were extended to include the temporary removal of the left-turn movement from Greenknowe Avenue into Macleay Street, Potts Point on Friday and Saturday nights.

In late 2016, the City sought clarification from the NSW Police on whether the temporary closures were still required on Friday and Saturday nights. In January, the City received correspondence from the NSW Police supporting the cessation of the temporary closures.

To adequately assess local impacts, a trial removal of the closures was conducted over four consecutive weekends commencing on 17-18 February 2017.

### ITEM 10 WORKS ZONE – DAWSON STREET SURRY HILLS (2017/204327)

#### RECOMMENDATION

It is recommended that the Committee endorse the reallocation of kerb space on the northern side of Dawson Street, Surry Hills, between the points 49 metres and 58 metres (two car spaces) east of Elizabeth Street as "Works Zone 7.30am-5.30pm Mon-Fri, 7.30am-3.30pm Sat" and "1P 5.30pm-10pm Mon-Fri, 3.30pm-10pm Sat, Permit Holders Excepted Area 18" subject to the following conditions:

- (A) The Applicant must comply with the Works Zone conditions as stipulated in Schedule C of this Agenda.
- (B) The Applicant is not permitted to operate any part of a crane over a public road or hoist/swing goods from a Works Zone across or over any part of a public road by means of a lift, hoist or crane unless a separate approval has been obtained from the City's Construction and Building Certification Services Unit as required under Section 68 of the Local Government Act 1993 and Section 138 of the Roads Act 1993.
- (C) The Works Zone shall only be used by vehicles up to an Australian Standard 6.4 metre long Small Rigid Vehicle (SRV) so that it does not impact on vehicular access along Dawson Street.
- (D) The Applicant must temporarily remove the kerb and footpath so that construction vehicles using the Works Zone can park up to the property line of the site. At the completion of the project, the Applicant must reinstate the original kerb and footpath to the satisfaction of the City.
- (E) The Applicant must provide RMS-Accredited Traffic Controllers to safely manage the operation of the Works Zone and maintain local vehicular access in Dawson Street at all times. If approaching traffic cannot pass a vehicle in the Works Zone, the RMS-Accredited Traffic Controllers must instruct the construction vehicle to depart the Works Zone immediately. Also if a vehicle cannot enter the driveway opposite the site, the RMS-Accredited Traffic Controllers must instruct the construction vehicle to depart the Works Zone immediately.
- (F) If access along Dawson Street, or access to the driveway opposite the site, is obstructed, the Applicant will be required to show cause why the Works Zone should not be terminated immediately.
- (G) The Applicant must notify adjacent properties of the Works Zone at least seven days prior to installation.
- (H) The Applicant must provide a telephone number of the Site Manager.

- (B) The Applicant is not permitted to operate any part of a crane over a public road or hoist/swing goods from a Works Zone across or over any part of a public road by means of a lift, hoist or crane unless a separate approval has been obtained from the City's Construction and Building Certification Services Unit as required under Section 68 of the Local Government Act 1993 and Section 138 of the Roads Act 1993.
- (C) Works for major transport projects, such as the CBD and South-East Light Rail (CSELR) project and the Sydney City Centre Access Strategy, are currently being undertaken in the City's Local Government Area and have priority access and use rights over City-owned or controlled land including roads and footpaths. The City may at any time, and with at least one business days' notice to the Applicant, revoke, suspend or restrict the Works Zone:
  - if the Works Zone is required for a major transport project; or
  - is impracticable due to changes arising from a major transport project, such as traffic diversions; or
  - is otherwise unsuitable due to a major transport project.

The Applicant must make their own enquiries, on a regular basis, about the potential impact of major transport projects on the Works Zone and the construction program for its development site.

- (D) The Applicant must notify adjacent properties of the Works Zone at least seven days prior to installation.
- (E) The Applicant must provide a telephone number of the Site Manager.

On 19 December 2013, the NSW Government adopted the Sydney City Centre Access Strategy (Access Strategy). The Access Strategy will deliver a fully integrated transport network in Sydney's City Centre that puts the customer first and meets the growing transport task. It will mean more people use public transport to access the City Centre and it will change the way people move around within it.

The Access Strategy considers all transport modes and demonstrates how light rail, buses, trains, ferries, cars, taxis, pedestrians and cyclists will interact in the heart of Sydney. The Access Strategy also provides a clear direction for how all the different transport modes will work together in the Sydney CBD to reduce congestion, provide for future growth and improve the customer experience.

There is intense competition for use of kerbside space in central Sydney. The narrow streets and short east-west blocks limit the useable kerb space that can be safely allocated to support commercial and transport functions.

As additional commercial, retail and residential floor space is constructed in and near central Sydney, and new precincts are developed, there will be increasing demands on the available ensure the street network can accommodate critical business and local needs, while maintaining the efficient operation of the broader public and private transport networks.
