ITEM 3 ITEM FOR COMMITTEE INFORMATION – OTHER AUTHORITIES – PARKING AND TRAFFIC CHANGES – LOFTUS STREET PITT STREET AND REIBY PLACE SYDNEY (2017/341515)

RECOMMENDATION

It is recommended that the Committee note the following traffic changes:

- (A) Change Loftus Street from One-Way restriction to Two-Way between Alfred Street and Reiby Place;
- (B) "No Entry Construction Vehicles and Vehicles Under 8.8 Metres Excepted" restriction for northbound access in Loftus Street, north of Reiby Place; and
- (C) Restrict Reiby Place to One-Way westbound between Loftus and Pitt Streets.

It is recommended that the Committee endorse the following reallocation of parking on the eastern side of Loftus Street, Sydney, south of Alfred Street, as;

(D) "No Stopping" between the points 125.6 metres and 151.7 metres.

It is recommended that the Committee endorse the following reallocation of parking on the western side of Loftus Street, Sydney, south of Alfred Street, as;

BACKGROUND

On 4 June 2014, the NSW Government approved the CBD and South East Light Rail (CSELR) project from Circular Quay through the CBD to Kingsford and Randwick via Surry Hills, Moore Park and Kensington. The project commenced construction in the Sydney CBD on 23 October 2015 and will continue until late 2018.

As part of the CSELR, Alfred Street, between George and Loftus Streets, will be permanently closed for the construction of the Circular Quay Light Rail station. In September 2015, Roads and Maritime Services (RMS) declared this section of Alfred Street as a Transitway.

Due to the closure of Alfred Street, parking and traffic in Loftus Street, Pitt Street and Reiby Place are required to change to maintain access and the parking needs of businesses and visitors.

The Development Consent for 13-17 Lachlan Street, Waterloo (D/2015/782) requires the Applicant to deliver a new road known as "Tong Hop Street", between Gadigal Avenue and Lachlan Place. At the completion of the works, the new road will be dedicated to the City as a Shared Zone.

The delivery of the Shared Zone in Tong Hop Street will address Consent Conditions 54 for 13-17 Lachlan Street, Waterloo and must be constructed prior to any Occupation Certificate being issued for the redevelopment.

ITEM 45 TRAFFIC TREATMENT – CONTINUOUS FOOTPATH TREATMENT PEDESTRIAN CROSSING RAISED THRESHOLD AND TIMED PARKING – PRIMROSE AVENUE ROSEBERY (2017/213247)

- (K) Eastern side, between the points 136.6 metres and 155 metres north of Crewe Place, as "No Stopping";
- (L) Southern side, between the points 0 metres and 13 metres west of Rosebery Avenue, as "No Stopping";
- (M) Southern side, between the points 13 metres and 23 metres west of Rosebery Avenue, as "No Parking";
- (N) Southern side, between the points 23 metres and 78 metres west of Rosebery Avenue, as "2P 8am-8pm";
- (O) Southern side, between the points 78 metres and 110 metres west of Rosebery Avenue, as "No Stopping";
- (P) Northern side, between the points 0 metres and 13 metres west of Rosebery Avenue, as "No Stopping";

- (Q) Northern side, between the points 13 metres and 68 metres west of Rosebery Avenue, as "2P 8am-8pm"; and
- (R) Northern side, between the points 68 metres and 110 metres west of Rosebery Avenue, as "No Stopping".

The Development Consent for 25-55 Rothschild Avenue, Rosebery (D/2015/1901) requires the Applicant to deliver a new road extending Primrose Avenue, between Crewe Place and Rosebery Avenue. At the completion of the works, the new road will be dedicated to the City.

The delivery of the new road will address Condition 47(b) for 25-55 Rothschild Avenue, Rosebery. In addition, Condition 48 requires the Applicant to submit a signage plan for kerbside parking and line marking arrangements that is to be referred to the Local Pedestrian, Cycling and Traffic Calming Committee, as part of the dedication of this section of Primrose Avenue as a public road.

- (E) Eastern side of Phillip Street, between the points 15.9 metres and 30.9 metres, as "Loading Zone Ticket 6am-6pm Mon-Fri 6am-10am Sat" and "Taxi Zone Other Times";
- (F) Eastern side of Phillip Street, between the points 46.3 metres and 122.9 metres, as "Loading Zone Ticket 6am-6pm Mon-Fri 6am-10am Sat" and "4P Ticket 6pm-12am Mon-Fri 10am-10pm Sat 8am-10pm Sun & Public Holidays"; and
- (G) The City, in conjunction with TfNSW, to review the provision of parking in Phillip Street, between Hunter and Martin Places, six months after implementation.

DECISION

BACKGROUND

On 19 December 2013, the NSW Government adopted the Sydney City Centre Access Strategy (Access Strategy). The Access Strategy will deliver a fully integrated transport network in Sydney's City Centre that puts the customer first and meets the growing

transport task. It will mean more people use public transport to access the City Centre and it will change the way people move around within it.

The Access Strategy considers all transport modes and demonstrates how light rail, buses, trains, ferries, cars, taxis, pedestrians and cyclists will interact in the heart of Sydney. The Access Strategy also provides a clear direction for how all the different transport modes will work together in the Sydney CBD to reduce congestion, provide for future growth and improve the customer experience.

There is intense competition for use of kerbside space in central Sydney. The narrow streets and short east-west blocks limit the useable kerb space that can be safely allocated to support commercial and transport functions.

As additional commercial, retail and residential floor space is constructed in and near central Sydney, and new precincts are developed, there will be increasing demands on the available kerbside space in the CBD. The consistent management and allocation of kerbside space will ensure the street network can accommodate critical business and local needs, while maintaining the efficient operation of the broader public and private transport networks.
