### **DECISION**

#### **BACKGROUND**

The Development Consent for 43-45 Beaconsfield Street, Beaconsfield (D/2012/342) requires the Applicant to submit a signage plan for kerbside parking arrangements for the site's frontage along Beaconsfield Street, to be referred to the Local Pedestrian, Cycling and Traffic Calming Committee.

## **COMMENTS**

The City has approved the redevelopment of 43-45 Beaconsfield Street, Beaconsfield.

The kerb space on the northern side of Beaconsfield Street, Beaconsfield, between William Street and Queen Street, is mostly unrestricted but contains some spaces that are signposted as "1/4P 9am-5pm Mon-Fri" and a "No Parking" across an old driveway.

It is proposed to update the parking restrictions to reflect the change in adjacent land use. As such, it is proposed to install "2P 8am-8pm" along the frontage of the redevelopment site. This change will replace the existing "1/4 9am-5pm Mon-Fri" restriction and unrestricted kerb space and will comply with City's Neighbourhood Parking Policy which recommends a two-hour parking limit as it better balances the aim of deterring commuter parking with the needs of households for visitors, carers and tradespeople.

One parking space will be signposted as "No Parking" in order to preserve the space until a submission is received by a car share operator. Once a submission is received the "No Parking" space will be reallocated as "No Parking Car Share Vehicles Excepted".

# **CONSULTATION**

The Applicant must notify adjacent properties at least seven days prior to the implementation of the changes.

# **FINANCIAL**

All costs associated with the proposal will be borne by the Applicant.
