RECOMMENDATION

It is recommended that the Committee endorse the reallocation of parking on the western side of Commonwealth Street, Surry Hills between the points 32.7 metres and 38 metres (1 car space) south of Wentworth Avenue, as “2P Ticket 8am-6pm, 4P Ticket 6pm-10pm Mon-Fri, 4P Ticket 8am-10pm Sat-Sun & Public Holidays”.

DECISION

BACKGROUND

The Developer of 46-52 Wentworth Avenue, Surry Hills has requested the extension of the existing 2P/4P ticket restriction in Commonwealth Street across the former driveway of the property.

This would also satisfy Condition 37 of the Development Consent (D/2015/61) which requires the Applicant to submit a signage plan for kerbside parking and line marking arrangements that is to be referred to the Local Pedestrian, Cycling and Traffic Calming Committee.

COMMENTS

The City has approved the redevelopment of 46-52 Wentworth Avenue, Surry Hills.

The kerb space on the western side of Commonwealth Street, between Wentworth Avenue and Goulburn Lane, is currently signposted as “2P Ticket 8am-6pm, 4P Ticket 6pm-10pm Mon-Fri, 4P Ticket 8am-10pm Sat-Sun & Public Holidays” and a short section of “No Parking” across an old driveway.

It is proposed to reallocate the “No Parking” zone across the former driveway to “2P Ticket 8am-6pm, 4P Ticket 6pm-10pm Mon-Fri, 4P Ticket 8am-10pm Sat-Sun & Public Holidays” as per the adjacent kerbspace. This would result in an increase of one parking space for visitors to the area.

CONSULTATION

Consultation with the affected stakeholders was undertaken as part of the Development Application process for 46-52 Wentworth Avenue, Surry Hills.

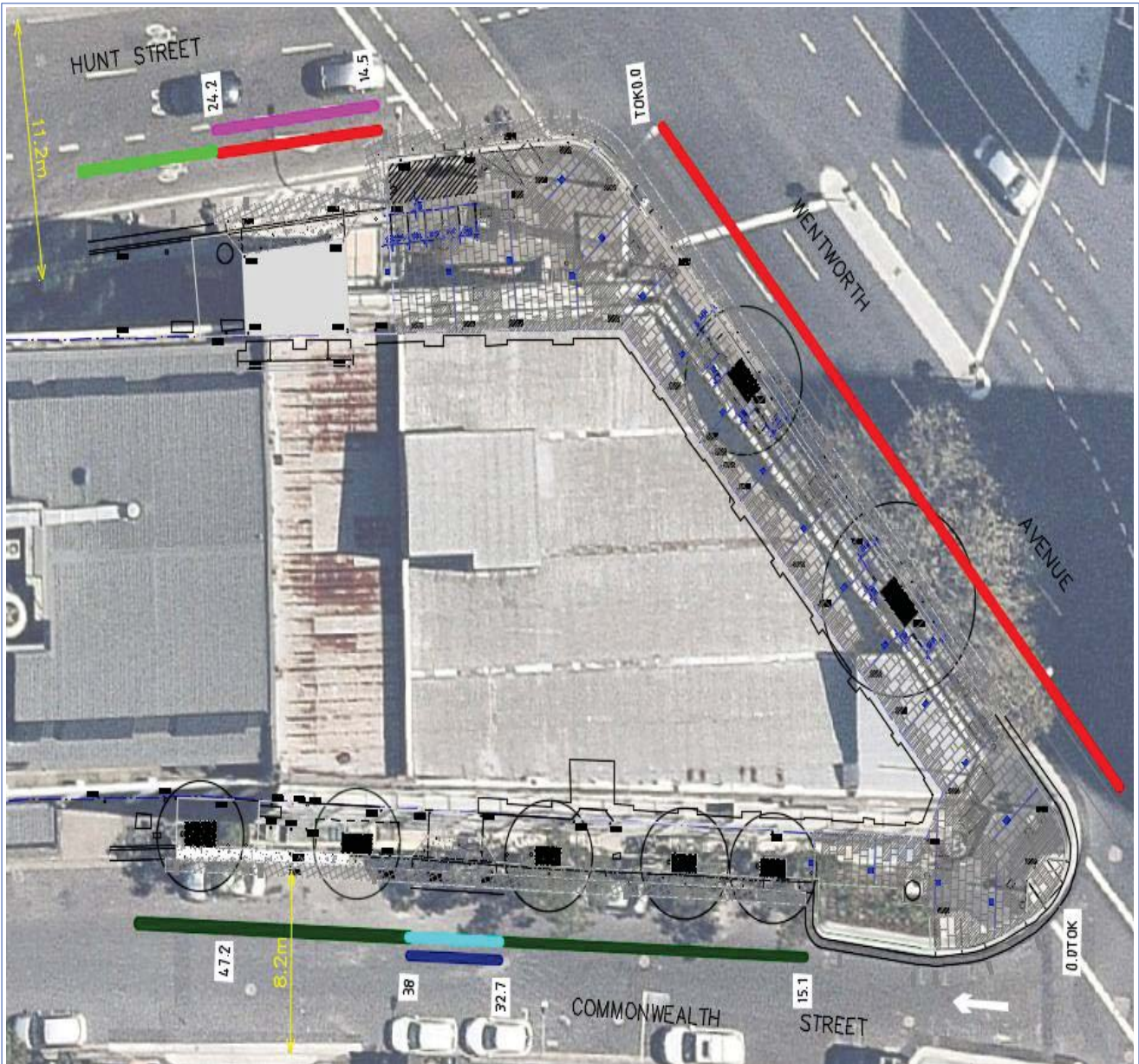
FINANCIAL
