

**ITEM 38. PARKING – TIMED PARKING – MCELHONE STREET

**RECOMMENDATION**

It is recommended that the Committee endorse the following reallocation of parking on the western side of McElhone Street, Woolloomooloo, south of Reid Street as:

- (A) “1/4P 8.30am-6pm Mon-Fri SDN Children’s Services Vehicles Excepted” between the points 10 metres and 22 metres (two car spaces); and
- (B) “1/4P 8.30am-6pm Mon-Fri” between the points 22 metres and 42.5 metres (three car spaces).

**DECISION**

**BACKGROUND**

SDN Children’s Services has requested consideration of dedicated on-street parking for their vehicles in McElhone Street, Woolloomooloo, to support operations at the SDN Woolloomooloo Children's Education and Care Centre.

**COMMENTS**

The five on-street parking spaces outside the SDN Woolloomooloo Children's Education and Care Centre on the western side of McElhone Street, Woolloomooloo, is currently signposted as “1/4P 8.30am-5pm Mon-Fri”.

On-site inspection shows there is a need to extend the 1/4P restriction from 5pm to 6pm and allocate two of the 1/4P parking spaces to exempt SDN Children’s Services vehicles to support operations at the SDN Woolloomooloo Children's Education and Care Centre.

SDN Children’s Services is a not for profit organisation that provides early childhood education and child care, and disability and family support services. The SDN Woolloomooloo Children's Education and Care Centre has no off-street parking.

**CONSULTATION**

The City originally consulted on a proposal to reallocate two of the 1/4P parking spaces to “No Parking SDN Children’s Services Vehicles Excepted”. There were 177 letter sent out

with no responses supporting the proposal and one response opposing the proposal due to the loss of the two 1/4P pick-up and drop-off spaces.

The proposal was amended to extend the 1/4P restriction from 5pm to 6pm and allocate two of the 1/4P parking spaces to exempt SDN Children's Services vehicles. The amended proposal was supported by SDN Children's Services.

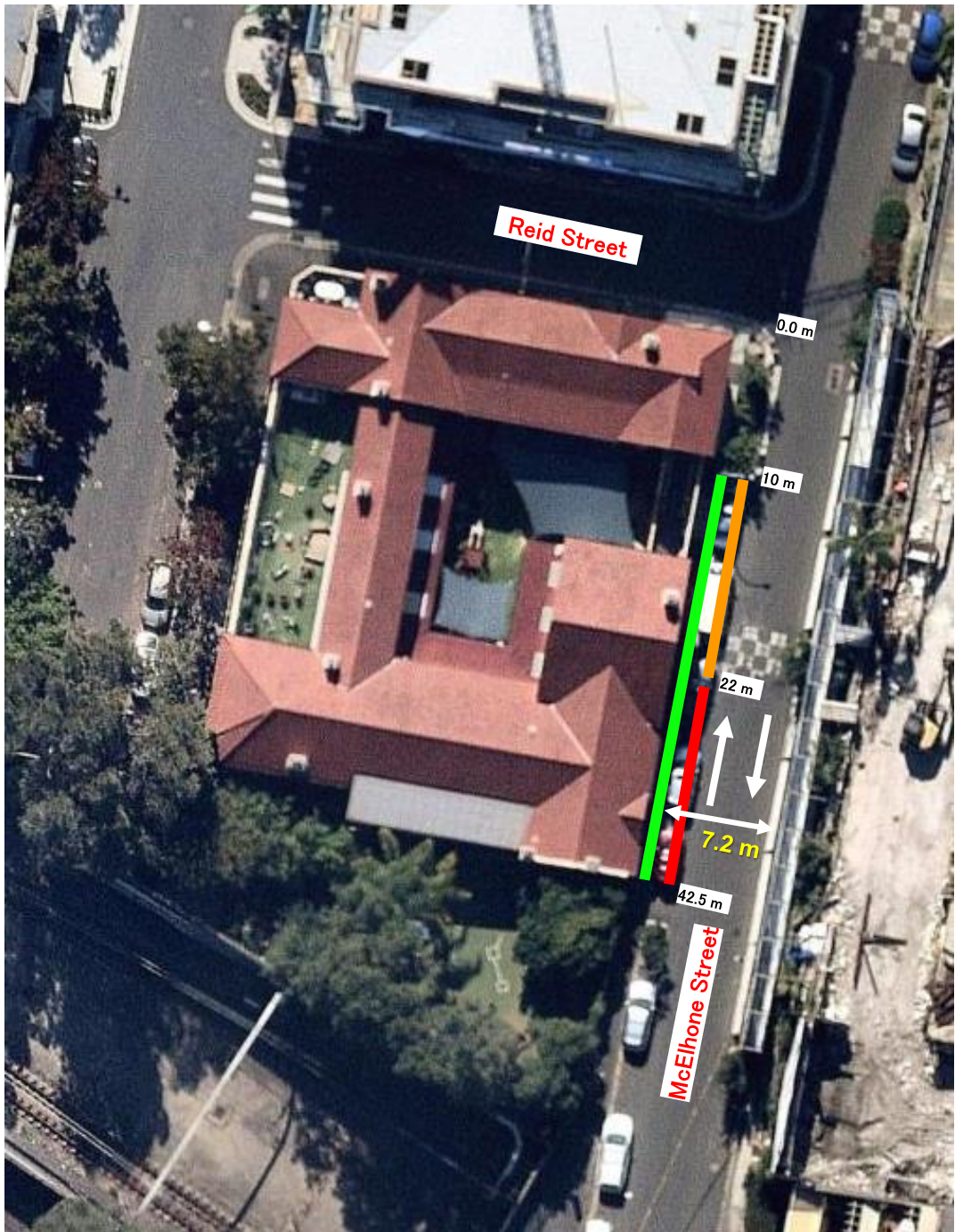
