

ITEM 10. MOBILE CRANES – TEMPORARY ROAD CLOSURES – BUTT STREET SURRY HILLS

RECOMMENDATION

It is recommended that the Committee endorse the temporary road closure of Butt Street, Surry Hills, between Elizabeth and Clisdell Streets on Thursday 2 November, Monday 6 November, Wednesday 8 November 2017 from 7:30am to 5:30pm, and Saturday 4 November from 7.30am to 3.30pm, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as mentioned in Schedule B of this Agenda.
- (B) The Applicant must comply with any other conditions imposed by City's Construction Regulation Unit.
- (C) The Applicant has indicated Friday 10 November, Monday 13 November, Wednesday 15 November and Friday 17 November 2017 as alternative dates in case of inclement weather.
- (D) The Applicant must contact Surry Hill Police to discuss deployment of user pay police for the road closure.
- (E) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to commencement of works.
- (F) The Applicant must provide a telephone number of the supervisor responsible for the proposed closure and include contact details in the notification letters to be distributed to affected stakeholders.

DECISION

BACKGROUND

At the 20 September 2017 meeting of the Local Pedestrian, Cycling and Traffic Calming Committee (LPCTCC), the Committee endorsed:

- the temporary closure of Butt Street Surry Hills, between Elizabeth and Clisdell Streets, on Thursday 5 October, Monday 9 October and Wednesday 11 October 2017 from 7:30am to 5:30pm, and Saturday 7 October 2017 from 7:30am to 3:30pm; and

- alternative dates in case of inclement weather for the temporary closure on Friday 13 October, Monday 16 October, Wednesday 18 October and Friday 20 October 2017.

The Applicant has advised that the temporary road closure could not be carried out on the approved and alternative dates. As such, the Applicant is seeking approval for the temporary road closure to be rescheduled to:

- Thursday 2 November, Monday 6 November, Wednesday 8 November 2017 from 7:30am to 5:30pm, and Saturday 4 November from 7.30am to 3.30pm; and
- alternative dates in case of inclement weather on Friday 10 November, Monday 13 November, Wednesday 15 November and Friday 17 November 2017.

COMMENTS

The proposed temporary road closure is required to allow a mobile crane to install hoarding in Butt Street.

The Applicant has provided a site-specific Traffic Control Plan that includes details of barricades, signs, flagmen and other traffic devices to implement the proposed road closure.

The temporary road closure will not affect any other properties, as local access will be provided at all times and alternative access routes are available nearby.

A Traffic Management Plan (TMP) for the temporary road closure was approved by Roads and Maritime Services (RMS).

CONSULTATION

The Applicant will be required to notify affected stakeholders as stipulated in Schedule B.

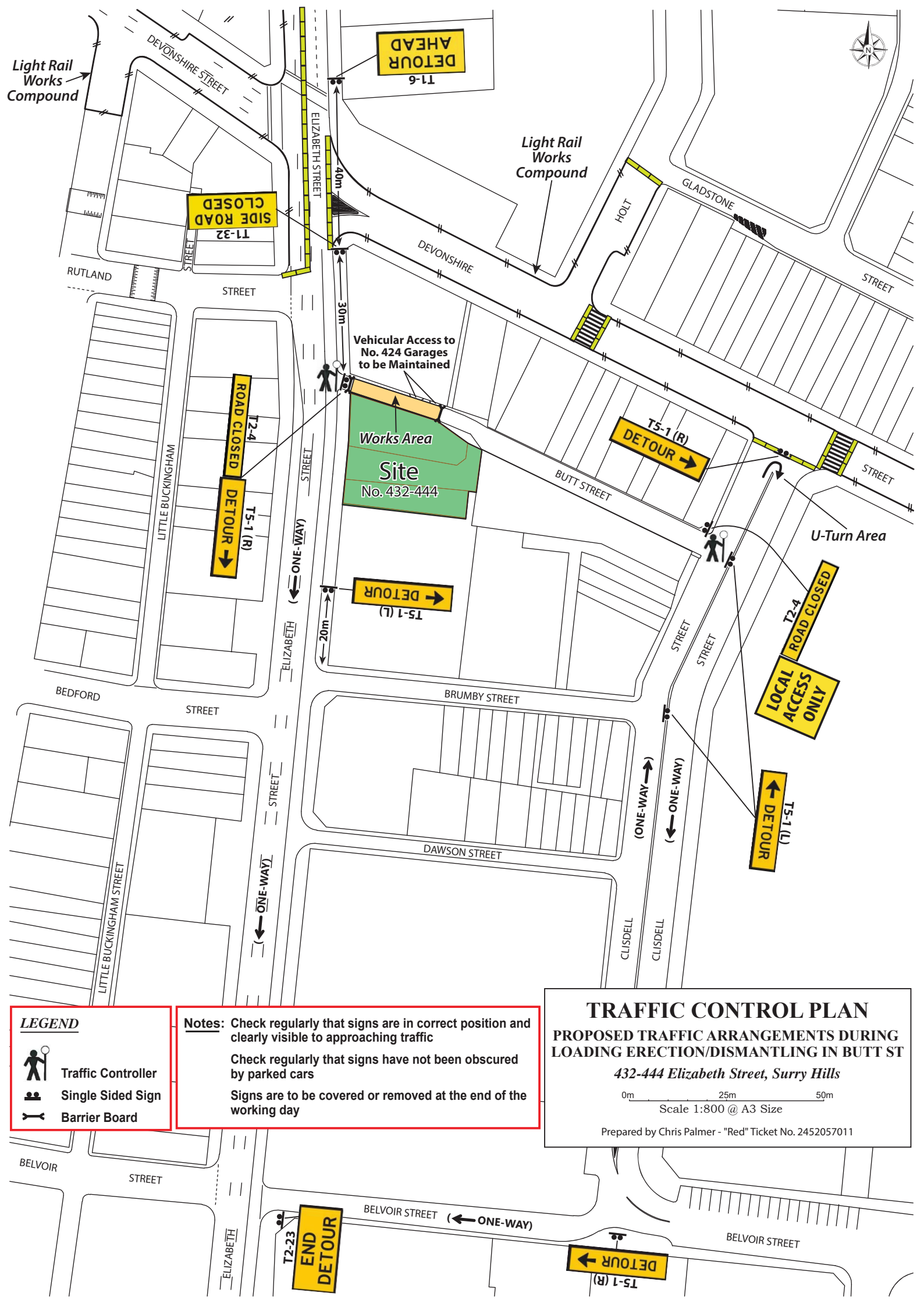
FINANCIAL
