The Access Strategy considers all transport modes and demonstrates how light rail, buses, trains, ferries, cars, taxis, pedestrians and cyclists will interact in the heart of Sydney. The Access Strategy also provides a clear direction for how all the different transport modes will work together in the Sydney CBD to reduce congestion, provide for future growth and improve the customer experience.

There is intense competition for use of kerbside space in central Sydney. The narrow streets and short east-west blocks limit the useable kerb space that can be safely allocated to support commercial and transport functions.

As additional commercial, retail and residential floor space is constructed in and near central Sydney, and new precincts are developed, there will be increasing demands on the available kerbside space in the CBD. The consistent management and allocation of kerbside space will ensure the street network can accommodate critical business and local

needs, while maintaining the efficient operation of the broader public and private transport networks.



ITEM 51 MATTERS RAISED – BAYSWATER ROAD TOW AWAY ZONES

In February 2014, the Committee unanimously endorsed a "Transport Zone" trial in Bayswater Road between Darlinghurst Road and Ward Avenue, Potts Point on Saturday 22 and Saturday 29 March and Saturday 5 April 2014 from 9pm to 6am.

The trial involved the installation of designated tow-away areas in both Bayswater Road and Ward Avenue to deter illegal parking.

Following the trial, the tow-away signs have remained in both Bayswater Road and Ward Avenue and the representative from Kings Cross LAC is concerned about the legitimacy of the designated "Tow-Away Area" given the trial concluded in April 2014.

The Committee noted the concern and recommended that representatives from Kings Cross LAC, Roads and Maritime Services, Sydney Coordination Office and the City of Sydney work collaboratively to confirm the legitimacy of the designated "Tow-Away Area" in both Bayswater Road and Ward Avenue.
