

**ITEM 28. PARKING – DISABILITY PARKING – MOORE PARK ROAD  
CENTENNIAL PARK**

**RECOMMENDATION**

It is recommended that the Committee endorse the reallocation of parking on the southern side of Moore Park Road, Centennial Park, as follows:

- (A) Between points 86.5 metres and 94.3 metres (one car space) west of Cook Road, as “1P 8am-10pm, Permit Holders Excepted Area 13”; and
- (B) Between points 94.3 metres and 102.1 metres (one car space) west of Cook Road, as “Disability Parking Only”.

**DECISION**

**BACKGROUND**

In response to a resident’s request, it is proposed to relocate the existing disability parking space on the southern side of Moore Park Road, Centennial Park, between Cook and Poate Roads, a few metres west to provide better access to the space.

**COMMENTS**

The kerb space on the southern side of Moore Park Road, Centennial Park is signposted with an existing disability parking space. The kerb space to the west of this disability parking space is currently signposted as “1P 8am-10pm; Permit Holders Excepted Area 13” while the kerb space to the east of the disability space is unrestricted.

The current disability parking space is located adjacent to a tree which restricts access for the resident who uses this space. Relocating the disability space to the west of the tree, in lieu of part of the existing “1P 8am-10pm, Permit Holders Excepted Area 13”, will improve access to the space. An additional 1 hour permit parking space will be provided to ensure no overall loss to the number of permit spaces in this section of Moore Park Road.

The Australian Standard for on-street disability parking (AS 2890.6 – 2009) requires the provision of a 3.2 metre wide by 7.8 metre long bay.

A 7.8 metre long bay is proposed and considering the width of the parking lane in Moore Park Road, a 3.2 metre wide bay can be accommodated within the carriageway.

Although the resident is not wheelchair-bound and kerb ramps are not necessary, the City will investigate installing ramps at this site should the proposal be endorsed.

**CONSULTATION**

The City consulted local residents and businesses in the area. There were 33 letters sent out with no responses supporting or opposing the proposal.

**FINANCIAL**

Funds are available in the current budget.
