On 19 December 2013, the NSW Government adopted the Sydney City Centre Access Strategy (Access Strategy). The Access Strategy will deliver a fully integrated transport network in Sydney's City Centre that puts the customer first and meets the growing transport task. It will mean more people use public transport to access the City Centre and it will change the way people move around within it.

The Access Strategy considers all transport modes and demonstrates how light rail, buses, trains, ferries, cars, taxis, pedestrians and cyclists will interact in the heart of Sydney. The Access Strategy also provides a clear direction for how all the different transport modes will work together in the Sydney CBD to reduce congestion, provide for future growth and improve the customer experience.

There is intense competition for use of kerbside space in central Sydney. The narrow streets and short east-west blocks limit the useable kerb space that can be safely allocated to support commercial and transport functions.

As additional commercial, retail and residential floor space is constructed in and near central Sydney, and new precincts are developed, there will be increasing demands on the available kerbside space in the CBD. The consistent management and allocation of kerbside space will ensure the street network can accommodate critical business and local

BACKGROUND

On 18 October 2017, the Local Pedestrian, Cycling and Traffic Calming Committee (LPCTCC) endorsed the provision of a Works Zone in Bulwara Road, Ultimo, to facilitate construction at 485-521 Harris Street for a period of approximately 52 weeks.

Since the LPCTCC endorsement, the City has received multiple representations against the proposed Works Zone from the local community.

On 1 December 2017, representatives from Council and the City met with local residents in Bulwara Road to further discuss the proposal. A summary of the issues raised is provided below:

- Bulwara Road is a local street predominantly used for local residential access while Harris Street is a State Road that has been designed to accommodate higher traffic volumes and larger vehicles;
- Bulwara Road comprises narrow footpaths which leads to some pedestrians walking within the road carriageway between William Henry and Quarry Streets – this issue has been exacerbated given that the hoarding for the redevelopment of 485-521 Harris Street has temporarily closed the eastern footpath of Bulwara Road immediately adjacent to the site;

- Bulwara Road is used as a walking route, including by school children, to and from Ultimo Public School, as well as Ultimo Community Centre, the Kindy Patch Ultimo Early Education Centre, and Quarry Green;
- Bulwara Road in the vicinity of Quarry Street and Quarry Green is a "Shared Zone" with a posted speed limit of 10km/h where pedestrians have priority over traffic this is not a space for construction traffic to safely mix with pedestrians and cyclists; and
- Given that the redevelopment of 485-521 Harris Street is already supported by a Works Zone along the Harris Street frontage, the construction methodology could be amended to build from Harris Street only thereby negating the need for the proposed Works Zone in Bulwara Road

COMMENTS

Following consideration of the community's concerns, the City has decided to put forward a proposal to not proceed with the installation of the proposed Works Zone in Bulwara Road.

The Applicant, Parkview Constructions Pty Ltd, was informed of the City's proposal not to proceed with the proposed Works Zone on 8 December 2017.



The Applicant has advised that the temporary road closure could not be carried out on the approved and alternative dates. As such, the Applicant is seeking approval for the temporary road closure to be rescheduled to Saturday 13 January 2018 and Sunday 14 January 2018 inclusive.

COMMENTS

The proposed temporary road closure is required to allow a mobile crane to remove an on-site tower crane at 960 Ebsworth Street, Zetland.

The Applicant has provided a site-specific Traffic Control Plan that includes details of barricades, signs, flagmen and other traffic devices to implement the proposed road closure.

There are currently no other approved temporary road closures proposed to take place on the same day in close proximity of this closure.

The temporary road closure will not affect any other properties, as local access will be provided at all times and alternative access routes are available nearby.





RECOMMENDATION

It is recommended that the Committee endorse the temporary road closure of Parker Street, Haymarket, between Hay and Barlow Streets, on Sunday 4 February 2018 from 2am to 8pm, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as mentioned in Schedule B of this Agenda.
