CENTENNIAL PARK – ELECTRIC GARDENS MUSIC FESTIVAL 2018**

**RECOMMENDATION**

It is recommended that the Committee note the temporary road closure of Moore Park Road, Centennial Park at Oxford Street for the Electric Gardens Music Festival held on Saturday 27 January 2018 from 9pm to 11pm subject to the following conditions:

- (A) The Applicant complied with the temporary road closure conditions as stipulated in Schedule A of this agenda.
- (B) The Applicant contacted the Surry Hills Police to discuss deployment of user pay police for the event.
- (C) The Applicant contacted the City’s Venue Management Unit to discuss the event.
- (D) The Applicant obtained a Road Occupancy Licence from the Transport Management Centre prior to commencement of the event.
- (E) The Applicant provided a telephone number of the supervisor responsible for the event and included contact details in the notification letters distributed to affected stakeholders.
- (F) This temporary road closure was activated only if it was deemed necessary by the NSW Police for the safe egress of the event crowd.
- (G) The Traffic Management and Traffic Control Plans were agreed to ‘in principle’ and finalised through a Working Group established by the Event Organiser. The Working Group comprised of representatives from NSW Police, Transport for NSW (Transport Management Centre), State Transit Authority, the City, Centennial Park and Moore Park Trust and Event Organisers.

**DECISION**

The Committee carried the recommendation unanimously out-of-session on 19 December 2017.

**BACKGROUND**

Event Services International Pty Ltd applied on behalf of the event organiser (T1000 Productions) for the temporary road closure of Moore Park Road, Centennial Park at

Oxford Street for the 2018 Electric Gardens Music Festival, held on Saturday 27 January 2018 from 9pm to 11pm.

### **COMMENTS**

Electric Gardens Music Festival is an annual event that requires the closure of City Streets and detours around the event location.

Vehicles travelling westbound towards Moore Park Road were diverted to stay on Oxford Street to travel towards the City and then south onto South Dowling Street. Vehicles travelling eastbound on Moore Park Road were able to proceed through to the intersection of Oxford Street only under the direction of NSW Police.

VMS messaging was implemented on Cleveland Street, Flinders Street and Anzac Parade to notify drivers of delays and detours.

### **Temporary Road Closures – Saturday 27 January 2018, 9pm to 11pm**

- The westbound traffic lanes on Moore Park Road at Oxford Street

There were no other approved temporary road closures in the area on the same day. The City has not received any traffic related complaints about temporary road closures in Moore Park Road in previous years.

### **CONSULTATION**

The Applicant was required to notify affected residents and stakeholders as stipulated in Schedule A.

### **FINANCIAL**

All costs associated with the proposed closures were borne by the Applicant.
