

**ITEM 25. PARKING – AUTHORISED PARKING – ALBERT AND REDFERN
STREETS REDFERN**

RECOMMENDATION

It is recommended that the Committee endorse the reallocation of parking at the following locations:

- (A) Southern side of Redfern Street, Redfern between the points 39.2 metres and 57.2 metres (three car spaces) west of Pitt Street, as “No Parking 8am-8pm, Mon-Fri; Health Department Vehicles Excepted”; and
- (B) Southern side of Albert Street, Redfern between the points 10 metres and 28 metres (three car spaces) west of Pitt Street, as “2P 8am-8pm; Permit Holders Excepted Area 41”.

DECISION

BACKGROUND

The Sydney South West Area Health Service – NSW Government has requested the relocation of the existing “No Parking 8am-8pm, Mon-Fri; Health Department Vehicles Excepted” from Albert Street, Redfern to a location outside their new property in Redfern Street, Redfern.

COMMENTS

The kerb space on the southern side of Albert Street, Redfern between Pitt and George Streets, is partly signposted as “No Parking 8am-8pm, Mon-Fri; Health Department Vehicles Excepted”. These dedicated parking spaces, ie three car spaces in length, were provided outside the Health Department Office to ensure convenient short-term access for their operations. The rest of Albert Street is signposted as “2P 8am-8pm; Permit Holders Excepted Area 41”.

The Sydney South West Area Health Service has recently relocated its premises from Albert Street to Redfern Street. Therefore the existing authorised parking spaces in Albert Street should also be relocated to Redfern Street outside the new premises.

The kerb space on the southern side of Redfern Street, between Pitt and George Streets, is currently signposted as “1P Ticket 8am-6pm, Mon-Fri” and “4P Ticket 8am-6pm, Sat-

Sun and Public Holidays". The dedicated parking for Health Department Vehicles would replace three of the above ticket parking spaces.

The kerbspace in Albert Street would be replaced with 2P permit parking similar to the adjacent kerbspace which should improve access to parking for residents.

CONSULTATION

The City consulted local residents and businesses in the area. There were 385 letters sent out with no responses supporting or opposing the proposal.

FINANCIAL

Funds are available in the current budget.
