

**ITEM 30. PARKING – LOADING ZONE AND TICKET PARKING – MARY STREET SURRY HILLS**

**RECOMMENDATION**

It is recommended that the Committee endorse the reallocation of parking in Mary Street, Surry Hills as follows:

- (A) Eastern side, between the points 20.6 metres and 30.9 metres (two car spaces) north of Foveaux Street, as “Loading Zone Ticket 8am-6pm, Mon-Fri” and “4P Ticket 6pm-10pm, Mon-Fri; 8am-10pm, Sat, Sun & Public Holidays”;
- (B) Eastern side, between the points 48.1 metres and 103.1 metres (13 car spaces) north of Foveaux Street, as “2P Ticket 8am-6pm Mon-Fri” and “4P Ticket 6pm-10pm, Mon-Fri; 8am-10pm, Sat, Sun & Public Holidays”;
- (C) Eastern side, between the points 154.9 metres and 167.3 metres (two car spaces) north of Foveaux Street, as “2P Ticket 8am-6pm Mon-Fri” and “4P Ticket 6pm-10pm, Mon-Fri; 8am-10pm, Sat, Sun & Public Holidays”; and
- (D) Western side, between the points 16.8 metres and 64.4 metres (eight car spaces), 90.8 metres and 103.1 metres (two car spaces), and between 127.5 metres and 158.2 metres (five car spaces) north of Foveaux Street, as “2P Ticket 8am-6pm Mon-Fri” and “4P Ticket 6pm-10pm, Mon-Fri; 8am-10pm, Sat, Sun & Public Holidays”.

**DECISION**

**BACKGROUND**

The City has reviewed parking restrictions in the vicinity of Foveaux Street, Surry Hills and identified locations that need to be updated in accordance with the City’s Neighbourhood Parking Policy and to align with other restrictions in the immediate area.

This proposal includes updating the parking restrictions in Mary Street, between Albion and Foveaux Streets.

Additionally, a business in Mary Street has requested consideration for installing a Loading Zone to improve local servicing operations.

## **COMMENTS**

The majority of the kerbspace on both sides of Mary Street, Surry Hills, between Albion and Foveaux Streets, is signposted as ticket parking with various time limits such as 1/2P, 4P and 1P. It is proposed to update the existing ticket parking to “2P Ticket 8am-6pm, Mon-Fri” and “4P Ticket 6pm-10pm, Mon-Fri; 8am-10pm, Sat, Sun & Public Holidays” to be consistent with nearby ticket parking restrictions and to better service the needs of the adjacent land use.

The kerb space on the eastern side of Mary Street, Surry Hills, where the Loading Zone is proposed, is currently signposted as “No Parking 8.30am-6pm, Mon-Fri”. The existing “No Parking” zone is not being used appropriately for set-down purposes and can be better utilised as a Loading Zone.

It is therefore proposed to install a “Loading Zone Ticket 8am-6pm, Mon-Fri” and “4P Ticket 6pm-10pm, Mon-Fri; 8am-10pm, Sat, Sun & Public Holidays” in this location to improve on-street servicing operations.

The proposed parking changes will align with other restrictions in the immediate area and improve compliance for all road users.

## **CONSULTATION**

The City consulted local residents and businesses in the area. There were 101 letters sent out with no responses supporting or opposing the proposal.

## **FINANCIAL**

Funds are available in the current budget.
