



## Hours of operation and noise


- initial proposal 7am to 12 midnight, Monday to Sunday
- subject proposal 7am to 10pm, Monday to Sunday
- expected that it will not operate to 10pm every night
- conditions for outdoors hours 8pm to 10pm subject to one year trial
- Plan of Management incorporates noise complaints handling process

### Licensed activities

- community facility is permitted in the Zone R1 General Residential
- activities held in the community facility may serve alcohol
- licensing arrangements are a matter for Liquor and Gaming NSW

#### Waste management

• waste storage area adjacent to Rose Lane is an existing arrangement



#### Waste management

- conditions recommended restrict waste collection hours in accordance with the City's Waste Management Local Approvals policy
  - 6am to 10pm Monday to Friday
  - 8am to 10pm weekends and public holidays
