Variation – Bulky Organics and Cleansing Waste Processing

This memo is for the information of the Lord Mayor and Councillors.

Purpose

Provide clarification for 3-year term of the contract extension requested and additional information regarding other waste processing services not directly related to this contract.

Background

At the meeting of the Corporate, Finance, Properties and Tenders Committee on 9 December 2024, further information was sought on the following:

Term of contract extension and other details

Complex contracts that require transfer and processing of multiple material streams can require longer lead times. Typically for this type of contract staff would commence market research and early tender document drafting approximately 12 months out from contract start. This allows time for document assembly for each stream and review of available suppliers, legal review of tender documents and contract, internal review and approvals, tenders or quotes out to market and evaluation, potential negotiations and contract transition.

Extending the current contract by 2 years will result in staff restarting the process of market analysis and tender document preparation within one year of the contract extension. It is not anticipated that any meaningful new processing facilities will be established during the extended contract period.

Additionally, the requested extension period will accommodate the 12-month insect processing trial scheduled to start in January 2025 and allow adequate time for evaluation and future service planning prior to the preparation of tender requirements for the next contract.

The contracts do not require the City to deliver minimum tonnages to any of the processing facilities.

Further information was also requested regarding other waste related contracts managed by the City, namely, who we have contracts with, how long the contracts are for, details of any extensions and information regarding relevant awards or enterprise agreements our suppliers have with their staff.
