Purpose

To provide an Alternative Recommendation that makes amendments to the draft Grants Guidelines proposed for public exhibition.

Background

Following publication of the draft Grants Policy and Guidelines, it was identified that due to an administrative error some changes had not been incorporated into the version published in the Committee papers and amendments were required to the draft Grants Guidelines proposed for exhibition.

General exclusions and ineligibility

Insertion of the below clause into the 'General exclusions and ineligibility' section is required.

 appear to be associated with a previous Recipient or grants project that didn't comply with their contractual obligations or complete the grants project satisfactorily

This clause reflects a similar clause in the current Grants Guidelines and was omitted in error.

Table of eligible entities

The table of eligible entities has been reviewed and updated to clarify the nature of entities eligible for grants and reflect the Glossary in the Guidelines to enable better readability and understanding of eligibility requirements.

Note that the draft Grants Policy and Guidelines will be reviewed prior to exhibition, with minor editorial amendments for clarity or correction of drafting errors made as required.
