- 3. Note that there is a three minute time limit for each speaker (with a warning bell at two minutes) and prepare your presentation to cover your major points within that time
- 4. Avoid repeating what previous speakers have said and focus on issues and information that the Committee may not already know.
- 5. If there is a large number of people interested in the same item as you, try to nominate three representatives to speak on your behalf and to indicate how many people they are representing.
- 6. Before speaking, turn on the microphone by pressing the button next to it and speak clearly so that everyone in the Council Chamber can hear.
- 7. Be prepared to quickly return to the microphone and respond briefly to any questions from Councillors, after all speakers on an item have made their presentations.

Committee meetings can continue until very late, particularly when there is a long agenda and a large number of speakers. This impacts on speakers who have to wait until very late, as well as Council staff and Councillors who are required to remain focused and alert until very late. At the start of each Committee meeting, the Committee Chair may reorder agenda items so that those items with speakers can be dealt with first.

## Grants and Sponsorship - Round Three 2018/19 - Environmental Grants - Environmental Performance Grants

## **Summary**

The City of Sydney's Grants and Sponsorship Program supports initiatives and projects that build the social, cultural, environmental and economic life of the city. To achieve the objectives of Sustainable Sydney 2030 requires genuine partnership between government, business and the community.

The provision of grants and sponsorships is a mechanism to further the aims identified in the City's social, economic and environmental policies. Applications are assessed against these policies and against broad City objectives and plans. In this way, the City and the community act collaboratively to bring to life Sustainable Sydney 2030 and the City of Villages it envisions.

The City advertised the following three environmental grant programs in Round Three of the annual grants and sponsorship program for 2018/19:

- Environmental Performance Building Operations: funding is available to help lower the costs of implementing building operations efficiency measures;
- Environmental Performance Ratings and Assessments: funding is available to undertake building performance ratings and certifications, energy audits and assessments to enable a building or facility owner to understand their opportunities to improve environmental performance; and
- Environmental Performance Innovation: funding is available to assess or demonstrate new technologies or processes that are currently not being implemented in the local market, but have the potential to achieve greenhouse gas emissions reductions and resource efficiencies that could be rolled out at scale within the local area.

For the Environmental Performance Grants, 43 eligible applications were received. This report recommends a total of 36 grants to a total value of \$400,588 for the 2018/19 financial year and \$19,000 for the 2019/20 financial year.

On 11 December 2017, Council adopted a revised Grants and Sponsorship Policy. All grants in this report were assessed against criteria and guidelines set out in this policy, with reference to Sustainable Sydney 2030, Environmental Action 2016-2021 Strategy and Action Plan, and Residential Apartments Sustainability Plan.

All grant recipients will be required to sign a contract, meet specific performance outcomes and acquit their grant.

All cash figures in this report exclude GST.

### Recommendation

It is resolved that:

- (A) Council approve the cash recommendation for the Environmental Performance Building Operations Grant Program as per Attachment A to the subject report;
- (B) Council approve the cash recommendations for the Environmental Performance Ratings and Assessment Grant Program as per Attachment B to the subject report;
- (C) Council approve the cash recommendations for the Environmental Performance Innovation Grant Program as per Attachment D to the subject report;
- (D) Council note that all grant amounts are exclusive of GST; and
- (E) authority be delegated to the Chief Executive Officer to negotiate, execute and administer agreements with any organisation approved for a grant or sponsorship under terms consistent with this resolution and the Grants and Sponsorship Policy.

## **Background**

- 1. The City of Sydney's Grants and Sponsorship Program supports residents, businesses and not-for-profit organisations to undertake initiatives and projects that build the social, cultural, environmental and economic life of the city.
- 2. On 23 October 2018, the City announced Round Three of the annual grants program for 2018/19 as being open for applications on the City's website, with grant applications closing on 20 November 2018.
- 3. The three environmental programs promoted were:
  - Environmental Performance Building Operations;
  - Environmental Performance Ratings and Assessments; and
  - Environmental Performance Innovation.
- 4. Information about these grant programs (such as application dates, guidelines, eligibility criteria and sample applications) was made available on the City's website. The City actively promoted the programs through Facebook, Twitter, What's On and Google AdWords. Email campaigns were also utilised to target interested parties who have applied previously for grants at the City or who have expressed an interest in the City's programs. The grants were also promoted to peak industry organisations, networks and stakeholders.
- 5. The three Environmental Performance programs are open to appropriately incorporated for-profit organisations. Fifteen applications were received this round from for-profit organisations. Eleven of these for-profit organisations are recommended in this report:
  - Ambadell Pty Ltd;
  - Blocktexx Pty Ltd;
  - Borstream Pty Ltd;
  - Hive Empire Pty Ltd;
  - Infoactiv Australia Pty Ltd;
  - Knight Frank Australia Pty Ltd;
  - Lilyvale Hotel Pty. Ltd;
  - Mulpha Hotel Operations Pty Ltd;
  - Vicinity Centres Pm Pty Ltd;
  - Watt Solutions Monitoring Pty. Ltd; and
  - Winadell Pty. Ltd.

- 6. The three environmental performance grant programs aim to build capacity and address barriers to the implementation of environmental actions within key customer sectors.
- 7. The assessment panels for applications received under the Environmental Performance Grants Program comprised the Sustainability Engagement Managers, Manager Carbon Strategy, Waste Strategy Manager, Environmental Projects Officer, Sustainability Engagement Coordinator, Sustainability Engagement Coordinator Cityswitch, Sustainability Engagement Coordinator Building Tune-Up, Sustainability Programs Coordinator Better Buildings Partnership, and Sustainability Engagement Officer.

## **Environmental Performance - Building Operations Grant Program**

- 8. The Environmental Performance Building Operations Grant Program aims to improve the environmental performance of buildings by lowering the costs and mitigating the barriers of implementing building efficiency measures, such as water monitoring in residential apartments.
- 9. One application has been received and assessed. It is recommended for support to a value of \$10,000. Strata Plan 69567 are committed to installing sub water meters in seven buildings as water use has increased 49 per cent across the whole complex over the past three years.

## **Environmental Performance - Ratings and Assessments Grant Program**

- 10. The Environmental Performance Ratings and Assessments Grant Program aims to address barriers to the uptake of building performance ratings and assessments across energy, water, waste and other sustainability aspects. Ratings and assessments enable a building owner or facility manager to understand their building's environmental performance and to identify efficiency opportunities. Applicants are required to implement efficiency measures based on the recommendations of the assessments.
- 11. Thirty-three applications have been received and assessed, the highest number for this program to date. Thirty-one are recommended for support to a value of \$274,878. There has been a substantial increase in the number of assessments received with the majority of applications for single buildings reflecting the marked increase in the number of applications from the residential sector, as well as applications from previously not recommended applicants. There were a small number of single applications received for a portfolio of buildings, as well as sustainability consultant service providers promoting their services together with the City grant program to their clients.

## **Environmental Performance - Innovation Grant Program**

- 12. The Environmental Performance Innovation Grant Program supports the feasibility or demonstration of new technologies or processes that are currently not being implemented in the local market, but have the potential to achieve greenhouse gas emissions reductions and resource efficiencies that could be rolled out at scale within the local area. Nine applications have been received and assessed. Four are recommended for support to the value of \$134,710.
  - (a) Blocktexx Pty Ltd is aiming to reduce clothing waste caused by fast fashion by using separation technology to reduce unwanted clothing down to their original fibres ready for reuse in new textiles to create uniforms for the Sydney Opera House.

- (b) CJ & SL Warren has partnered with Amora Hotel Jamison Sydney to engage and educate hotel guests and staff about saving water, energy and waste by using a scientifically verified system of monitoring, forecasting and feedback. They intend to share outcomes with the industry via events supported by the City of Sydney's Sustainable Destination Partnership.
- (c) Infoactiv Australia Pty Ltd will help achieve the goals of Sustainable Sydney 2030 zero waste strategy through the Ecoactiv platform. It digitises and controls the recycling collective in one central place, removing barriers to recycling by managing the entire process of identification, education, collection, tracking, recycling and reporting of waste.
- (d) The University of Technology, through the design and fabrication of a new invention called the Green Wall-bot, is aiming to increase the life and health of 'green walls' by using the wall-bot prototype to seed, weed and maintain the walls. This technology will significantly reduce maintenance costs and overcome OHS issues, and will lead to an increase of green-walls, biodiversity and infrastructure.
- 13. The 2018/19 Environmental Performance Program budget is summarised as follows:

14. The Environmental Performance Grant Program opened again for applications in February 2019 for the first round of the 2019/20 financial year.

## **Key Implications**

## **Strategic Alignment - Sustainable Sydney 2030 Vision**

- 15. Sustainable Sydney 2030 is a vision for the sustainable development of the City to 2030 and beyond. It includes 10 strategic directions to guide the future of the City, as well as 10 targets against which to measure progress. This program is aligned with the following strategic directions and objectives:
  - (a) Direction 2 provides a road map for the City to become A Leading Environmental Performer the grant projects recommended in this report will support the City's endeavours to work with our business and residential communities to reduce greenhouse emissions, potable water use and encourage diversion of waste from landfill across the local government area.

## **Organisational Impact**

16. The grants and sponsorships contract management process will involve staff in the City's grants and sustainability teams setting contract conditions and performance measures for each approved project and review project acquittals.

### **Environmental**

17. The recommended environmental grants under the Ratings and Assessments
Program will provide energy and water savings as a result of improved monitoring and
applicants implementing efficiency measures as a condition of the grants.

## **Budget Implications**

18. A total value of \$400,588 in cash is recommended in this report and is above the allocated 2018/19 Environmental Performance Grants budget. Savings were identified within the grants and sponsorship budget as well as in the broader City Life operational budget to respond to the increase in applications. A further amount of \$19,000 is recommended from the draft Environmental Performance Grants budget for 2019/20.

## **Relevant Legislation**

- 19. Section 356 of the Local Government Act 1993 provides that a council may, in accordance with a resolution of the council, contribute money or otherwise grant financial assistance to persons for the purpose of exercising its functions.
- 20. Section 356(3)(a) (d) is satisfied for the purpose of providing grant funding to forprofit organisations because:
  - (a) the funding is part of the Environmental Grants Environmental Performance Grants program;
  - (b) the details of the program have been included in Council's draft operation plan for financial year 2018/2019;
  - (c) the program's budget does not exceed five per cent of Council's proposed income from ordinary rates for financial year 2018/19; and
  - (d) the program applies to a significant group of persons within the local government area.

## **Public Consultation**

- 21. For all programs open to application in Round Three of the annual grants and sponsorship program for 2018/19, one question and answer session was held in Town Hall House to assist potential applicants with their applications on Wednesday 7 November 2018 from 4pm to 7pm.
- 22. Twenty-three meetings were held on the day where prospective applicants sought advice from City staff about their project proposals and the application process.
- 23. Sixty-five per cent of these attendees advised they had not applied for a City of Sydney grant previously.

## **Knowledge Exchange Sponsorship - 1 Million Women Event**

## Summary

An application for sponsorship under the Knowledge Exchange Sponsorship Program has been received from the not-for-profit organisation 1 Million Women Limited to host a one-day public program to mark its 10 year anniversary, on Saturday 25 May 2019 at CarriageWorks.

1 Million Women is a movement of over 800,000 women. Their aim is to empower women and girls to act on climate change, providing them with the tools and inspiration to reduce carbon pollution through everyday actions.

The Sydney event will feature key speakers, panel discussions, workshops, live performances and a marketplace. Attendees will hear from leaders in their field talking about a range of environmental issues, including overconsumption, food waste, climate change and climate justice.

Sponsorship of this event, as well as support of 1 Million Women more broadly, aligns with the City's Environmental Strategy and Action Plan, in particular, the City's target to reduce emissions by 70 per cent based on 2006 levels by 2030. The City recognises that combatting climate change, and meeting the City's ambitious environmental targets, is an issue that requires leadership at all levels. 1 Million Women is a grass roots organisation with a proven track record of community engagement.

The application has been assessed and this reports recommends \$15,000 cash in support of the initiative.

## Recommendation

It is resolved that:

- (A) Council approve a cash sponsorship of \$15,000 (excluding GST) to 1 Million Women Limited for the 1 Million Women 10 Year Anniversary event from the 2018/19 General Contingency Budget; and
- (B) authority be delegated to the Chief Executive Officer to negotiate and enter into a sponsorship agreement with 1 Million Women Limited in respect of the City's sponsorship of this event described in (A) above.

## Background

- 1. 1 Million Women is a movement of over 800,000 women. Their aim is to empower women and girls to act on climate change, providing them with the tools and inspiration to reduce carbon pollution through everyday actions.
- 2. Through online channels (website, social media, app) and offline initiatives (workshops, events) they share information regarding food waste, home energy savings and clean energy options, reducing overconsumption, investing and divestment, sustainable fashion and low-impact travel.
- 3. The event is due to be held at CarriageWorks on Saturday 25 May 2019, marking 10 years of 1 Million Women.
- 4. Approximately 2,000 attendees are expected to attend the one-day event the majority being from the Sydney metropolitan area. Given the location of the event, the organisers anticipate a large cohort from the City's local government area.
- 5. 1 Million Women focus on women as the agents of change and as such, this event will target women. Their research indicates that women make 85 per cent of the consumer decisions that affect a household's carbon footprint and have enormous influence as consumers and through the lifestyle choices they make every day.
- 6. While access to the marketplace component of the event is free, the program of talks and workshops is projected to cost \$20 per person.
- 7. The City will be one of 15 partners, including CarriageWorks, Bank Australia, Australian Ethical, Nissan and KeepCup.
- 8. The one day program includes:
  - (a) key speakers, panel discussions, workshops and live performances;
  - (b) a marketplace with stalls showcasing environmentally friendly products and services;
  - (c) an opportunity for attendees to make a pledge to environmental actions; and
  - (d) an invitation to contribute tips and ideas for reducing carbon pollution, which will be published as an e-book following the event.

Some aspects of the event will be live streamed.

- 9. The outcomes will be evaluated against the following performance criteria:
  - (a) audience participation of 2,000 or more from across inner Sydney and wider Sydney;
  - (b) event activities to facilitate knowledge sharing and inspire action; and
  - (c) post-event community engagement and impact.
- 10. Sponsor benefits include logo recognition, distribution of City of Sydney sustainability materials, an opportunity to draw the winner of the Nissan electric vehicle displayed at the event, an opening address and inclusion in the highlights video package after the event.

- 11. Sustainable Sydney 2030 is a vision for the sustainable development of the City to 2030 and beyond.
