Background

Park Street is a critical bus corridor that services more than 30 routes through the CBD. The location of the bus route provides direct access for customers to the Sydney Light Rail, Town Hall Station and the future Metro Station at Pitt Street.

It has been identified that buses are being severely delayed through Park Street from Castlereagh Street to George Street which is not only impacting on the operation of the bussing operation but also causing overcrowding of pedestrians at the bus stops. The addition of bus priority in lane two on Park Street will provide easy access to the bus stop and a dedicated lane for buses heading westbound through the CBD.

This proposal was part of the Capacity Improvements package (2015) which has been approved through an REF process which included public consultation. With the opening of the light rail and the reduced number of private vehicles in the CBD, it is an appropriate time to implement the final part of this package of works.

The work will be managed by Sydney Coordination and delivered by City of Sydney as part of their re-sheeting program. Installation of the Park Street bus lane would commence in May 2020 and be completed by June 2020.

It has also been determined that under Covid-19 conditions vehicle and pedestrian volumes are significantly reduced which provides good opportunity to implement the proposal and monitor the changes.

Item 26 Matters Raised

Temporary cycleways

The City of Sydney and Transport for NSW will fast-track new walking and riding connections to ensure people can get around the city while maintaining physical distancing.

The roll-out of temporary cycleways will provide an essential transport option for many residents of inner suburbs and reduce crowding on public transport. The first six cycleways to be rolled-at are:

- Pitt Street, between King Street and Reiby Place, CBD;
- Henderson Road, Eveleigh, and Railway Parade/Bridge Street, Erskineville;
- Dunning Ave, Rosebery;
- Moore Park Road and Fitzroy Street, Paddington / Surry Hills;
- Pyrmont Bridge Road, Pyrmont; and
- Sydney Park Road, Erskineville.

An out-of-session endorsement will be sought from the Committee prior to the installation of the temporary cycleways.

Footpath signage to maintain physical distancing

The Representative for Newtown requested information about footpath signage to maintain physical distancing.

The City of Sydney and Transport for NSW (TfNSW) will fast-track new walking and riding connections to ensure people can get around the city while maintaining physical distancing.

As part on these works, the City will work with TfNSW on a communication strategy to remin pedestrians to maintain physical distancing in particular at signalised pedestrian crossings.

Automated pedestrian crossings

The Representative for Newtown requested an update to the request to automate all signalised pedestrian crossings. TfNSW representative advised that any further expansion of the automatic pedestrian introduction would be limited to health precincts to reduce the spread of COVID-19.

BikeSydney suggested a meeting with all relevant stakeholders to discuss the matter. The City of Sydney will organise the meeting.
