The Chief Executive Officer, Chief Operating Officer, Chief Financial Officer, Director City Projects and Property, Director People, Performance and Technology, Director City Services, Director City Planning, Development and Transport, Director Legal and Governance and Director City Life were also present.

#### **Remote Meeting**

The Chair (the Lord Mayor) advised that the meeting of Council was being held via audio visual links, with Councillors (and relevant staff) attending the meeting remotely. This is in accordance with section 747A of the Local Government Act 1993.

#### **Opening Prayer and Acknowledgement of Country**

The Lord Mayor opened the meeting with prayer and an acknowledgement of country.

#### **Webcasting Statement**

The Chair (the Lord Mayor), advised that in accordance with the City of Sydney Code of Meeting Practice, Council meetings are audio visually recorded and webcast live on the City of Sydney website. The Chair (the Lord Mayor) asked that courtesy and respect be observed throughout the meeting and advised those in attendance to refrain from making defamatory statements.

Due to unforeseen circumstances, the Council meeting is able only to be audio recorded and webcast while the Council is unable to meet in person.

Councillor Linda Scott left the meeting of Council at 5.59pm, prior to discussion and voting on Item 6.4, and returned to the meeting at 6.00pm, after the vote on Item 6.4. Councillor Scott was not present at the meeting of Council, which was held remotely, during discussion or voting on Item 6.4.

#### Item 1 Confirmation of Minutes

Moved by the Chair (the Lord Mayor), seconded by Councillor Scully -

That the Minutes of the meeting of Council of Monday, 24 August 2020, as circulated to Councillors, be confirmed.

Carried unanimously.

#### Item 2 Disclosures of Interest

Councillor Linda Scott disclosed a pecuniary interest in Item 6.4 on the agenda, in that she is President of Local Government NSW. Councillor Scott stated that she would leave the meeting for that item.

Councillor Philip Thalis disclosed a less than significant, non-pecuniary interest in Item 9.3 on the agenda, in that one of the consultants associated with this project has been engaged by Councillor Thalis' practice on an unrelated matter outside of the City of Sydney local government area.

No other Councillors disclosed any pecuniary or non-pecuniary interests in any matter on the agenda for this meeting of Council.

## Local Government and Planning Legislation Amendment (Political Donations) Act 2008

No disclosures were made by any members of the public at this meeting of Council.

#### Adjournment

At this stage of the meeting, at 5.09pm, it was moved by the Chair (the Lord Mayor), seconded by Councillor Thalis –

#### Item 4 Memoranda by the Chief Executive Officer

### Item 4.1 Election of Deputy Lord Mayor

#### **Memorandum by the Chief Executive Officer**

To Council:

Sections 231(1) and (2) of the Local Government Act 1993 (the Act) provide:

- (1) the councillors may elect a person from among their number to be the deputy mayor; and
- (2) the person may be elected for the mayoral term or a shorter term.

At the Council meeting of 9 September 2019, Councillor Jess Scully was elected Deputy Lord Mayor in accordance with the provisions of section 231 of the Local Government Act 1993 for a term commencing immediately and ending on the day appointed for the next ordinary election of Council.

#### **Postponement of Local Government Elections**

In March 2020, the Minister for Local Government announced that the September 2020 local government elections would be postponed to address the risks posed by the Covid-19 pandemic. The Local Government Act 1993 has been amended to confer on the Minister, a time-limited power to postpone council elections.

The official Order under the Local Government Act 1993 deferring the local government election from 12 September 2020 for twelve months was made on 12 June 2020. The NSW Government has announced that the local government elections will be held on 4 September 2021.

Accordingly, given the postponement of the local government election, it is appropriate that Council declare the office of Deputy Lord Mayor vacant to enable it to elect a Deputy Lord Mayor for a new term of office commencing immediately and ending on the day appointed for the next ordinary election of Council, currently scheduled to be held in September 2021.

#### Payment of Fees

Section 249(5) of the Act provides:

(5) a council may pay the deputy mayor (if there is one) a fee determined by the council for such time as the deputy mayor acts in the office of the mayor. The amount of the fee so paid must be deducted from the mayor's annual fee.

On 5 June 2000, Council resolved to:

"Pay Councillors the maximum of the range (as determined annually by the Local Government Remuneration Tribunal) as a matter of standing policy.

Pay the Lord Mayor the maximum of the range (in addition to the fee as a Councillor) - as a matter of standing policy (less the Deputy Lord Mayor's fee).

Pay the Deputy Lord Mayor, in addition to the fee as a Councillor, an amount equal to 10 per cent of the mayoral fee actually paid to the Lord Mayor as a matter of standing policy."

#### **Call for Nominations**

Nominations for the office of Deputy Lord Mayor are now invited. Nominations must be made in writing by two or more Councillors (one of whom may be the nominee). Nomination forms will be provided to Councillors.

#### **Conduct of Election**

Schedule 7 of the Local Government (General) Regulation 2005 provides the method of conducting an election for Deputy Lord Mayor (further details on election procedures will be provided to Councillors). The last time the Deputy Lord Mayor's position was contested the method of voting selected by the Council was open, exhaustive voting.

#### Recommendation

It is resolved that:

- (A) Council declare the office of Deputy Lord Mayor vacant effective immediately;
- (B) Council elect a Deputy Lord Mayor for a term commencing immediately following the election and ending on the day appointed for the next ordinary election of Council;
- (C) the method of voting be by open, exhaustive voting; and
- (D) the Chief Executive Officer conduct the election forthwith.

- (C) the method of voting be by open, exhaustive voting; and
- (D) the Chief Executive Officer conduct the election forthwith.

Carried unanimously.

At this stage of the meeting, the Chief Executive Officer, as Returning Officer, called on the Council Business Coordinator to assist with the conduct of the ballot.

The Council Business Coordinator announced that two duly completed, written nominations had been received, namely –

Councillor Jess Scully (nominated by the Lord Mayor, seconded by Councillor Thalis)

Councillor Angela Vithoulkas (nominated by Councillor Chung, seconded by Councillor Scott)

Councillors Scully and Vithoulkas in turn indicated acceptance of their nominations.

An election for the office of Deputy Lord Mayor was then conducted, in alphabetical order, and resulted as follows –

Councillor Scully – 5 votes

Councillor Vithoulkas - 5 votes

The Council Business Coordinator then explained the procedures to be followed where an equality of voting has occurred.

The names of Councillor Scully and Vithoulkas were subsequently deposited in the ballot box.

Upon one name being drawn from the ballot box, the Council Business Coordinator announced that Councillor Scully had been duly elected to the office of Deputy Lord Mayor in accordance with the provisions of section 231 of the Local Government Act 1993 for a term commencing immediately and ending on the day appointed for the next ordinary election of Council.

# Item 4.2 Council Committees - Functions, Membership, Election of Deputy Chairpersons

#### **Memorandum by the Chief Executive Officer**

#### To Council:

In accordance with the provisions of section 360 of the Local Government Act 1993, the Local Government (General) Regulation 2005 and clause 18.2 of the City of Sydney Code of Meeting Practice (the Code), the council may establish such committees as it considers necessary.

In 2019, Council resolved to adopt meeting times, functions, policies and procedures of the following Committees and Sub-Committees:

- Corporate, Finance, Properties and Tenders Committee, inclusive of the Economic Development and Business Sub-Committee, commencing at 2.00pm.
- Environment Committee, commencing at the conclusion of the Corporate, Finance, Properties and Tenders Committee.
- Cultural and Community Committee, comprising two Sub-Committees: the Cultural and Creative Sub-Committee and the Healthy Communities Sub-Committee, meeting consecutively at the conclusion of the Environment Committee.
- Transport, Heritage and Planning Committee, commencing at the conclusion of the Cultural and Community Committee.

The administrative arrangements associated with Council's Committees and Sub-Committees are detailed in the 'Functions, Delegations, Policies and Procedures of Council Committees' (refer Attachment A). No amendments are proposed to these documents.

#### **Election of Deputy Chairpersons**

Council may elect a Deputy Chairperson of each Committee and Sub-Committee and, if the Lord Mayor does not wish to be the Chairperson of any Committee, elect the Chairperson of each such Committee and Sub-Committee (clauses 18.15 and 18.16 of the Code).

Previously, the Council has chosen to hold a separate election for each of the Deputy Chairperson positions. Elections were conducted by open, exhaustive voting (that is, by a show of hands or similar means for candidates duly nominated).

At the Council meeting of 9 September 2019, Council elected Deputy Chairpersons for each of Council's Committees and Sub-Committees for a term commencing immediately and ending on the day appointed for the next ordinary election of Council, with the Lord Mayor chairing all Committees.

#### **Postponement of Local Government Elections**

In March 2020, the Minister for Local Government announced that the September 2020 local government elections would be postponed to address the risks posed by the Covid-19 pandemic. The Local Government Act 1993 has been amended to confer on the Minister, a time-limited power to postpone council elections.

- (A) the Functions, Delegations, Policies and Procedures of Council Committees, as shown at Attachment A to the subject Memorandum, be endorsed and adopted;
- (B) Council declare the offices of Deputy Chairperson of the Corporate, Finance, Properties and Tenders Committee, Environment Committee and Transport, Heritage and Planning Committee vacant effective immediately;
- (C) Council elect the Deputy Chairpersons of the Corporate, Finance, Properties and Tenders Committee, Environment Committee and Transport, Heritage and Planning Committee for a term commencing immediately following the election and ending on the day appointed for the next ordinary election of Council;
- (D) Council declare the offices of Deputy Chairperson of the Sub-Committees of the Corporate, Finance, Properties and Tenders Committee and Cultural and Community Committee vacant effective immediately;
- (E) Council elect the Deputy Chairpersons of the Sub-Committees of the Corporate, Finance, Properties and Tenders Committee and Cultural and Community Committee for a term commencing immediately following the election and ending on the day appointed for the next ordinary election of Council;
- (F) if the Lord Mayor does not wish to be the Chairperson of any Committee, Council elect the Chairperson of each such Committee for a term effective immediately and ending on the day appointed for the next ordinary election of Council;

- (G) the method of voting be open, exhaustive voting; and
- (H) the Chief Executive Officer conduct the election forthwith.

- (G) the method of voting be open, exhaustive voting; and
- (H) the Chief Executive Officer conduct the election forthwith.

Carried unanimously.

The Chair (the Lord Mayor), in accordance with clause (F) of the resolution, confirmed that she wished to be the Chair of all Committees.

At this stage of the meeting, the Chief Executive Officer, as Returning Officer, called upon the Council Business Coordinator to assist with the conduct of the ballot.

The Council Business Coordinator invited nominations from Councillors for the positions of Deputy Chairs of Committees and Sub-Committees.

Nominations were made and accepted as follows. Elections were conducted with the results as follows –

## Item 4.3 Central Sydney Planning Committee - Election of Councillors

#### **Memorandum by the Chief Executive Officer**

To Council:

The Central Sydney Planning Committee (CSPC) is constituted by the City of Sydney Act 1988 (the Act).

Section 34(1) of the Act provides that the Committee shall consist of seven members:

- (a) the Lord Mayor of Sydney;
- (b) two councillors of the City of Sydney elected by the City Council; and
- (c) four persons (two of whom are senior State government employees and two of whom are not State or local government employees) appointed by the Minister administering Part 4 of the Planning Act, each having expertise in at least one of architecture, building, civic design, construction, engineering, transport, tourism, the arts, planning or heritage.

The persons currently appointed by the Minister pursuant to clause (c) are Ms Abbie Galvin, Ms Alex O'Mara, Mr Dick Persson AM and Mr Richard Horne.

Previously, the Council has chosen to hold a separate election for each of the two Council-elected members; the elections were by open, exhaustive voting (that is, by a show of hands or similar means for candidates duly nominated).

At the Council meeting of 9 September 2019, Council elected Councillors Philip Thalis and Jess Scully to the two positions on the Central Sydney Planning Committee, effective immediately until the day appointed for the next ordinary election of Council.

The Act provides that Council may appoint an alternate for each of the elected members. At the Council meeting of 9 September 2019, Council appointed Councillor Robert Kok as alternate to Councillor Thalis and Councillor Linda Scott as alternate to Councillor Scully until the day appointed for the next ordinary election of Council.

#### **Postponement of Local Government Elections**

In March 2020, the Minister for Local Government announced that the September 2020 local government elections would be postponed to address the risks posed by the Covid-19 pandemic. The Local Government Act 1993 has been amended to confer on the Minister, a time-limited power to postpone council elections.

The official Order under the Local Government Act 1993 deferring the local government election from 12 September 2020 for twelve months was made on 12 June 2020. The NSW Government has announced that the local government elections will be held on 4 September 2021.

Accordingly, given the postponement of the local government election, it is appropriate that Council declare the offices of Central Sydney Planning Committee member vacant to enable it to elect Central Sydney Planning Committee members for a new term of office commencing immediately and ending on the day appointed for the next ordinary election of Council, currently scheduled to be held in September 2021.

#### Recommendation

It is resolved that:

- (A) Council declare the offices of Central Sydney Planning Committee member vacant effective immediately;
- (B) Council elect two Councillors to be members of the Central Sydney Planning Committee commencing immediately following the election and ending on the day appointed for the next ordinary election of Council;

- (E) Council appoint alternates for each member elected.

# Item 4.4 Local Pedestrian, Cycling and Traffic Calming Committee - Policies and Procedures, Membership and Appointment of Chairperson and Alternate Chairperson

#### **Memorandum by the Chief Executive Officer**

#### To Council:

The Local Pedestrian, Cycling and Traffic Calming Committee is a statutory committee, established under the Roads Act 1993 and in accordance with administrative procedures required by Transport for NSW (formerly Roads and Maritime Services).

Councils have been delegated certain powers by Transport for NSW regarding the regulation of traffic on local roads. A condition of this delegation is that councils must take into account the advice of their Local Pedestrian, Cycling and Traffic Calming Committee before exercising these powers.

The Local Pedestrian, Cycling and Traffic Calming Committee has no decision-making powers. It is primarily a technical review body which is required to advise Council and City staff on traffic-related matters. Council and City staff are therefore not bound or required to implement a proposal supported by the Local Pedestrian, Cycling and Traffic Calming Committee. Any proposal supported by the Local Pedestrian, Cycling and Traffic Calming Committee must be approved by either the elected Council or authorised City staff (depending on the nature of the proposal) if it is to be implemented. This can only be done when the advice of the Committee is unanimous. Where the advice of the Committee is not unanimous, Council must separately notify and obtain the endorsement of Transport for NSW and NSW Police.

The Local Pedestrian, Cycling and Traffic Calming Committee is made up of four formal (voting) members as follows:

- one representative of Council (Chairperson or alternate Chairperson);
- one representative of NSW Police;
- one representative of Transport for NSW;
- the local State Member of Parliament (MP) or their nominee;
- one representative of a relevant NSW Government agency (where applicable)\*.

Representatives of NSW Police and State MPs can only vote on matters in their respective command or electorate.

\*The NSW Government agencies are formal (voting) members for matters relating to roads over which they have jurisdiction only (for example, Property NSW / Place Management NSW / Infrastructure NSW). The City of Sydney Council is not a formal (voting) member for these matters.

The Chairperson and alternate Chairperson are to be determined by Council, and Council's representative may be any Councillor or City staff. Council (in consultation with the formal members of the Local Pedestrian, Cycling and Traffic Calming Committee) may also decide to have additional informal (non-voting) representatives who can provide non-binding input on matters under consideration. Informal (non-voting) members of the Local Pedestrian, Cycling and Traffic Calming Committee are as follows:

- Transit Systems representative;
- Transport Workers Union representative;
- cycling representative appointed by the Lord Mayor; and
- pedestrian representative appointed by the Lord Mayor.

City staff convene meetings and provide administrative support for the Committee, including the preparation of agendas, reports and minutes, and formally represent Council when both the Chairperson and the alternate Chairperson are absent.

The Local Pedestrian, Cycling and Traffic Calming Committee meets every third Thursday of the month, except in January, at 10.00am. Members of the public can attend and speak to an item on the Local Pedestrian, Cycling and Traffic Calming Committee agenda.

At the Council meeting of 9 September 2019, Councillor Philip Thalis and Councillor Linda Scott were appointed Chairperson and alternate Chairperson of the Local Pedestrian, Cycling and Traffic Calming Committee respectively for a term office ending on the day appointed for the next ordinary election of Council.

#### Postponement of Local Government Elections

In March 2020, the Minister for Local Government announced that the September 2020 local government elections would be postponed to address the risks posed by the Covid-19 pandemic. The Local Government Act 1993 has been amended to confer on the Minister, a time-limited power to postpone council elections.

The official Order under the Local Government Act 1993 deferring the local government election from 12 September 2020 for twelve months was made on 12 June 2020. The NSW Government has announced that the local government elections will be held on 4 September 2021.

Accordingly, given the postponement of the local government election, it is appropriate that Council declare the offices of Chairperson and alternate Chairperson vacant to enable it to appoint a Chairperson and alternate Chairperson for a new term of office commencing immediately and ending on the day appointed for the next ordinary election of Council, currently scheduled to be held in September 2021.

It is also recommended that the Policies and Procedures of the Local Pedestrian, Cycling and Traffic Calming Committee as set out in Attachment A to this Memorandum be endorsed and adopted. Minor amendments are proposed reflecting the organisational changes at State government level.

- (C) Council declare the offices of Chairperson and alternate Chairperson of the Local Pedestrian, Cycling and Traffic Calming Committee vacant effective immediately;
- (E) Council appoint Councillor ....... as the alternate Chairperson of the Local Pedestrian, Cycling and Traffic Calming Committee, for a term commencing immediately and ending on the day appointed for the next ordinary election of Council.

Members: There are four formal members of the Traffic Committee:

- NSW Police Service
- NSW Roads and Maritime Services Transport for NSW
- Local State Members of Parliament or their nominee.
- NSW Government Agencies\*\*

Note: representatives of the NSW Police Service and representatives of State MPs can only vote on issues in their command or electorate respectively.

- \*\*The NSW Government agencies are formal (voting) members for matters relating to roads over which they have jurisdiction only (for example, Property NSW / Place Management NSW / Infrastructure NSW). The City of Sydney Council is not a formal (voting) member for these matters.
- (b) Informal (non-voting) representatives, where relevant, from each of the following –
- Transport for NSW representative Transit Systems representative
- Transport Workers Union representative
- a cycling representative appointed by the Lord Mayor and
- a pedestrian representative appointed by the Lord Mayor.

The Chairperson and their alternate shall be determined by Council. The views of informal members are considered but not binding.

Administration:

City staff convene meetings and provide administrative support for the Committee, including the preparation of agendas, reports and minutes, and formally represent Council when both the Chairperson and the alternate are absent.

Function:

Council has been delegated certain powers from *Transport for* **NSW** the Roads and Maritime Services with regard to traffic matters on local roads. A condition of this delegation is that Council must take into account the advice of the Local Pedestrian, Cycling and Traffic Calming Committee. The Local Pedestrian, Cycling and Traffic Calming Committee has no decision-making powers. It is primarily a technical review body which is required to advise Council on traffic related matters. All proposals recommended by the Local Pedestrian, Cycling and Traffic Calming Committee must still be formally approved by either the elected Council or authorised City staff (depending on the nature of the proposal). This can only be done when the advice of the Committee is unanimous. Where the advice of the Committee is not unanimous, Council must separately notify and obtain endorsement from Roads and Maritime Services Transport for NSW and the NSW Police Service.

Meetings/Attendance:

The Local Pedestrian, Cycling and Traffic Calming Committee generally meets every third Thursday of the month at 10.00am in the Council Chamber, Level 1, Sydney Town Hall, George Street, Sydney. Members of the public are welcome to attend and speak to an item on the Local Pedestrian, Cycling and Traffic Calming Committee agenda. Addresses to the Committee are limited to 3 minutes, but this can be extended at the discretion of the Chairperson. If a member of the public wishes to attend, it is requested that they inform the Committee Secretary in advance on 9265 9648.

#### Item 4.5 Determination of Number of Councillors

#### **Memorandum by the Chief Executive Officer**

To Council:

Section 224 of the Local Government Act 1993 requires that:

- (1) A council must have at least five and not more than 15 councillors (one of whom is the mayor).
- (2) Not less than 12 months before the next ordinary election, the council must determine the number, in accordance with subsection (1), of its councillors for the following term of office.
- (3) If the council proposes to change the number of councillors, it must, before determining the number, obtain approval for the change at a constitutional referendum.

Council is therefore required by section 224 of the Local Government Act 1993 to determine the number of councillors for the term of office to follow the elections to be held in September 2021.

I am not aware of any reason why Council would wish to increase or decrease the number of councillors.

Accordingly, it is not proposed to take any action in respect of the holding of a constitutional referendum to seek approval for such a change.

On 9 September 2019, Council determined that the number of councillors be maintained at 10 for the following term of office of the City of Sydney Council, commencing in September 2020.

In March 2020, the Minister for Local Government announced that the September 2020 local government elections would be postponed to address the risks posed by the Covid-19 pandemic. The Local Government Act 1993 (the Act) has been amended to confer on the Minister, a time-limited power to postpone council elections.

The official Order under the Local Government Act 1993 deferring the local government election from 12 September 2020 for twelve months was made on 12 June 2020. The NSW Government has announced that the local government elections will be held on 4 September 2021.

As the determination made in 2019 made specific mention of the term of office commencing in September 2020, given the deferral of the local government elections, and the absence of a provision that automatically extends the determination to the new election date, it is considered prudent for a new determination to be made referring to the new date.

It is resolved that Council determines that the number of councillors be maintained at 10 for the following term of office of the City of Sydney Council, commencing following the next ordinary local government election.

#### Question

#### **Answer by the Chief Executive Officer**

City staff are working with staff from Transport for NSW to implement a joint monitoring and evaluation framework. It assesses the delivery of the program and usage, as well as place outcomes. Transport for NSW has installed counters on all the pop-up cycleways to measure usage. City staff have started observational studies. The timing and format of releasing the reporting needs to be agreed with Transport for NSW.

#### **Public Bicycle Racks**

2. By Councillor Forster

#### Question

- 1. How many public bicycle racks are there in the City of Sydney Local Government Area (LGA)?
- 2. How many public bicycle racks have been installed within the LGA within the last 12 months?
- 3. What is the cost of each individual installation?
- 4. Have any public bicycle racks been removed in the last 12 months? If so at what locations and at what cost?

#### **Answer by the Chief Executive Officer**

- 1. There are approximately 3,300 bicycle public bicycle racks in the City of Sydney Local Government Area.
- 2. There have been 18 bicycle racks installed within the last 12 months.
- 3. Each bicycle rack costs approximately \$300.
- 4. Three bicycle racks were removed in Regent Street, Redfern. Bicycle racks will be reinstalled as part of the public domain works on completion of this development.

Three bicycle racks were removed in Layton Street, Camperdown following community concerns about their positioning. A review of the area found that there were numerous racks nearby that remained available. The City is confident that there are enough bike racks to meet demand across the local government area.

#### **Embarkation Park**

**3.** By Councillor Forster

#### Question

Embarkation Park in Potts Point is open to the public between 6am and 8pm seven days a week.

Why is this park closed and locked up during night time hours?

#### **Answer by the Chief Executive Officer**

Embarkation Park is a roof garden located on top of the Navy Carpark and is leased from the Department of Defence. Closing the park at night has been in place for approximately 15 years and was introduced due to complaints about anti-social behaviour including intimidating behaviour, drug taking and dealing, noise, vandalism, gardens being used for camping and sleeping. There was also a fatality at the site.

Navy personnel also exit the carpark by passing through the park 24 hours a day due to staggered shifts and they requested the City look at management of the park, particularly at night in relation to the safety issue.

City staff have not received any requests to have the park open at night, however, there have been requests to extend the opening hours in winter when the park has been shut at sunset. Staff will change the closure time to 7.00pm in winter and 9.00pm in summer to accommodate this request.

#### 2020/21 Rate Peg

#### 4. By Councillor Chung

#### Question

On 8 September 2020, the Independent Pricing and Regulatory Tribunal announced that Councils will be able to increase the revenue they can collect from rates by a maximum of 2.0 per cent in 2021/22.

The economy of the City of Sydney has been significantly hit by Covid restrictions resulting in job losses, closure of small business, significantly reduced rentals to landlords amongst other impacts. The recovery of the economy is expected to take many years.

- 1. Could the Chief Executive Officer please provide an analysis of how a 2 per cent rate increase will impact our ratepayers and what options there are for full or partial deferral or waiving of rates for 2021/22.
- 2. What impact would the following options have on the City of Sydney:
  - (a) foregoing the 2 per cent per cent increase in 2021/22;
  - (b) partially increasing rates in 2021/22;
  - (c) deferring a portion of the rate increase over a number of years;
  - (d) hypothecating the rate increase to specific business recovery expenditure;
  - (e) other options that the Chief Executive Officer may consider.

#### S129268

#### **Answer by the Chief Executive Officer**

1. A rate peg increase of 2 per cent will result in an increase of \$6.3M on the current rates budget of \$316.1M.

Rates will generally increase by 2 per cent as the same land valuation basis will apply next year. For the 80 per cent of residential property owners, who pay a minimum rate of \$586.85, this would increase by \$12 for the year.

Under the legislation Council cannot waive rates for financial hardship including the circumstances caused by the pandemic. The City continues to communicate with our ratepayers to advise that we understand that these are difficult and unprecedented times, and to encourage residents and businesses who are experiencing financial hardship to contact the council. Many ratepayers have subsequently made arrangements to defer payment of their rates account over an extended period of time, with interest waived for those in financial distress.

#### 2. The City has the option to:

- (a) increase rates by the full rate peg of 2 per cent, some part thereof, or none of it;
- (b) defer all (or part) of the rate peg increase, and recover any shortfall over a period of up to 10 years.

If the City were to forego the 2 per cent per cent increase in 2021/22, or some part of it, there would be a shortfall in income of up to \$6.3M for 2021/22, and every year thereafter, because the 'base' income would be forever lower than it otherwise would have been. The City would have to adjust its long-term financial plan to accommodate this permanent and compounded loss in income and consider what operational or capital reductions might be required to balance funding within the plan.

(c) deferring a portion of the rate increase over a number of years

Deferring the rate increase involves the City catching up the income shortfall in future years. Our preferred position, reflecting better financial management practice, is to ensure those that can pay continue to pay now, and those that cannot pay are assisted through alternative repayment arrangements.

(d) hypothecating the rate increase to specific business recovery expenditure

The City's annual budget and long-term financial plan includes all anticipated revenue sources, operating expenditure and capital expenditure commitments. The plans already anticipate future years' rate increases just as they provide for rising salaries and wages, service delivery, contract, project and other operational expenditure costs.

Hypothecating particular revenue sources to particular programs limits Council's capacity to holistically determine the appropriate amount of funding to direct towards the City's priority projects and programs. For instance, Council's Small Business, Cultural and Creative Support Package as resolved in May, far exceeded the rates increase in that and/or the current year, but Council considered the need to support the community to the best of its ability so elected to develop a Financial Recovery Plan that enabled it to forward fund these support initiatives.

(e) other options that the Chief Executive Officer may consider

While the Covid-19 pandemic has caused enormous strain on many businesses and individuals, many of the City's ratepayers are still able to pay their rates and continue to do so. Providing rates relief of \$6.3M across all 120,000 ratepayers would not direct financial assistance to those most in need.

Ratepayers in financial difficulty receive assistance through alternative repayment arrangements and short-term payment deferrals. This relief is targeted to those who need it and avoids the 'bill shock' for all ratepayers of future increases in their rates to recover the shortfall of not taking up the rate peg at this time.

#### Ausgrid Footpath Installation on the corner of Macleay and Manning Streets

5. By Councillor Phelps

#### Question

The Ausgrid installation on the footpath on Macleay Street at the corner of Macleay and Manning Streets, Potts Point, was promised to be relocated as part of the Macleay Street upgrades when it was first installed.

Its current location makes it an inconvenient and potentially dangerous obstacle for pedestrians travelling down Macleay Street, particularly for those with mobility issues.

Could the Chief Executive Officer please advise:

- 1. If the Ausgrid installation on the corner of Macleay and Manning Streets, Potts Point, is still to be relocated as part of the Macleay Street upgrades?
- 2. If so, what is the expected completion date of these works?

#### S129272

#### **Answer by the Chief Executive Officer**

- 1. The City has started discussions with Ausgrid to seek approval to relocate the installation.
- 2. Pending approval from Ausgrid, the City will look to complete these works as part of the Macleay Street upgrade by early 2022.

#### Item 12.1 Saving Moore Park

Moved by Councillor Phelps, seconded by Councillor Forster -

It is resolved that:

- (i) Moore Park is part of Governor Macquarie's 1811 Sydney Common. As a park that is more than 150 years old, it is older than Centennial Park, and has major national and state heritage value;
- (ii) Moore Park is the largest park close to the City of Sydney and residential areas which have the greatest population density in Australia;
- (iii) especially during the Covid-19 pandemic this open space is vitally important for the physical and mental wellbeing of the community;
- (iv) Moore Park is of considerable environmental and historical significance including the surrounds of Kippax Lake, itself one of the last remnants of Sydney's early water supply, Busby's Bore;
- (v) Moore Park is seriously degraded after decades of on-grass car parking in connection with sporting events at the SCG and SFS and under-investment by the NSW State Government;
- (vi) in 2016, the NSW Government signed off on the Moore Park Master Plan, however it is yet to allocate any funds towards its implementation;
- (vii) the two areas currently used for car parking would provide excellent playing fields for junior and community sport, there being a desperate shortage of such fields in the Sydney metropolitan area; and
- (viii) there is widespread community support for the removal of on-grass car parking from Moore Park and the need for funding of the Moore Park Master Plan; and
- (B) the Lord Mayor be requested to write to the Premier, the Hon Gladys Berejiklian MP, and the Minister for Planning and Public Spaces, the Hon Rob Stokes MP, requesting that the NSW Government:
  - (i) agree to the permanent removal of event on-grass car parking on the northern section of Moore Park East with immediate effect;
  - (ii) announce that car parking on the southern end of Moore Park East will cease by mid-2023 to allow time for the provision of alternative parking and access arrangements;
  - (iii) develop and implement a comprehensive plan, based on the Moore Park Master Plan, for the remediation and revitalisation of Moore Park East including the provision of a new junior playing field on the northern section and facilities for community use; and
  - (iv) strengthen and formalise links between local communities and the new Greater Sydney Parklands Board and Management to ensure they respond to needs identified by the community.

Amendment. Moved by Councillor Thalis, seconded by the Chair (the Lord Mayor) -

It is resolved that:

- (i) Moore Park is public land that is part of the original Governor Macquarie's 1811 Sydney Common bequest for the benefit of the people of Sydney;
- (ii) the Lord Mayor's private members bill, the Centennial Park and Moore Park Trust (Macquarie Sydney Common) Amendment Bill in 1992 stopped plans to rezone the Showground site for sale and development when the Royal Agricultural Society moved to Homebush, confirming it as public land and placing it under the stewardship of the Centennial Park and Moore Park Trust;
- (iii) for years the Lord Mayor has advocated to NSW Governments to protect Moore Park and stop prioritising commercial interests over the public interest;
- (iv) Moore Park is 3km from the city centre and is within 2km of the Green Square urban renewal area, the densest residential area in Australia with an expected population of up to 70,000 people by 2031;
- (v) increased density has consequently increased demand for open space and parklands, especially during the Covid-19 pandemic, highlighting that Moore Park is vitally important for the physical and mental wellbeing of the community;
- (vi) Moore Park is of considerable environmental and historical significance including the surrounds of Kippax Lake, itself one of the last remnants of Sydney's early water supply, Busby's Bore;
- (vii) Moore Park is seriously degraded after decades of on-grass car parking in connection with events at the Sydney Cricket Ground and Sydney Football Stadium and withdrawal of investment by the NSW State Government for the upkeep and maintenance of the park;
- (viii) the Lord Mayor has met with the Minister of Planning and Public Spaces to discuss the new Greater Sydney Parklands Government Agency and written to him about it requesting the need for meaningful community consultation on the future of the parklands, and reduction of commercialisation of the parklands;
- (ix) on 18 August, the Lord Mayor reiterated those concerns to Michael Rose, Chair of the Greater Sydney Parklands and its Chief Executive Officer, Suellen Fitzgerald who have assumed responsibility for the Centennial Parklands;
- (x) in 2016, the NSW Government signed off on the Moore Park Master Plan 2040, however it is yet to allocate any funds towards its implementation;
- (xi) the Moore Park Master Plan 2040 has a welcome commitment to phase out on-grass event parking;
- (xii) the areas at the northern and southern ends of East Moore Park currently used for event on-grass car parking would provide excellent playing fields for junior and community sport, there being a desperate shortage of such fields in the Sydney metropolitan area;
- (xiii) there is widespread community support for the removal of on-grass car parking from Moore Park;

- (xiv) on 17 September, the Lord Mayor met with Michael Waterhouse, President of Saving Moore Park and offered her support for their campaign for the removal of on-grass car parking at Moore Park;
- (xv) the recently opened CBD and South East Light Rail offers patrons easy access to the Moore Park precinct; and
- (xvi) a fully integrated ticketing system for events at Moore Park will encourage more patrons to use public transport, rather than driving, to and from the precinct;
- (B) the Lord Mayor be requested to write to the Premier, the Hon Gladys Berejiklian, MP and the Minister for Planning and Public Spaces, the Hon. Rob Stokes, MP requesting that the NSW Government:
  - (i) agree to the permanent removal of event on-grass car parking at Moore Park;
  - (ii) develop and implement the proposal in Moore Park Master Plan 2040 for the remediation and revitalisation of Moore Park East including the provision of a new junior playing field on the northern section of Moore Park East and facilities for community use; and
  - (iii) strengthen and formalise links between local communities and the new Greater Sydney Parklands Board and Management to ensure they respond to needs identified by the community; and
- (C) the Lord Mayor be requested to write to the Minister for Transport, the Hon. Andrew Constance, MP and the private sporting codes operating at Moore Park to work together and formally commit to integrated ticketing for all events at Moore Park, and actively promote other incentives that encourage public transport and reduce private vehicle use for people going to events.

Variation. At the request of the Chair (the Lord Mayor), Councillor Phelps and Councillor Thalis, and by consent, the amendment was varied, such that clause (B) (i) read as follows:

(i) agree to the permanent removal of on-grass car parking at Moore Park with immediate effect;

  - (a) efficient capture of floating marine litter including micro plastics;
  - (b) high impact visual communication for solutions, awareness and education; and
  - (c) data monitoring of micro plastics, marine litter, surface pollutants and general health of the water table;
- (ii) on 31 July 2020, Councillors were informed via a CEO Update that:
  - (a) the City will liaise with Transport for NSW and Property NSW in relation to the Seabin City Pilot Project and share data on the performance results;
  - (b) collaborating with these agencies and Seabin Project has the aim of sharing and analysing data and considering opportunities for the installation of additional Seabin units; and
  - (c) the City will contact local universities to investigate opportunities for collaboration between the universities, Seabin Project and the City;
- (iii) in July 2020, Seabin Project launched a 12-month Sydney City Pilot Project as the first step in providing a full services Seabin package to the city;
- (iv) the pilot is self-funded by Seabin Project with the goal of obtaining funding and support from a number of key stakeholders;
- (v) the Seabin technology works 24/7 to remove marine debris and surface pollutants, and is managed by environmental technicians using a Pollution Index program to provide measurable impact and community engagement;
- (vi) the environmental technicians will be responsible for the servicing and maintenance of the units, daily marine data entries, engaging with community members and facilitating educational events;
- (vii) during the first month (July) of the Sydney City Pilot Project, Seabin achieved:
  - (a) a community reach of 5.8 million people based in Sydney and NSW;
  - (b) the removal of over 1.16 tonnes of marine debris, the equivalent of covering 28 football fields with plastic bags; and
  - (c) the filtration of 312 million litres of water for microplastics, plastic fibres, oil and more;

- (viii) the Seabin City Pilot Project is a platform to effectively address a range of matters including:
  - (a) accurate and ongoing data collection;
  - (b) visual communication to be seen to be doing something about community concerns;
  - (c) prevention and waste reduction via behavioural change; and
  - (d) the physical and visual act of cleaning up our waterways;
- (ix) Seabin Project are currently working with Macquarie University and University of Technology Sydney on multiple projects;
- (x) Seabin Project understands the need for data to provide credibility for the self-funded pilot as well as show the impact the pilot has on the health of waterways;
- (xi) self-funding a city pilot is not sustainable in the long-term for Seabin Project but was an important step to commit to; and
- (xii) a number of the City of Sydney's Sustainable Sydney 2030 strategic directions include:
  - (a) a globally competitive and innovative city;
  - (b) a leading environmental performer;
  - (c) sustainable development, renewal and design; and
  - (d) implementation through effective partnerships; and
- (B) the Chief Executive Officer be requested to liaise and collaborate with Seabin Project to identify and investigate ways the City of Sydney can support Seabin's Sydney City Pilot Project and the potential future expansion of the Sydney City Pilot Project.

  - (c) the removal of over 2 tonnes of marine debris, this is the equivalent of covering 48 football fields with plastic bags; and
  - (d) the filtration of more than 560 million litres of water for microplastics, plastic fibres, oil and more:
- (viii) the Seabin City Pilot Project is a platform to effectively address a range of matters including:
  - (a) accurate and ongoing data collection;
  - (b) visual communication to be seen to be doing something about community concerns;
  - (c) prevention and waste reduction via behavioural change; and
  - (d) the physical and visual act of cleaning up our waterways;
- (ix) Seabin Project are currently working with Macquarie University and University of Technology Sydney on multiple projects;
- (x) Seabin Project understands the need for data to provide credibility for the self-funded pilot as well as show the impact the pilot has on the health of waterways;

It is resolved that:

- following a Lord Mayoral Minute of 15 May 2020, pop-up cycleways were identified by Transport for NSW (TfNSW) and the City as part of a solution to ease demand for public transport as the NSW Government eases restrictions on business activity following the Covid-19 lockdown;
- (ii) there has been significant community opposition to the City of Sydney and Transport for NSW proposal for a temporary cycleway on Bridge Road, Glebe, due to the adverse impact the pop-up cycleway is having on the local community, including the imposition of a 24/7 clearway outside of residences on both sides of Bridge Road, where houses already have no stopping along the laneway to the rear and associated loss of all on street parking spaces; and
- (iii) residents of Bridge Road in Glebe are extremely concerned about the safety of cyclists, pedestrians, motorists and those attempting to access their homes without any ability to stop along Bridge Road. This includes:
  - (a) no ability for ambulances, buses, taxis and other vehicles to stop along the entirety of Bridge Road to pick up or drop off residents who are unable to cycle; and
  - (b) congestion down a key arterial road during garbage collection, resulting in the unsafe overtaking of garbage trucks by personal vehicles; and
- (B) the Chief Executive Officer be requested to:
  - (i) liaise with Transport for NSW to conduct and publish a safety audit regarding the Bridge Road Cycleway, prior to it being completed and open for use. This audit should relate to all aspects of a cycleway in Bridge Road including, but not limited to:
    - (a) whether the cycleway creates unacceptable risks of death or injury for cyclists, pedestrians, motorists or residents;
    - (b) the impact of any such cycleway on residents, including elderly, vulnerable and disabled residents;
    - (c) the effect of any such cycleway on emergency and essential services including but not limited to, garbage removal, water and electricity;
    - (d) any report or investigations, whether final or preliminary, conducted in the last ten years which deals with safety issues concerning a cycleway in Bridge Road;
    - (e) the basis of the determination by the Minister that the making of the Ministerial Order was necessary for the health, safety and welfare of the public during the Covid-19 pandemic;
    - (f) the number of cyclists using the Bridge Road cycleway in the period since it was installed compared with the number of cyclists using Bridge Road in the period immediately prior to the installation of the cycleway; and

- (g) the number of, and reasons, for cyclists using the footpaths on Bridge Road since the installation of the pop-up cycleways; and
- (ii) report back to Council via the CEO Update.

Note – at the meeting of Council, the content of the original Notice of Motion was varied by Councillor Phelps. Subsequently, it was –

Moved by Councillor Phelps, seconded by Councillor Forster –

It is resolved that:

- following a Lord Mayoral Minute of 18 May 2020, pop-up cycleways were identified by Transport for NSW (TfNSW) and the City as part of a solution to ease demand for public transport as the NSW Government eases restrictions on business activity following the COVID-19 lockdown;
- (ii) there has been significant community opposition to the City of Sydney and TfNSW proposal for a temporary cycleway on Bridge Road, Glebe, due to the adverse impact the pop-up cycleway is having on the local community, including the imposition of a 24/7 clearway outside of residences on both sides of Bridge Road, where houses already have no stopping along the laneway to the rear and associated loss of all on street parking spaces; and
- (iii) residents of Bridge Road in Glebe are extremely concerned about the safety of cyclists, pedestrians, motorists and those attempting to access their homes without any ability to stop along Bridge Road. This includes:
  - (a) no ability for ambulances, buses, taxis and other vehicles to stop along the entirety of Bridge Road to pick up or drop off residents who are unable to cycle;
  - (b) congestion down a key arterial road during garbage collection, resulting in the unsafe overtaking of garbage trucks by personal vehicles; and
  - (c) funding and commissioning an independent professional safety audit titled "Stage 5 (Existing Road) Road Safety Audit for Bridge Rd Glebe with emphasis on the newly installed Cycleway facility", tabled at the September 21, 2020 Council meeting. This safety audit found that as of 6 September 2020 there were 26 identified safety issues, with risk attached to each issue classified as intolerable, high, or medium; and
- (B) the Chief Executive Officer be requested to:
  - (i) liaise with Transport for NSW to close the Bridge Road cycleway and relocate the Glebe pop up cycleway to a safer, more suitable location as soon as possible; and
  - (ii) report back to Council via the CEO Update.

Amendment. Moved by Councillor Scully, seconded by the Chair (the Lord Mayor) -

It is resolved that:

- (i) following a Lord Mayoral Minute of 15 May 2020, pop-up cycleways were identified by Transport for NSW (TfNSW) and the City as part of a solution to ease demand for public transport as the NSW Government eases restrictions on business activity following the Covid-19 lockdown;
- (ii) there has been community opposition to the City of Sydney and Transport for NSW proposal for a temporary cycleway on Bridge Road, Glebe due to the adverse impact the pop-up cycleway is having on the local community, including the imposition of a 24/7 clearway outside of residences on both sides of Bridge Road, where houses already have no stopping along the laneway to the rear and associated loss of off-peak clearway parking spaces; and
- (iii) Some residents have expressed concerns about safety, access and congestion. It is important to note that:
  - (a) under NSW Road Rules 2014 Reg 307, emergency vehicles can stop anywhere they need to.
  - (b) under NSW Road Rules 2014 Reg 176, buses (including mini-buses) and taxis can stop in a clearway when they are picking up or dropping off passengers. Staff advise that on Bridge Road, buses will however be stopping at the bus stops, which are not clearways;
  - (c) residents have commissioned an independent professional safety audit titled "Stage 5 (Existing Road) Road Safety Audit for Bridge Rd Glebe with emphasis on the newly installed Cycleway facility", tabled at the September 21, 2020 Council meeting. This safety audit presents the assertion that as of 6 September 2020 there were 26 identified safety issues, with risk attached to each issue classified as intolerable, high, or medium. These claims should be conveyed to Transport for NSW to be considered as they are working on their own safety audit of the Bridge Road pop up cycleway;
  - (d) responding to community feedback, City staff are working with our waste collection services to implement changes to collection processes to ensure safer practices in these new conditions, and to minimise delays and impacts on congestion. Staff will also look for alternative waste bin pick up locations and work with Cleanaway to adjust their routes where feasible;
  - (e) the City is engaging with and responding to community concerns and suggestions as the pop-up cycleways are rolled out, and City staff are conveying recommendations to Transport for NSW regarding improvements or changes, a number of which have been implemented. Community members are encouraged to share their feedback and input with the City and with Transport for NSW to improve the operation of the cycleways; and
  - (f) the pop-up cycleway on Bridge Road is being delivered by Transport for NSW. Transport for NSW are conducting a Road Safety Audit in advance of the formal completion of the cycleway. The content and format of Road Safety Audit reports are governed by Transport for NSW, Austroads and Institute of Public Works Engineering Australasia (IPWEA) guidelines; and
- (B) the Chief Executive Officer be requested to obtain the Road Safety Audit for the Bridge Road pop-up cycleway from Transport for NSW once it is complete and publish it in a CEO update.

#### Item 12.5 Go Native

Moved by Councillor Phelps, seconded by Councillor Vithoulkas –

It is resolved that:

- (i) the City of Sydney is located in a spectacular and unique part of the Sydney basin. The inner city is home to around 365 local native plants and 90 different native bird species;
- (ii) while the City's urban population has grown, the urban biodiversity has been greatly reduced from its original state in the City of Sydney local government area;
- (iii) the City should create areas that celebrate local native plants that thrive in the Sydney region and that create habitats for native fauna;
- (iv) through its Urban Ecology Strategic Action Plan, the City encourages residents to create "habitat gardens," in backyards, on balconies, in common areas, or community spaces like local schools;
- (v) the City of Sydney's Street Tree Master Plan focuses on planting "the right tree in the right location," but the Master Plan does not account for available habitat or assist in the movement of native fauna species between those areas:
- (vi) currently 75 per cent of the City's park trees and 58 per cent of the City's street trees are native. Approximately 30 per cent of plants in the City's park and public domain gardens are native; and
- (vii) there are restrictions on what species can be planted in particularly harsh urban environments, however, the City can continue to improve on its efforts to create lush green spaces which showcase native Australian plant species and provide homes for native animals and birds; and
- (B) the Chief Executive Officer be requested to:
  - (i) consult with WIRES to compile a list of preferred trees and shrubs for planting in the City of Sydney that creates suitable habitats to enable birds, frogs, lizards, flying foxes, microbats, possums and other small mammals such as bandicoots to successfully survive;
  - (ii) use this list in planning considerations and maximising the planting of native flora where possible; and
  - (iii) share the list via the CEO Update.

Amendment. Moved by Councillor Miller, seconded by the Chair (the Lord Mayor) –

It is resolved that:

- (i) the City of Sydney is located in a spectacular and unique part of the Sydney basin. The inner city is home to around 365 local native plants and 90 different native bird species;
- (ii) the City creates areas that celebrate local native plants that thrive in the Sydney region and that create habitats for native fauna;
- (iii) the City's urban population has grown, and while the urban biodiversity has been greatly reduced from its original state in the City of Sydney local government area, the City has increased its bush restoration areas in open spaces from a baseline of 4.2hectares to approximately 13 hectares in the last seven years;
- (iv) these areas are managed in accordance to the guidelines outlined in the City's Bush Restoration Management Plan;
- (v) the objective of these areas is to create habitat for native flora and fauna;
- (vi) the City has developed a planting guide for its bush restoration and habitat sites to ensure that flora and fauna thrive in an urban environment;
- (vii) the City is developing a list of preferred tree species for the Grey-headed flying fox based on the extensive work carried out by experts;
- (viii) the City encourages developers to use the City's planting guide in their development projects, and the Urban Ecology Co-ordinator advises City Projects on park upgrades where native planting is recommended for habitat outcomes;
- (ix) through its Urban Ecology Strategic Action Plan, the City encourages residents to create "habitat gardens," in backyards, on balconies, in common areas, or community spaces like local schools;
- (x) the City of Sydney's Street Tree Master Plan and other policies and plans consider habitat a key consideration when selecting a tree species to encourage native flora and fauna;
- (xi) the City of Sydney also considers environmental tolerance, functional requirements and aesthetic and design requirements when planting trees;
- (xii) the City is currently working with consultants to further improve the identification of biodiversity and habitat corridors to encourage the movement of native fauna across the City of Sydney;
- (xiii) the objective of these works is to define how public and private landscapes can assist in strengthening habitat corridors and provide the opportunity for planning controls to be amended to support this aim;
- (xiv) currently 75 per cent of the City's park trees and 58 per cent of the City's street trees are native. Approximately 30 per cent of plants in the City's park and public domain gardens are native;
- (xv) there are restrictions on what species can be planted in particularly harsh urban environments, however the City can continue to improve on its efforts to create lush green spaces which showcase native Australian plant species and provide homes for native animals and birds; and

(B) the Chief Executive Officer be requested to consult with WIRES as part of the current review of the Greening Sydney Strategy, Street Tree Master Plan and Urban Forest Strategy.

  - (ii) in January 2019, the State Government presented their preferred Master Plan for Waterloo:
    - (a) they proposed 30 per cent social, 65 per cent market and 5 per cent affordable housing;
  - (iii) in March 2019, the City released an alternate scheme for Waterloo for which it is seeking funding from the Federal Government:
    - (a) the City's scheme included a mix of social and affordable housing comprising 50 per cent social, 20 per cent affordable and 30 per cent private market housing; and
    - (b) it substantially increases the number of social and affordable dwellings to address the social and affordable housing crisis;
  - (iv) in May 2020, NSW Land and Housing Corporation lodged a planning proposal request for Waterloo South with the City of Sydney;
  - (v) Sustainable Sydney 2030 envisages that, by 2030, 7.5 per cent of all housing in the City of Sydney will be affordable housing;
  - (vi) access to affordable housing is essential for a diverse, inclusive, cohesive, and economically successful global city;
  - (vii) the City of Sydney's City Plan 2036 City of Sydney Local Strategic Planning Statement and Housing for All - City of Sydney Local Housing Strategy both identify the need for Aboriginal and Torres Strait Islander housing in Redfern/Waterloo in particular, and in the local government area generally;
  - (viii) in 2013, the City entered into a deed with the Aboriginal Housing Company which included:
    - (a) the transfer of land on Caroline Lane, Eveleigh Lane and Eveleigh Street Redfern to the Aboriginal Housing Company to facilitate the redevelopment known as the Pemulwuy Project; and
    - (b) the deed was subject to the delivery of affordable housing, childcare, gallery space and public open space;
  - (ix) in April 2016, the City granted \$100,000 to Redfern Legal Centre to support tenants during the redevelopment of the Waterloo Estate;
  - (x) in October 2017, the City granted \$47,980 (excluding GST) to Waterloo Public Housing Action Group to support tenants through their Future Planning Office;

- (xi) in February 2020, the City granted \$150,000 to St George Community Housing for a shared capacity development project (between St George Community Housing, Bridge Housing and City West Housing) to employ and train a dedicated Aboriginal Affordable Housing Manager to improve access to affordable housing opportunities for Aboriginal and Torres Strait Islander persons in the local area;
- (xii) the Redfern Waterloo Aboriginal Affordable Housing Campaign advocates for:
  - (a) 10 per cent of all redevelopment on government land in Redfern/Waterloo to be Aboriginal affordable housing; and
  - (b) an increase in Aboriginal social housing in partnership with an Aboriginal community-controlled organisation; and
- (xiii) an alliance of community organisations has given their support to the Redfern Waterloo Aboriginal Affordable Housing Campaign; and
- (B) Council support the Redfern Waterloo Aboriginal Affordable Housing Campaign.

Amendment. Moved by Councillor Phelps -

That the motion be amended such that clauses (A) (viii) (a) and (b) be deleted.

The amendment lapsed for want of a seconder.

The motion was carried unanimously.

#### Item 12.7 Climate Change and City Electric Vehicle Fleet Outcomes

Moved by Councillor Scott, seconded by Councillor Miller -

It is resolved that:

- (i) the City has offset emissions, including fleet emissions, since 2007 and was certified carbon neutral under the National Carbon Offset Standards from 2011;
- (ii) under the Sustainable Sydney 2030 policy the City is committed to reducing carbon emissions by 70 per cent by 2030, which is less than nine and a half years away;
- (iii) battery run Electric Vehicles have zero exhaust emissions at the tailpipe compared to internal combustion engine vehicles;
- (iv) the City recognises both the environmental and economic benefits of electric vehicles and as at April 2019, Council had 19 Electric Vehicles in its fleet, as well as 40 hybrid cars and 70 hybrid trucks;
- (v) the Council's first electric truck, which is a tipper truck and separate to the rubbish truck trial vehicle, has been unfortunately delayed due to Covid but upon arrival will be trialled across a number of business units over the period of one year;
- (vi) the first fully electric rubbish trucks in Australia were introduced in May 2019 by the City of Casey and in January 2020 an additional several new electric trucks were added to the City of Casey rubbish collection fleet under the management of WM Waste Management as part of a new waste contract;
- (vii) additional benefits of electric vehicle rubbish trucks is that they are quieter than diesel counterparts;
- (viii) in a disaster and recovery situation such as blackouts the vehicles can be pivoted to act as temporary emergency power; and
- (ix) in March 2020, the Lord Mayor announced via Facebook the City will be trialling an initial electric garbage truck;
- (B) Council recognise that electric trucks are a key part of the City of Sydney's demonstration of support for renewable energy as they significantly reduce the City's environmental footprint and improve the sustainability of residential hard waste collection;
- (C) Council further recognise that an electric vehicle fleet as a whole supports future sustainability of the vehicle fleet more generally; and
- (D) on the basis of the City's successful trial of the electric vehicle rubbish truck, the Chief Executive Officer be requested to:
  - (i) progress the transition to carbon neutral vehicles, including rubbish collection vehicles, for the City of Sydney to reduce the City's reliance on costly carbon offsets;
  - (ii) provide an update to Council on the current trial of one electric vehicle rubbish collection truck including whether it is able to manoeuvre the LGAs streets, the economic and carbon reduction benefits and whether the trial truck is quieter than those in use currently;

- (iii) based on the positive outcomes of the pilot, provide an update to Council on the timeframe for implementation of the roll out of a full electric vehicle rubbish collection fleet; and
- (iv) advise Council whether the current waste removal contract will allow for the introduction of additional electric vehicle rubbish trucks to the fleet or whether this will be required to be negotiated as part of the next contract and the year in which this tender will be released.

Variation. At the request of Councillor Miller, and by consent, the motion was varied such that it read as follows –

#### It is resolved that:

- (i) the City has offset emissions, including fleet emissions, since 2007 and was certified carbon neutral under the National Carbon Offset Standards from 2011;
- (ii) under the Sustainable Sydney 2030 policy the City is committed to reducing carbon emissions by 70 per cent by 2030, which is less than nine and a half years away;
- (iii) battery run Electric Vehicles have zero exhaust emissions at the tailpipe compared to internal combustion engine vehicles;
- (iv) the City recognises both the environmental and economic benefits of electric vehicles and as at April 2019, Council had 19 Electronic Vehicles in its fleet, as well as 37 hybrid cars and 70 hybrid trucks;
- (v) Cleanaway, the City's contractor for domestic waste, trialled two electric trucks (one larger and one smaller) in February, March and July 2020;
- (vi) procurement of the Council's first electric truck, which is a tipper truck and separate to the rubbish truck trial vehicle, has been unfortunately delayed due to Covid but upon arrival will be trialled across a number of business units over the period of one year;
- (vii) Fleet Services have included options for suppliers to respond to all recent (applicable) tenders with electric vehicles;
- (viii) the first fully electric rubbish trucks in Australia were introduced in May 2019 by the City of Casey and in January 2020 an additional several new electronic trucks were added to the City of Casey rubbish collection fleet under the management of WM Waste Management as part of a new waste contract;
- (ix) additional benefits of electric vehicle rubbish trucks is that they are quieter than diesel counterparts;
- (x) in a disaster and recovery situation such as blackouts the vehicles can be pivoted to act as temporary emergency power; and
- (xi) the City is in the process of purchasing an electric rubbish truck for its own fleet, delivery is expected mid-2021;
- (xii) while electric vehicles can have higher upfront costs (up to two and a half times more for heavy vehicles), they cost less in ongoing maintenance and fuel;
- (xiii) the City regularly renews the vehicles in its fleet, and has a plan for increasing the proportion of electric vehicles as older vehicles reach the end of their useful lives; and

- (xiv) the City is developing a "Greening the Fleet" Strategy, which will come to Council for approval when finalised;
- (B) Council recognise that electric vehicles are a key part of the City of Sydney's demonstration of support for renewable energy as they significantly reduce the City's environmental footprint and improve the sustainability of residential hard waste collection;
- (C) Council further recognise that an electric vehicle fleet as a whole supports future sustainability of the vehicle fleet more generally; and
- (D) the Chief Executive Officer be requested to:
  - (i) provide an update to Council about whether the electric rubbish trucks that Cleanaway trialled in the City were able to manoeuvre City streets and laneways, has high levels of safety for staff, the economic and carbon reduction benefits and whether the trial truck is quieter than those in use currently, via the CEO Update;
  - (ii) should the trial be successful and safe, progress the transition to carbon neutral vehicles, including rubbish collection vehicles, for the City of Sydney to reduce the City's reliance on costly carbon offsets; and
  - (iii) advise Council whether the current waste removal contract will allow for the introduction of additional electronic vehicle rubbish trucks to be introduced to the fleet or whether this will be required to be negotiated as part of the next contract and the year in which this tender will be released, via the CEO Update.

The motion, as varied by consent, was carried unanimously.

#### Item 12.8 City Community Engagement for State Significant Precincts

#### (A) Council note:

- (i) the NSW Government has announced State Significant Precincts in Pyrmont, around Central Station, and in a range of other City of Sydney areas; and
- (ii) State Significant Precincts do not allow for positive engagement with City of Sydney communities to create a vision for the future of these places;
- (B) on the basis of the City's successful community engagement strategies, the Chief Executive Officer be requested to outline a community engagement program to allow City communities opportunities to have a voice in the State Significant Precincts, including Pyrmont/Ultimo and the communities around Central Station redevelopment, including Chippendale; and
- (C) the Lord Mayor be requested to write to the NSW Planning Minister seeking a commitment to ensure the voice of City communities will be considered during any rezoning or planning approvals in State Significant Precincts in the City of Sydney.

Variation. At the request of Councillor Thalis, and by consent, the motion was varied such that it reads as follows –

It is resolved that:

- (i) the NSW Government has announced State Significant Precincts in Pyrmont, around Central Station, and in a range of other City of Sydney Areas;
- (ii) the Department of Planning Industry and Environment has developed a new approach to precinct planning that acknowledges local councils 'know their people and communities best';
- (iii) the approach includes 'Council-led rezoning' for State Significant Precincts that recognises council is best placed to deliver detailed planning within its communities;
- (iv) recent assessment of 'Council-led rezoning' proposals on Land and Housing Corporation (LAHC) sites, has demonstrated the City's ability to deliver better planning outcomes for the local area that are driven by positive community engagement strategies; and
- (v) the City calls on the return of planning power for all private and government-owned sites in our local area so that the community can be meaningfully involved in the decision-making process and positively contribute to planning outcomes; and
- (B) the Lord Mayor be requested to write to the NSW Planning Minister expressing the above views.

The motion, as varied by consent, was carried on the following show of hands -
