#### Advice

City Staff to further liaise with Transport for NSW (TfNSW) regarding the traffic arrangement at the intersection of Swanson Street should the City change the traffic arrangement in Railway Parade.

#### **Background**

This project includes a 2.4m wide separated bi-directional cycleway at Bridge Street between Ashmore Street and Swanson Street, getting across Swanson Street and continuing along Railway Parade and joining Henderson Road up until its intersection with Mitchell Road. It also includes bi-

directional cycleway on Ashmore Street between Fox Avenue and Mitchell Road and conventional running separated cycleway on each side of Harley Street between Mitchell Road and McEvoy Street.

These project aims to fill in the missing links on the City's bike network identified in the Cycling Strategy adopted by Council in November 2018. They will improve the safety of people riding locally, or to work or school. This will serve as strategic connection while improving amenity of the area while supporting overall traffic calming.

It was endorsed to convert Railway Parade into one way southbound between Swanson Street and Sydney Street at the traffic committee meeting on 18 February 2021. However, this decision was overturned by Council in its March 2021 meeting and new proposal to retain two-way traffic arrangement at Railway Parade was requested.

#### Item 18 Matters Raised

#### Chairperson

#### Church Street, Paddington - Traffic Treatments

It was requested that the City investigate traffic treatments in Church Street, Paddington to assist with the prevention of speeding vehicles.

The City advised that an Item will be tabled at the November 2021 meeting for the introduction of a continuous footpath treatment in Church Street, Paddington, just east of South Dowling Street. The City will also investigate further traffic treatments at this location.

#### Matters Raised by the Representative for the Member for Newtown

The Representative for the Member for Newtown raised concerns regarding the removal of seating along Broadway Road, Ultimo

The City advised that seats were temporarily removed and will be replaced with new seating shortly.

#### Matters Raised by the Representative for the Member for Balmain

The Representative for the Member for Balmain raised concerns about vehicles exiting Jones and Mount Streets, Pyrmont into Miller Street cycleway.

City staff advised that the treatments implemented along the cycleway in Miller Street, Pyrmont are in line with the Technical Direction Traffic and Transport TTD 2020/03 | Version No. 01 – 26 June 2020 - Shared Environment Intersection Treatment <a href="https://roads-waterways.transport.nsw.gov.au/trafficinformation/downloads/ttd\_2020-03.pdf">https://roads-waterways.transport.nsw.gov.au/trafficinformation/downloads/ttd\_2020-03.pdf</a>

#### **Placement Management NSW**

Placement Management NSW advised the Committee:

The Rocks Markets road closure on <u>George St from Lower Fort St to Hickson Rd</u> will recommence again under the current Development Approval D/2012/1592/C from this weekend and for October as follows.

- Sat 16<sup>th</sup> at 0400 till Sun 17<sup>th</sup> Oct at 2200 The Rocks Outdoor Dining project, Mercantile Activation + Tree Fairly Lights replacement works.
- Sat 23<sup>rd</sup> at 0400 till Sun 24<sup>th</sup> Oct at 2200 The Rocks Outdoor Dining project, Mercantile Activation + roadway condition review TBA.
- Sat 30<sup>th</sup> at 0400 till Sun 31<sup>st</sup> Oct at 2200 Rocks Markets returns with canopy erected.

The Rocks Markets will return to normal operations on 30<sup>th</sup> and 31<sup>st</sup> October and continue until further notice with road closures and canopy over George St together with markets in Playfair St and Jack Mundey Place.

This was noted by the Committee.

#### City of Sydney

#### Sydney Metro the contract to deliver the Waterloo Integrated Station Development (ISD)

The City advised the Committee of the proposed temporary partial road closures of Cope, Raglan and Wellington Streets until the end of March 2022. Including the closure of the footpaths and parking lanes alongside the ISD, provision of a single travel lane and conversion from two-way to one-way streets commencing in November 2021 to facilitate the construction of the Waterloo Integrated Station Development.

The City advised that Out-of-Session endorsement will be sent to Committee members before the end of October 2021.

This was noted by the Committee.

# Temporary occupation of the parking lane outside the Capitol Theatre – Campbell Street, Haymarket

The City advised the Committee that in November 2020, the Committee provided an out-of-session endorsement for the proposal to temporary occupy the parking lane outside Capitol Theatre in Campbell Street, Haymarket until October 2021.

In consultation with health advisors to operate in a COVID Safe manner. The occupation of the parking lane will allow pedestrians to walk past the theatre while patrons wait in a queueing area on the footpath before the start of the show. The queueing area is required to:

- Ensure patrons have checked into the venue via the Theatre's contact tracing system;
- Control the flow of people into the theatre;
- Manage the number of people in the foyer spaces at any one time as they move to their seats in the auditorium; and
- Ensure all patrons are called through to the foyers and auditorium in an orderly and physically distanced way.

The Capitol Theatre is currently hosting the Broadway hit Come from Away. Whilst it was originally planned to continue until October 31, 2021, due to COVID-19 shutdown, the season has now been extended until the end of January 2022.

The theatre is therefore seeking the Committee's endorsement to extend the use of roadway and footpath until <u>1 February 2022</u> or until the queueing area is deemed not required by NSW Health.

The Capitol Theatre has notified the proposed changes with the local community.

This was endorsed by the Committee.

#### Change of Date - Local Pedestrian, Cycling and Traffic Calming Committee Meeting

The Committee noted the change of date for the Local Pedestrian, Cycling and Traffic Calming Committee from 18 November 2021 to Thursday 25 November 202.

The Committee also noted that due to the Local Government Elections a meeting will not be held on 9 December 2021.

This was endorsed by the Committee.
