Advice

The Committee unanimously supported the recommendation.

Background

The proposed Accelerated Bike Network Program: Castlereagh Street North project involves the extension of the existing Castlereagh Street Cycleway on Castlereagh Street, Sydney to include the area between Liverpool Street and King Street.

Castlereagh Street is an important, central, north-south connection in Sydney's Bike Network, identified in Council's Strategy and Action Plan. These links are aligned with the NSW Government's Co-designed Bicycle Network (Principal Bike Network) for Inner Sydney and their Sydney City Centre Access Strategy.

The design approach is consistent with the Town Hall Public Domain Plan that Council adopted in October 2021 and with the NSW Government's Movement and Place Framework, its Road User Space Allocation Policy, and its hierarchy of road users, which prioritises people walking. To accommodate the proposed changes the number of general traffic lanes on Castlereagh Street would be reduced by one. The City collaborated closely with NSW Government agencies on the reallocation of the traffic and parking lane.

The proposed extension of the Castlereagh Street cycleway would encourage more of Greater Sydney's residents and workers to cycle by providing a safer and more accessible route through the CBD via Castlereagh Street and connect to the broader cycling network. The project will also widen the western footpath on Castlereagh Street and support improvements to the public domain in the area.

At its November 2020 meeting, the Local Pedestrian, Cycling and Traffic Calming Committee (LPCTCC) endorse the pedestrian boulevard in George Street between Bathurst Street and Rawson Place.

The introduction of the CBD and South East Light Rail (CSELR) permanently closed and converted George Street into a pedestrian boulevard between Hunter and Bathurst Streets.

To continue the pedestrian boulevard, George Street between Bathurst Street and Railway Square was permanently close with footpath widenings. The extension of the pedestrian boulevard includes the permanent closure, changing the traffic arrangement and widening the footpath of nearby streets, including Hay Street in Haymarket between George and Harbour Streets.

Advice

The Committee unanimously supported the recommendation.

Background

Between 2015 and 2020, a crash cluster with a rate 5x greater than Sydney's average road users occurred at this intersection, with a total of 15 crashes recorded. Of these 15 crashes, 7, were pedestrian crashes, 3 caused serious injury and there was 1 fatality east of the intersection.

The project treatments are part of the 2026 Road Safety Action Plan, which looks at halving the deaths and reducing severe injuries by 30% on NSW roads by 2030.

The project is part of the Road Safety Program, and specifically aims to address these safety concerns identified by providing enhanced pedestrian facilities and elimination of pedestrian-motorist conflicts.

With the existing pedestrian demand already significant at this intersection, this will only increase due to the opening of the Sydney Metro station located at the corners of Park Street, with Pitt Street and Castlereagh Street.

Comments

Transport for NSW will deliver the project to improve safety and amenity at this location by addressing road safety concerns identified.

Removal of Right-Turn

The removal of the right turn will eliminate the conflict with pedestrians crossing Pitt St, with motorists turning right from Park St. Traffic counts and surveys have been undertaken at the intersection, to identify and analyse the most suitable diversion route for motorists accessing the Pitt St corridor.

It has been determined, while considering the existing and future changes known at this time, that Castlereagh St and Liverpool St will be the most suitable alternate route for motorists and customers accessing the businesses located at the Pitt St corridor.

Kerb Buildouts

The construction of kerb buildouts will provide enhanced pedestrian amenity and wider footpath space for pedestrians crossing Park St and Pitt St. The footpath widening will improve pedestrian safety and accessibility while reducing the distance for pedestrians crossing at the intersection.

The kerb buildouts will not have any significant impacts to the bus zones, parking, and adjacent traffic lanes.

A plan showing the locations of the kerb buildouts is shown below.

Stakeholder engagement

We engaged with stakeholders that would be affected by removing the right-turn and kerb buildouts. These stakeholders were Hilton Hotel, Wilson Parking, Citigroup, Woolworths and Australia Post.

Wilson Parking was unhappy with our proposal, as they are concerned it will impact revenue. Public liability teams' details were given to Wilson, as they would like compensation for the loss of income that may occur due to these changes.

Comments identified were regarding the alternate routes and the subsequent duration of timing for travel, potential for implementing pedestrian protection measures which could be substituted instead of removal of the right-turn at this location.

Transport for NSW had responded to these comments, by sharing the details of the alternate routes identified, with analysis of travel time duration for the motorists and confirmed that there will be no restriction in access to the businesses along Park St.

Responses to the engagement process also informed the stakeholders that the current pedestrian protection measures at Park St and Pitt St had been implemented by Transport for NSW, in 2016 and the next step in addressing the safety concerns requires the removal of the right-turn at this intersection.

Our meeting with Woolworths and Australia post identified that changes to the kerbside parking arrangement would no longer be viable, as Big W is moving in and there would be more deliveries. TfNSW will offer Hilton some printable maps they can give guests on alternate routes and give Wilson key findings from this study.

Financial

The project will be funded and delivered by Transport for NSW.

- (F) During the Works Zone hours, the Applicant must provide vehicle access to the Works Zone for deliveries to the Edinburgh Castle.

TfNSW requested confirmation on the No Stopping distance from the stop line to the Work Zone, for Sydney Metro to provide an assessment of right turn queue impacts, and consultation with the Hotel.

Background

CPB Contractors has requested an extension of the existing Works Zone by 8 metres in Pitt Street, Sydney to facilitate construction works for the Pitt Street Metro.

Comments

The kerb space on the eastern side Pitt Street, Sydney between Bathurst and Liverpool Streets where the Works Zone is proposed is currently signposted as "No Stopping" and "No Parking".

The Works Zone is intended to operate 6.30am to 12am Monday to Friday and 7.30am to 1pm on Saturday.

The Works Zone on Pitt Street will revert to "No Stopping All Other Times" after the Works Zone hours.

Consultation

The applicant must notify adjacent properties at least 14 days prior to the implementation of the Works Zone.

Financial

All costs associated with the Works Zone will be borne by the Applicant.

Item 36 Matters Raised

Alternate Chairperson

George Street, The Rocks – outdoor dining and partial closure

The Alternate Chairperson (Councillor Davis) for the LPCTCC received representations from Paul Nicolaou from Business Sydney regarding deliveries for cruise ships which are expected to peak between now and April 2023 and concerns that deliveries are impacted by the partial closure of George Street, The Rocks. Business Sydney is requesting that the two-way traffic be reinstated.

The TfNSW representative informed the Committee that the temporary partial closure was reviewed and a Traffic Management Plan for the cruise ship freight management has been developed in consultation with Place Management NSW, Transport for NSW, City of Sydney and local stakeholders. Traffic conditions are also monitored during cruise ship delivery periods.

As George Street is under the management of Place Management NSW the concerns will be forwarded to Place Management NSW for their attention and response.

Member for Sydney

The Member for Sydney on behalf of The Pyrmont Peninsular Public Transport Forum requested TfNSW to investigate a bus stop in King Street, Sydney based on the format used for Miller Street in Pyrmont.

TfNSW advised that they will investigate the implementation of a Bus Stop in York Street, Sydney and respond back to the Member for Sydney with the outcome of the investigation.

City of Sydney

The City requested an update from TfNSW on the following:-

Erskineville Road Pedestrian Crossings:

Erskineville Road pedestrian crossing near Woolworths - matter raised at the LPCTCC meeting on 21 July 2022

- TfNSW have advised that they will review the corridor and remove any 50km/h speed limit signs and pavement markings. They will also review the marked pedestrian crossings to determine if there are any opportunities to improve pedestrian safety.
- The City has also received similar representations from residents about the other pedestrian crossings on Erskineville Road (at Prospect Street and George Street), requesting they be upgraded to raised crossings.

Could TfNSW investigate and advise.

TfNSW advised that there are no 50km/h speed limit signs at this location and that all marked pedestrian crossing met the current Standards. They have also advised that they are finalising the new Policy for Raised Pedestrian Crossings.

Temporary Road Closure – Marriott Street, Redfern – Change of Date

At the 21 July meeting, the Committee endorsed the temporary road closure of Marriott Street, Redfern, between Cooper Street and Cleveland Street, from 7.30am on Monday 29 August 2022 to 5.30pm Tuesday 30 August 2022 (three lanes), 24 Hours continuous.

The Applicant advised that due to delays and inclement weather the endorsed road closure did not take place, and are now seeking endorsement for the temporary road closure of Marriott Street, Redfern, between Cooper Street and Cleveland Street on:

- 11.59pm on Sunday 24 September 2022 to 5.30pm on Tuesday 27th September 2022, (three lanes), 24 Hours continuous
- 11.59pm on Tuesday 4th October to 5.30pm on Thursday 6th October 2022 (contingency for weather)

The Committee noted and endorsed the change of date for the temporary road closure of Marriott Street, Redfern, between Cooper Street and Cleveland Street.

Works Zone – 138 Pitt Street, Sydney – Relocation of Works Zone

At the 18 August 2022 meeting, the Committee endorsed a Work Zone on the eastern side of Pitt Street, Sydney between the points 14.4 metres and 24.4 metres north of King Street as "Works Zone 7am-7pm Mon-Fri 7am-5pm Sat" and "No Parking Other Times Buses Excepted 15 Minute Limit".

Due to an existing Works Zone at this location the Works Zone for 138 Pitt Street, Sydney would need to be relocated between the points of 75.5m and 87.5m on the eastern side of Pitt Street, Sydney.

The Committee noted and endorsed the relocation of the Works Zone for 138 Pitt Street, Sydney.

Surry Hills PAC

Surry Hills PAC raised a request for consideration for (centre of / median strip) road fencing along Moore Park Road, possibly for length between Anzac and Regent Streets. The issue is raised owing the ongoing problems with egressing pedestrian, post event, and risk of conflict. Installation of fencing along Alison Road / Randwick Racecourse seems to have achieved excellent results and expect similar with installation at this location. Cost aside. May I request an assessment by engineers and advice on Council position on this type of installation, and how it may be achieved?.

The City advised the Committee that the City does not support pedestrian fencing as it can cause corralling and pedestrians can become trapped between the fence and moving traffic if they attempt to cross the road, however the City will consider additional landscaping to reduce the gaps in the existing median.

The Representative for the Member for Sydney and the Pedestrian Representative also raised their objections to pedestrian fencing. The speed limit on Moore Park Road has been reduced to 40km/h and therefore making it safer for pedestrians.

The Office of the Lord Mayor representative expressed community concerns regarding similar fencing in Anzac Parade as it separates the Parklands from the Community.

Matters Raised by the Representative for the Member for Balmain

The Representative for the Member for Balmain requested an update on the 30km/h Speed Limit proposal.

TfNSW advised that the New Speed Zone Guidelines are currently being reviewed and will update the Committee at a future meeting once the Guidelines have been finalised.
