Background

The City seeks to conduct public domain and pedestrian upgrade works within the road reserves across Loftus Street, Reiby Place, Customs House Lane in Sydney.

The works seek to revitalise and upgrade the public spaces through the prioritisation of pedestrian movements whilst maintaining appropriate vehicle access through a 'shared pedestrian/vehicle' traffic arrangement.

The works will result in additional public spaces being prioritised for pedestrians through increasing the size of the pedestrian footpaths, creation of a shared zone and provision of footpath continuations. The works will also encompass demolition, tree removal, earthworks, public embellishment works including new trees, benches, smartpoles and lighting. The development works are primarily along Loftus Street but extend towards Reiby Place and Custom House Lane.

As a result of the works, the northern end of Loftus Street (north of Reiby Place) will be prioritised to pedestrians, with a shared zone for special service and delivery vehicles. The vehicle lanes along Reiby Place and Custom House Lane will be narrowed and the pedestrian area widened.

The project is consistent with Council's strategic vision for the locality outlined in the City North Public Domain Plan 2015 and implements the City's Sustainable Sydney 2030-2050 Continuing the Vision Project Idea: City Space Improvement Program. This Plan highlights ideas for improving streets and open spaces which can be used as guidelines for future development. The proposed works will implement targets set by the plan with regards to improving pedestrian links and providing for a more walkable CBD.

In George Street:

- (A) Footpath widening on the east side of George Street and permanent road closure of the southbound traffic lane of George Street, from Bond Street to Hunter Street;

- (A) Permanent road closure of Jamison Street at George Street and extension of footpath across intersection;

- (G) On the north side, install "Taxi Zone 3pm-6pm Mon-Fri", "Loading Zone Ticket 6am-3pm Mon-Fri, 6am-10am Sat" and "4P Ticket 6pm-Midnight Mon-Fri, 10am-10pm Sat, 8am-10pm Sun & Public Holidays" between the points 64.2 metres to 82.2 metres, east of York Street;
- (H) On the north side, install "Taxi Zone" between the points 82.2 metres to 109.8 metres, east of York Street;
- (I) On the north side, install "No Stopping" between the points 109.8 metres to 121 metres, east of York Street:

- (J) On the south side, install "No Stopping" between the points 0 metres to 36.7 metres, east of York Street;
- (K) On the south side, install "Loading Zone Ticket 6am 6pm Mon-Fri, 6am-10am Sat" and "4P Ticket 6pm-Midnight Mon-Fri, 10am-10pm Sat, 8am-10pm Sun & Public Holidays" between the points 76.5 metres to 94.4 metres, east of York Street; and
- (L) On the south side, install "No Stopping" between the points 94.4 metres to 121 metres, east of York Street.

In Lang Street:

- (B) On the south side, install "No Stopping 7am-10am, 3pm-7pm Mon-Fri" and "No Parking Coaches Excepted 15min Limit Other Times" from 18.6 meters to 36.4 meters.

In York Street:

- (A) Install kerb buildout at northeast corner of intersection with Margaret Street; and
- (B) Install "No Left Turn" restriction on York Street (southbound) to Margaret Street.

In Margaret Street:

- (I) On the north side, install "1/4P Ticket 7am-6pm Mon-Fri, 7am-10am Sat, Sun & Public Holidays" and "4P Ticket 6pm-10pm Mon-Fri, 10am-10pm Sat, Sun & Public Holidays" and "Loading Zone Ticket Other Times" between the points 33.8 metres to 50.4 metres, east of York Street;
- (J) On the north side, install "No Stopping" between the points 50.4 metres to 69.4 metres, east of York Street and from 0 meters to 46.2 meters east of Carrington Street;

- (K) On the south side, install "No Stopping" between the points 0 metres to 69.2 metres, east of York Street; and
- (L) On the south side, install "No Stopping" between the points 0 metres to 69.2 metres, east of York Street; and
- (M) On the south side, install "No Stopping" between the points 0 metres to 32.4 metres, east of York Street.

In Wynyard Street:

- (A) Change road restrictions from two-way to one-way eastbound between York Street and Wynyard Lane; and
- (B) Install a 10km/h Shared Zone treatment in Wynyard Street between Carrington Street and Wynyard Lane.

In Wynyard Lane:

- (A) Change road restrictions from one-way southbound to one-way northbound between Margaret Street and Wynyard Street; and
- (B) Install a 10km/h Shared Zone treatment in Wynyard Lane between Wynyard Street and Margaret Street.

In Carrington Street:

- (A) Install kerb buildouts at intersection with Margaret Street; and
- (B) Install "Left Turn Only" restriction at intersection with Margaret Street.

Background

The City of Sydney's Sustainable Sydney 2030-2050 Continuing the Vision strategic plan identifies George Street as the central spine of the city centre. The vision for George Street is a pedestrianised boulevard designed to provide a focus for public life in the city centre with light rail connecting three city squares – Circular Quay, Town Hall and Central Station.

The City's Community Recovery Plan in response to the Covid-19 pandemic included actions to continue the acceleration of the capital works program to upgrade city streets, parks and playgrounds; work with the NSW Government on city management initiatives such as mobility and transport, temporary footpath widening, cycleways, change signal timing, lower speed limits, travel demand planning and reprioritisation of roads; and invest in the pedestrianisation and activation of north George Street.

George Street, between Hunter Street and Railway Square, has had traffic treatments installed to close the road to general traffic and convert it into a pedestrian boulevard following the introduction of the CBD and South East Light Rail (CSELR).

To continue the pedestrian boulevard, it is proposed to install traffic treatments to close the road to general traffic and widen the footpath of George Street between Hunter Street and Alfred Street.

The proposed extension of the pedestrian boulevard of George Street includes footpath widening, traffic changes and the permanent road closure of nearby streets. These details are shown in the Concept Design included in Attachment A.

Item 42 Matters Raised

Transport for New South Wales

The Network and Safety Services Manager (Eastern Harbour City) advised the Committee as part of the Smart Signage trial in Chalmers Street, Transport has a plan to change the static signs on the ELP outside the Inner Sydney High School to digital signs.

As such, Transport is requesting the static signs on the ELP be removed and digital Bus Zone, 2P and 4P sign be installed 4.4m south of the ELP towards Cleveland Street.

The distance from the Bus Zone sign to the Bus Stop B-pole is 27.6m. Since articulated buses stop at this Bus Stop, 32m is required to allow articulated buses (18m) to safely draw into (14m) the Bus Stop

This was noted by the Committee.

Representative for the Member for Balmain

Smart Signage - Chalmers Street, Surry Hills

The Representative of the Member for Balmain submitted feedback regarding the display for the Smart Signage, seeking if the contrast, lighting, and the font of the restrictions could be improved to make the display more visible.

TfNSW advised they are investigating to improve the digital signage.

Two-way Bike Traffic on One-way Streets

The Representative of the Member for Balmain raised the proposal of two-way bike traffic on one-way streets (approximately 159 streets). The Representative was advised that once the proposal has been finalized it will be referred to a future Committee meeting.

City staff advised any requests on additional location should be made to the City's Manager Cycling Strategy Manager.

City of Sydney

World Pride Day

The City advised TfNSW to be aware of maintenance and construction work in the months of January to March 2023 due to Sydney World Pride events.

Raised Pedestrian and Bike Crossing across Mitchell Road near Harley Street

At the 18 February 2021, meeting of the Local Pedestrian, Cycling and Traffic Calming Committee. The Committee endorsed A Raised Pedestrian and Bike Crossing across Mitchell Road near Harley Street, as part of the Ashmore and Harley Streets Cycleway.

During the construction in 2022 a number of latent conditions were uncovered which meant it was not possible to install the designed in-ground stormwater infrastructure. Flood modelling was undertaken which identified that introducing the raised crossing would pose a flood risk to adjacent properties.

As such, we are seeking endorsement to install a pedestrian and bike crossing at road grade, noting that there is a future plan to convert this intersection to a signalised crossing.

This was noted by the Committee.

Wentworth Avenue, Sydney

The Representative of the Member for Sydney requested an update from TfNSW regarding the No Stopping on Wentworth Avenue and the rerouting of buses

TFNSW advised they will work with the City to review the No Stopping restrictions along Wentworth Avenue, Sydney and the relocation of bus stops due to the Liverpool Street cycleway works.

Reduction in City Bus Stops

The Representative of the Member for Sydney requested an update from TfNSW regarding the reduction of City Bus Stops

(a) TfNSW advised they will liaise directly with the Representative of the Member for Sydney and Member for Newtown.

Pedestrian Representative

The Pedestrian Representative requested an update on the review for the implementation on the 40km/h speed limits for Glebe, Forest Lodge, Beaconsfield and Waterloo.

TFNSW is investigating lowering speed limits in Glebe, Forest Lodge, Beaconsfield and Waterloo and State and Regional Roads. TFNSW will work with the City of Sydney following the investigation.
